GENERAL COMMUNITY BOARD MEETING MINUTES

Tuesday, September 16, 2014 @ 6:30 PM

Held at: Bronx Library Center ♦ 310 East Kingsbridge ♦ Bronx, New York 10458

- I. Public Session began at 6:30pm with the following speakers:
 - A. Assemblyman Jeffrey Dinowitz:
 - 1. Spoke about the changes in SCRIE program for Seniors who are 62 and over who live in rent control, rent stabilized and Mitchell-Lama apartments. Seniors can now have an income up to \$50,000 to qualify for a rent freeze. Changes were also made in the DRCIE program so that more individuals may qualify for rent freezes
 - 2. Universal Pre-K for all is up and running
 - B. Councilman Andrew Cohen:
 - 1. Announced he was providing funding for a skateboard park to be built in Willismbridge Oval Park
 - 2. He is working with the 52nd Pct. to get "Shot Spotter" for the Precinct. This system is antenna system that can locate where a gunshot comes from
 - 3. Mentioned many area programs that he has provided funds to
 - C. Michael Alvarez, Chief Librarian, Bronx Library Center:
 - 1. The library is having a Job Fair with 22 organizations participating. The fair will be held on September 17, 2014
 - 2. Consititution day individuals will be reading the Constitution of the United States of America from 6:00-8:00pm
 - 3. For 2016 Budget Capital Requests, he is requesting the following:
 - a. Mosholu Library needs funding so it can run 6-days-a-week program
 - b. Bronx Library Center is in need of a new phone system
 - D. Chairperson Adaline Walker:
 - 1. Introduced District Manager, Dustin Engelken as well as the office staff, Maria Baez and Londy Ramirez
 - E. Charlotte Walker, Community Resident:
 - 1. Thanked the Community Board for its efforts in helping to reduce a noise problem she was having
 - F. William Francis, Board Member:
 - Talked about the Participatory Budgetting Process that Council Member Cohen and Torres were involved with. This process is where local residents get a say in what capital projects should be funded in the community . The Council Members have 1 Million dollars each for community selected projects. Community Residents need to voice their project requests
