GENERAL COMMUNITY BOARD MEETING MINUTES

Tuesday, May 22, 2018 @ 6:30 PM | Mosholu Montefiore Community Center

- I) The meeting opened at 6:40 pm with greetings from Barbara Stronczer who is the acting Chairperson.
- II) Public Session
 - A) Councilman Fernando Cabrera spoke about a bill he is presenting to the City Council to increase the CB budget, which has not had an increase since 2012.
 - 1) The funds would enable the CB to hire much needed staff and/or consultants to carry on the work of the Boards in serving over 200,000 residents.
 - 2) The Councilman distributed surveys to support the request and is asking the CB for a letter to be sent to the Mayor about the appeal. It was noted that the CB would be voting on this issue tonight.
 - B) Councilman Andy Cohen spoke in support of Councilman Cabrera's bill.
 - C) Casey Monroe, representing Congressman Espaillat introduced herself as a new member of his staff. She will be attending meetings and will listen to concerns.
 - D) Angel Gerana, from NYC Parks Dept. reported on the upcoming activities at St James Recreation Center.
 - E) Frederich Klein, representing Assemblyman Jeffrey Dinowitz reported on the efforts by the Assemblyman to secure ADA funding for an elevator at the Mosholu train station that will serve the large number of handicapped people who live in the area or who visit the various Medical Centers, Hospitals, Nursing Homes and where two of the tallest buildings in the Bronx are located. Call the Assemblyman's office in support of this request.
 - 1) He also invited all to the Memorial Day concert supported by the Assemblyman at Van Cortlandt Park on Sunday, May 27th at 2 pm.
 - F) Ariana Collado, from Councilman Andy Cohen's office thanked the members who attended the street naming for Andrew Sandler.
 - 1) She invited all to the Williamsbridge Oval on June 5th for an event.
 - 2) On June 10th, the Councilman is sponsoring a bike helmet giveaway at the Annual River Fest at Mt. St. Vincent, from 10 pm to 3:30 pm.
 - 3) The Councilman has an office at MMCC for any concerns or questions.
 - G) Jane Addison-Amoyan, from the Mosholu Library reported on the upcoming activities at the library. Every Tuesday in the summer is called STEM Tuesdays, where there will be activities around music, electricity/electronics, and water play. No registration required; open to children 5 years and up.

- 3) Housing Land Use & Zoning: The Housing Committee recommends that CB#7 approve the proposed M1 Hotel Zoning Text Amendment to establish a City Planning Commission special permit for new hotels, motels, tourist cabins, and boatels in M1 districts. A specific review process will ensure that in the future hotels are built on appropriate sites in order to attain a balanced mix of uses in a given area.
 - a) Motion approved unanimously.
- 4) Public Safety & Quality of Life: To have a CB7 Community Resource Fair and a Back to School Event.
 - a) Motion approved with one abstention (Lowell Green).
- 5) Traffic & Transportation: To provide a letter of support to the Bedford Mosholu Community Association's letter to DOT requesting a study to be performed by the Department of Transportation along Marion Avenue between the eastbound lanes of Mosholu Parkway and the south service road of Mosholu. They propose that the one short block become a one-way street going south without the loss of parking.

 - i. DOHMH This specific area is currently being indexed. Rat Indexing is an inspection process that is part of the overall DOHMH Rat Initiative, currently operating in the Bronx and Manhattan. This program is based on the concept that rats rarely inhabit a single property - rather, they occupy entire blocks or larger areas. In Rat Indexing we inspect all the properties in a targeted area. This process allows us to identify all of the properties in a neighborhood with active rat signs and conditions conducive to rats. Once identified, we can address these properties simultaneously and the effectiveness of the efforts is enhanced. The DOHMH inspectors visited the location for an initial inspection on 1/19/18. The location failed the inspection for harborage, although harborage can be conducive to rats in this specific case the location showed no active sign of rat activity. Our inspectors revisited the location for a compliance inspection on 3/28/18; the location passed the inspection with no active signs of rat activity. If Mr. McCabe believes that the issue has not been addressed he may file a 311 complaint.

Lastly, raccoons are protected wildlife. Like many other animals if there is an active food source in the area it is not uncommon to see raccoons. Although raccoons are nocturnal it is not uncommon to see them during the day, especially if they have a litter nearby. If the raccoon is being aggressive or acting erratically I advise to not try to engage with the animal. Instead a 311 complaint should be filed and our animal control unit will be sent out to observe the animal. If the animal is observed behaving erratically by our AC unit the animal will be trapped. If the animal is behaving normally the animal will not be captured. If raccoons inhabit a private property, the property owner can seek and pay for a private trapper. Please advise if you have any additional questions.

- 5) Metropolitan Transit Authority
 - a) UPDATE: Flood Lights on during Daytime Hours 3119 Jerome Avenue (Concourse Maintenance Shop) superintendent is aware of the faulty timer and he will have it repaired.

 - 1) Expenditures are being made to spend down the excess funds in the budget. There are no specifics except for office supplies, CB tote bags, dog signs an doggie bags. To date there were no requests from the Committee Chairs.
- B) Economic Development/ Community Relations & Long Term Planning
 - 1) Tiffany Wheatland Disu reported on the presentation by NBCCC at the last meeting. There was an overview of all the projects that the Coalition was involved in over the last 40 years. Some of the initiatives discussed were the weatherization Program and the Commercial Lease Assistance Program.
 - 2) Another speaker, Gabrielle Engh spoke on the Sane Energy Project. The initiative is to clean up dirty buildings to help reduce pollution. Signatures to our legislators are necessary to support the bill. One of the outcomes to the bill is a cleaner environment and jobs for community residents.
- C) Environment & Sanitation
 - A report was made on the Weatherization project where heating, roof repairs, replacement of boilers and installation of AC's when medically needed.
 In order to participate, the building must have at least 50% of the tenants' income eligible.

With so many people in need of food, Lowell wondered if the community knew of the SNAP program which is available to seniors but not used. Her goal is to urge support and enroll those in need of these services.

 - 1) Edgar Ramos reported that the MTA would be discussing the Bedford Park Subway Station and elevators at the June 7th meeting.
