A. Committee Description: The social service & housing committee represents the community's interests with regards to social services including senior services, disability, veterans and housing concerns and acts as a liaison between community members and the NYC Human Resources Administration, Department of Homeless Services, Department of Aging, New York City Housing Authority, and the Department of Health and Mental Hygiene. The Disability Sub-Committee is under this committee.

## II. Speakers

#### A. Joseph Onwu, NYC Commission On Human Rights

The New York City Commission on Human Rights is charged with the enforcement of the Human Rights Law, Title 8 of the Administrative Code of the City of New York, and with educating the public and encouraging positive community relations. The Commission is divided into two major bureaus -- Law Enforcement and Community Relations. The Law Enforcement Bureau is responsible for the intake, investigation, and prosecution of complaints alleging violations of the Law. The Community Relations Bureau provides public education about the Human Rights Law and helps cultivate understanding and respect among the City's many diverse communities through its borough-based Community Service Centers and numerous educational and outreach programs.

There is no timeline of when the CCHR can respond to cases because it varies from case to case but the office tries to reply in a timely manner as much as possible when cases are received.

## A. New York State's first Chief Disability Officer

This position was a creation of Governor Hochul's and was established with the enactment of A3130 / S1836 in February of this year, which Assembly Member Reyes multi-sponsored. Under the statute, the office and its director/officer are meant to do the following: Advise and assist state agencies in developing policies designed to help meet the needs of persons with disabilities, Serve as the state's coordinator for disability policy, ensuring the following: New York State adheres to the Americans with Disabilities Act (ADA), State programs do not discriminate against persons with disabilities, Those programs provide services to individuals with disabilities in the most integrated setting appropriate to their needs, Work with state agencies to develop legislation and potential regulatory changes to help effectuate the duties and responsibilities required in this article, and any other changes that may significantly affect the lives of persons with disabilities in the state, Review and report to the Governor about the potential impact of proposed legislation and regulations

# B. Assembly Standing Committee on People with Disabilities

The Assembly Standing Committee on People with Disabilities is a functioning committee of the chamber. It is a committee that deals with and considers all legislation introduced that relates the challenges faced by persons with disabilities. It plays a leading role in crafting budget priorities for the needs of the disabled and has oversight over state agencies deal with disabled community. Also, it holds certain public hearings on specific topics. These hearings are not held frequently and are held usually during the off-session time of the year (July – December). Additionally, the New York State Senate has the Committee on Disabilities, which does many of the same functions as the Assembly committee.
