NYCHA & Housing Committee Meeting Summary February 4, 2025

Committee Description: The NYCHA & Housing Committee represents the community's interests with regards to housing related matters and concerns, namely in relation to NYCHA, and acts as a liaison between community members and the New York City Housing Authority as well as local property owners and management teams.

 - a. Overview NYCHA and our capital projects portfolio

 - Primary Customers: Property Staff & Residents
 - A&CM activities and services fall in 3 areas: Property Modernization;
 Sustainability and Resiliency; and Technical Advisory and Support
 - What projects get funded and why?
 - a. Spending over \$1 billion per year of Federal, State and City funds
 - b. Funding priorities largely determined by funders and compliance requirements, and capital eligibility rules
 - c. Assets prioritized across properties based on PNA, work order, outage, other data, and input from Property Management and other Operations Staff
 - d. Any unearmarked funds mainly used to fill project funding gaps and for emergencies
 - A typical capital projects takes 4-5 years
 - a. Year 1: Plan and Engage Stakeholder; Select designer and construction manager
 - b. Year 2: Complete designs and approvals; Procure general contractor
 - a. Year 3: Plan and complete construction
 - b. Year 4: Commission, document handover and turnover; Survey residents and staff
 - A&CM implements 3 types of capital programs: Component-focused capital renovation programs; Comprehensive modernization program; and Innovation & Sustainability initiatives

 - a. Heating decoupling, decentralized gas, geothermal and heat pump systems
 - b. Roof Replacement
 - c. Elevators
 - d. Compactors & Waste Yards
 - e. Brickwork and Local Law 11
