



## **District Service Cabinet Summary**

***April 15, 2025 - 1:00 PM***

**Description:** *The City Charter establishes a District Service Cabinet (DSC) in each community district, to be composed of agency officials responsible for local service delivery. The District Manager of the Community Board chairs the District Service Cabinet, whose members include representatives of the agencies that deliver local services to the Community District. The District Service Cabinet is the primary mechanism through which local service delivery issues can be raised, discussed and resolved. If used effectively, the Cabinet can provide the basis for a comprehensive approach to service delivery within the community district.*

The following outlines the discussion on service requests and update from various agencies:

- A. District Manager Rivera shared that there have been ongoing issues with an establishment on Manor Ave. Sergeant Soriano will look into this matter.
- B. The Battalion Chief from Battalion 3 shared the following statistics: 79 fires in the Bronx and there has been a small increase in District 9 by 11%, medical runs have decreased by 5.1%.
- C. The 43<sup>rd</sup> Precinct and NYPD Traffic reports that Around 50 vehicles with ghost plates and illegal plates were towed.
- D. Sergeant Soriano reported that there have been issues with illegal vendors at the playgrounds by Morrison and Watson.
- E. Mr. Acosta from NYC Parks Department shared that Parks Department will also assist in managing similar issues in Parks as the summer approaches.
- F. Ms. Dowe from the Mayor's Office shared that there will be a new Quality of Life unit at NYPD. The pilot has started in 40<sup>th</sup> Precinct and will run for about two months.
- G. Mr. Luna from Council Member Farias office shared that HPD recently launched Bruckner Heights and affordable housing applications will be open until June 2<sup>nd</sup>.
- H. Mr. Novella shared that the Department of Consumer and Worker Protection shared that they are wrapping up their tax campaign and will begin worker rights campaign soon.
- I. District Director Jolly shared that Social Service committee requested a representative for Department of Aging, and Mr. Melendez from the Department of Aging confirmed that he will attend the Social Services meeting on May 6<sup>th</sup>.
