#### **Public Session**

- 1. Rogier Van Vlissingen, Plant based diet- Mr. Van Vlissingen stated that as of 2020 plant based will be mandatory in every NYS hospital. Mr. Van Vlissingen also announced that on January 18th, 2020 a cooking class will be held at St. Helenas.
- 2. Jonathan Pansela Young life Bronx region, this program is made for kids throughout their adolescent years. Young Life is the name of our organization and is also the term used for the program with high school students. Young Life's multicultural ministry, focused on kids in diverse cultural communities and those in economically-depressed areas, is arguably the largest of its kind in the United States.

There are still officers getting assaulted. Mr. Ortiz sted that the Comptroller would like to find out how we can better assess the budget. There are so many other things that can be done. Antirson thanks everyone on behalf of comptroller and wished them a happy holiday.
- 4. Taneya Jolly from Teens Talk, stated that teen talk provides conversations about politics, identify and culture through different mediums. Ms. Jolly stated that this platform is for all youth in America. Ms. Jolly stated that submissions for teen talk are received every month and that the first deadline is January 28th, 2020. DM Rivera ask for Taneya to come to the Y&E meeting in January.
