1. - A. Emily Lopez, Family Enrichment Center- Ms. Lopez spoke about the Family Enrichment Center which is a program funded by ACS and Ms. Lopez stated it would be great to have a location in the Soundview area. The Family Enrichment Center (the O.U.R place) is a home-like space where neighborhoods in Hunts Point/Longwood are able to connect, contribute to their community, find resources, learn, and share with others. FEC use a strength-based approach to planning that asks empowering questions and contributes to collaboration. Together community members discover the best for their communities, create a dream for the future, and design and walk a path to get there together.
