3. Liquor License

- A. El Dorado Sport Lounge
 - On White Plains Road; Serial #1003986
 - 2 years ago, there were some issues with the noise
 - It was called Archer Sports Bar
 - They have been there for 20 years
 - They also have cameras that record for 30 days
 - They may need security if it starts getting more crowded
 - DM Rivera spoke with NCO and they didn't have any issues
 - Sometimes there is a group of people outside the establishment and should contact NCO if issues arise
 - No objections from board members
- B. DLO Bar & Restaurant: Willie's Steakhouse
 - On Westchester Ave
 - There are cameras
 - Usually an older crowd and there aren't really any issues
 - They should contact the NCO
 - No objections from board members
- C. La Kamelia Bar & Restaurant Inc.
 - 1802 Westchester Ave

- There are no problems but a while back, the DJ had to summoned because the music was too loud
- The cameras record for 30 days
- This is the only Colombian restaurant
- DM Rivera suggests that there should be a manager or security on the weekends
- Bartenders should check IDs before serving
- No objections from the board members

D. Mi Gente Café Inc.

- 1306 Unionport Road
- Manny is a good owner and a retired firefighter
- There were issues but Manny is very cooperative with the police
- The camera records for 12 days
- There are 20 cameras all together
- Security is one of the best
- No objections from committee members

DM Rivera will mail the letters to SLA for all of the liquor licenses and email it to the owners.

4. New Business

- A. Bicycle & Scooter Share Program
 - Two letters sent and was sent directly to DOT
 - Waiting for Chairperson Nicholas Himidian to explain the program
- B. Hookah: Illegal?
 - Hookah isn't illegal and the smoking age is 21+
 - It can be smoked on the sidewalk
 - If an establishment has made 51% or more of the total sales off of hookah, then they have to file a permit
 - When City Council meet up, they come up with things that can't be enforced
- C. Selling Cars on the Street
 - 308 Stephens Ave
 - Selling used cars on the street taking up parking spots
 - DM Rivera spoke to the lady and warned her
 - The cars were towed twice last year
 - He leaves the cars for a week and then there's a new car the next week
 - Henry Pelayo said he will take pictures and send it to 311
- D. Man putting up random Stop Signs
 - DOT just takes them down

- A. Paquitas
 - The owner closed the place down; she may have sold the building and the rights to the building
 - A new establishment, "Mi Casa.. Tu Casa" came in
 - Across from Isla; 1852 Westchester Ave
 - DM Rivera is requesting the committee to hold off on the meeting, so he can speak with the new owner with NCO Eric Hernandez
 - They want a family-style restaurant with a liquor license until 4 AM
 - DM Rivera wasn't comfortable with the restaurant staying open that late because of the area; he would be more comfortable if they stayed open until 2 or 3 AM but will meet with them to address any other issues

- The committee members are okay with holding off on the meeting with Paquitas
- B. Banyer Place two-way traffic (between Fteley and Croes)
 - DOT approved our request but we don't know when it will be done
- B. Renaming of East 177th Street
 - Cross Bronx Service Road between Zerega Ave and Bronx River Ave will go back to East 177th Street, so that it's in accordance to GPS's
- C. DEP Data
 - Committee should read through it
- D. Newsstand will be installed on the corner of Starling Ave and Olmstead Ave
 - DM Rivera will speak with the businessowners to inform them of the change
- E. DOT Updates
 - DM Rivera will bring up DOT updates at the DSC meeting
 - He will be able to update the committee in the April Public Safety Meeting
- F. Yadira Arroyo Memorial
 - There will be a new memorial and CB9 have coordinated the event
