PUBLIC HEARING

ROLL CALL

Chairperson Ms. Dealice Fuller requested District Manager Mr. Esposito call the roll. He informed the Chairperson that there were 24 members present, a sufficient quorum to open the public hearing.

APPROVAL OF THE AGENDA

Chairperson Ms. Fuller requested approval of the agenda. Mr. Torres made a motion to approve the agenda as written. Mr. Weiser seconded the motion. The motion was unanimously carried.

PRESENTATION -ACCESSIBLE DISPATCH PROGRAM: PROGRAM CONNECTING THE COMMUNITY TO WHEELCHAIR ACCESSIBLE TAXIS THROUGHOUT NYC: The Accessible Dispatch Program gives New York City residents and visitors with disabilities greater access to wheelchair accessible taxis - by Steven Williams, Community Outreach Trainer, MTM.

Mr. Steven Williams addressed the board. He stated that he is the Training Coordinator for the Accessible Program. He noted Sue Calvin, who oversees the accessible program as the program manager with the TLC, was with him this evening. This dispatch program connects the community to wheelchair accessible taxis all throughout the five boroughs in NYC. This program allows people to access the City, especially people who use wheelchairs. All drivers are trained in

wheelchair securement (getting in and out of the vehicle) and people with other mobility devices. The program is for everybody. People pay the same fares as they would with a standardized sedan, so they get more for their money because they get a larger vehicle and someone who is trained to assist them if they need them. They were trying to get the word out to everyone, and ask that if anyone knows someone who has mobility issues, or doesn't necessarily feel safe in a regular sedan car, or needs a larger car in order to accommodate a mobility device, let them know that these taxis are available and the price is the same. They are a great service. The vehicles are rear entry for wheelchairs. The vehicles are large enough to hold four people. You have to let them know about the number of guests so that the vehicle is large enough to accommodate them. You can call them anytime and do not have to wait 24 hours. Chairperson Ms. Fuller thanked Mr. Williams and his colleague for the presentation.

PRESENTATION: BROOKLYN PUBLIC LIBRARY-RENOVATION PLANS FOR THE LEONARD BRANCH - by Naila Rosario, Manager, Government & Community Relations, Brooklyn Public Library.

Ms. Lauren Comito, supervisor for the Leonard Street Branch, presented on the renovations plans for the library. She was joined at the meeting with other branch supervisors in the district (Ms. Alexa Orr, from the Greenpoint Branch; Ms. Catherine Skrzypek, from the Williamsburg Branch). They each gave a short updates their respective branches.) The project at Leonard would be discussed in more detail. Plans for the work at the Leonard Branch were submitted (attached). The Greenpoint Branch is being eyed for a February re-opening. At the Williamsburg Branch there is no construction currently going on. They are happy for the support that they receive from the North Brooklyn Community. The Williamsburg branch has a variety of classes such as= how to learn to play guitar, toddler time, and Spanish story time. They have a lot going on at the branches, such as a green recycle swap. They have recently started a knitters and crochet club at the Leonard Branch. They will have a ghost story telling on December 24th at 10:30AM. It has the feel of "Dickens" going on. Material was distributed. At the Leonard Branch, there is some building projects coming up. They would like to have an HVAC system and the Department of Design and Construction was present to discuss the plans. The plans are going before the Design Commission. The work is planned for 2020 and includes:

- Roof Replacement.
- Replacement of the HVAC.

Mr. Blackman, from DDC, noted that the building is very old. It is a little uncomfortable for the librarians and public. A team of consulting engineers discussed the plans for the roof and HVAC, It is a pretty straight forward project. Before the new HVAC equipment goes up, the will work on the roof. It will basically be a new roof. The shingled roof will be repaired with a new shingles, coping and other accoutrements. Various views were displayed of the building. The existing condition of the HVAC is poor and derelict. It is not functioning right. All of the drains will be addressed. The slate shingles will be selectively replaced. Added to this work is come interior restoration. A historic ceiling exists but has been covered up for a long time. It will be exposed and a skylight will be

exposed. They are not sure what they are dealing with until it is exposed. They have to see how the support structures are. They are committed to having more green design, however, the roof may not be able to support solar panels. The Brooklyn Public Library has cut its greenhouse gases. They are planning on cutting down their greenhouse gases to "zero" by 2050. This is their aim.

- The front steps will also be repaired.
- They are installing a wheelchair ramp in the rear yard.
- They will be replacing some of the brick.
- Removing a layer of concrete on the steps.
- Installing ADA access to the rear entry.

Some additional changes were also noted and included changes to the doors and improved drainage in order to prevent further cracking of the brick. There will be a ramp that opens to a reading garden in the back. An elevator is needed to provide ADA access. They are using a lift to get people to the meeting room. The bathrooms have to be reconfigured to have them be wheelchair accessible. They will need more funding in the future for the design. It is an older building and a lot has to be done for a re-design. The redesign and scope is under review.

They are looking at how to do any revamping. Chairperson Ms. Fuller thanked them for the presentation and moved to the next item on the agenda,

There was one speaker regarding the liquor licenses.

Mr. Sante Miceli, resident and member of the Milton Street Block Association, spoke about concerns with liquor licenses and these type of establishments in the Greenpoint Historic District. He related that the concerns were around quality of life and uncontrolled number of liquor licenses in the given area. He noted that they have come to an agreement with a new established proposed for Franklin Street. He discussed protecting the quality of life for residents. He spoke about sidewalk cafes and the requirements. He raised support for Five Leaves at 18 Bedford Avenue as they have been there for a number of years. He urged for all to come together with the community, to discuss the parameters and the regulations.

There were no additional speakers. Chairperson Ms. Fuller noted that the public hearing was concluded. She moved to the public hearing.

BOARD MEETING

MOMENT OF SILENCE

Chairperson Ms. Fuller requested a moment of silence.

ROLLCALL

Chairperson Ms. Fuller requested District Manager Mr. Esposito to call the roll. He informed the Chairperson that there were 29 members present, a sufficient number for a quorum to open the board meeting.

APPROVAL OF THE AGENDA

Mr. Caponegro made a motion to approve the agenda as written. The motion was seconded by Mr. Torres, and was carried unanimously.

APPROVAL OF THE MINUTES

Ms. Kaminski made a motion to approve the two sets of minutes for the October 10, 2019 Combined Public Hearing & Board Meeting and the November 12, 2019 Combined Public Hearing and Board Meeting. The motion was seconded by Ms. Cabrera. The motion was unanimously carried.

COMMITTEE REPORTS

Land Use, ULURP and Landmarks [subcommittee] – Ms. Teague, Committee Chair, presented a written report on behalf of the committee. She requested a vote on the item, which was a letter of support for the Brooklyn Public Library's renovation plans for the Leonard Branch.

Ms. McKeever made a motion to approve the recommendation. The motion was seconded by Ms. Kaminski. The motion was unanimously carried. The vote was as follows: 36 "YES"; 0 "NO"; 0 "ABSTENTIONS"; 0 "RECUSALS".

SLA Review & DCA Committee – Mr. Burrows, Committee Chair, presented a written report on behalf of the committee. He said that all board members should look at the list of liquor licenses on the public hearing agenda and let the committee know if there were any concerns. He noted that the POD Hotel was on the list and related that there were concerns raised in the past about their license. He read the report and noted that various recommendations. There were eleven (11) new licenses listed. There were four (4) approvals. In regards to the new licenses, he was looking for an approval of the committee's recommendations. Mr. Chesler noted that the license for "Bury the Hachet" was not deeply addressed. Mr. Burrows asked to hold a vote on this license separately. He made a motion to approve the three licenses as noted. Mr. Chesler seconded the motion. The motion was carried. There was one (1) against [Ms. Kuonen]. The vote was as follows: 35 "YES"; 1 "NO"; 0 "ABSTENTIONS"; 0 "RECUSALS".

A roll call vote was requested for the “Bury the Hatchet”. Ms. Teague made the motion. The motion was seconded by Ms. Cabrera. The motion was carried. The vote was 22 "YES"; 6 "NO"; 2 "ABSTENTIONS"; 0 "RECUSALS".

Previously Postponed Items: Mr. Burrows noted that there was a split vote on Shake Shack. Mr. Bachorowski made a motion to support the various recommendations. Ms. Cabrera seconded the motion. The motion was unanimously carried. Ms. Iglesias made a motion to support the remainder of this section of the report. The motion was seconded by Mr. Torres. The motion was unanimously carried.

The vote was as follows: 36 "YES"; 0 "NO"; 0 "ABSTENTIONS"; 0 "RECUSALS".

Mr. Burrows noted the applications that were withdrawn. He noted that there were applicants who did not appear. In this case, the committee recommends denial of the no-shows. Mr. D’Amato made a motion to support the recommendation. The motion was seconded by Mr. Bachorowski. The motion was carried.

The vote was as follows: 36 "YES"; 0 "NO"; 0 "ABSTENTIONS"; 0 "RECUSALS".

Mr. Burrows noted that a list of establishments that have applied for all night permits for New Year’s Eve was forwarded to the community board. He read the list and asked if there were any comments.

Mr. Burrows reported on a meeting that was held at Assemblyman Lentol’s Office by Senator Kavanagh. The meeting was regarding the East River State Park and the Smorgasborg events that are held there. The report is attached. It was requested that the Smorgasborg principals come to the CB#1 meeting and present to the full board; and that Ms. Wright, from NYS Parks should attend as well. It was noted that the meeting at Assemblyman Lentol’s office was called by the Senator Kavanagh. CB#1 was invited to attend.

Transportation Committee – Mr. Bruzaitis submitted a written report that he read to the members. There were no items to be voted on. He spoke about the Calyer Triangle Intersection and provided a recap of the recent site walk-through with Elizabeth Adams & NYC DOT. The report is attached.

Board Budget Committee – Ms. Viera submitted a written report. She discussed the items in it. The report is attached. She noted an item that had the lowest rating --- the CRM. There was a lot concern about it, i.e. - lack of security, etc. was removed from the table. Ms. Viera related that the results were tallied by counting the number of people who ranked each category in their order of preference. Example: Sound System Upgrade – 6 people ranked this option as their #1 preference or 6(1); 8 people ranked this option as their #2 preference or 8 (2):

#3* Live Stream Full Board Meetings - \$3,300 per month x 4 mos. (March –June) - \$13,200

#4* Internet Upgrading -\$100 per month x 6 mos. (Jan. to June) + \$100 installation fee - \$700

#5 – Board Development/Sensitivity Trainings-Contingent on City's approval of concept.

[Approved expense but it is held for future discussion & disbursement]

#6 – Co-sponsoring event – Contingent on City's approval of concept. Costs to be appraised

[Approved expense but it is held for future discussion & disbursement]

#7* Shredder (Per City contracted vendor) \$800.

#8 – CRM (City approved vendor/product) Appx. \$10,000. *[This item was **removed**]*

Another item that was previously paid with the funding was a replacement battery backup unit for the office computers: \$244.00. The Total Expenses was: \$29,768 (This figure does not depict the specific actual cost of trainings and/or events which are to be determined). With the CRM removed the figure was reduced to \$19,768.

At this time, an approval was requested for expenses: # 1 (combined with #2); #3; #4; & #7. The vote was as follows: 35 "YES"; 1 "NO" (Weiser); 0 "ABSTENTIONS"; 0 "RECUSALS".

Ms. Viera announced that the next meeting of the committee was: Tuesday, January 7, 2020 at 6:30 PM, in CB#1's District Office, 435 Graham Avenue.

There was no old business raised and Chairperson Fuller moved to the next item on the agenda.


NEW BUSINESS

The Executive Committee members reviewed a number of requests received for presentations. The following actions were taken:

HOUSING & PUBLIC HOUSING COMMITTEE REPORT

TO: Chairperson Dealice Fuller
and CB#1 Board Members

RE: Committee Meeting held Wednesday, November 13, 2019

The Housing and Public Housing Committee met at the CB#1's District Office, 435 Graham Avenue, Brooklyn, NY 11211 (corner of Frost Street), at 6:30 PM.

ATTENDANCE:

Present: Rabbi Niederman (committee chair); Cabrera; Foster; Gross; Needelman; Rachlin.
Absent: Viera (committee co-chair); Goldstein; Green; Landau; Peterson.
(A quorum was not achieved.)

POWER OUTAGE

Before engaging in a discussion of the public charge issue, Mr. Brian Honan, Director of the Office of Intergovernmental Relations, NYCHA made an announcement regarding a heating outage at Independence Tower. Several board members at the meeting expressed their dismay at the fact that on such a cold night families in the community would have to go without heat in their homes. Mr. Honan stated that he is likewise very concerned about the situation, but that the cause of this outage is the chronic underfunding of NYCHA housing. Mr. Honan also stated that the problem is not simply a management issue and that no amount of staff restructuring will make up for a shortfall in the operating budget.

PUBLIC CHARGE

Rabbi Niederman opened this portion of committee meeting by stating that we need to put our heads together to figure out how to protect the most vulnerable people who live in public housing. He stated that he wants to understand the President's executive order regarding the Public Charge issue. Rabbi Niederman explained that under the public charge rule, which is currently being held up in the courts, as he understands it...if a person has a green card, receives public assistance (such as public housing or Section 8) for 12-months in a 36-month period, and then leaves the country for 6 months...they may not be able to come back. Rabbi Niederman expressed gratitude for the people who took the Administration to court and obtained an injunction, but expressed concern that eventually some version of this rule will be implemented. He asked NYCHA representatives to comment on how NYCHA is handling this situation and specifically on how NYCHA can help protect non-citizens should this rule go into effect by securing the information of public housing residents and Section 8 recipients.

The NYCHA representative, Mr. Brian Honan, stated that the rule is of great concern to NYCHA and that never have they seen anything like this. Mr. Honan introduced NYCHA's Policy Analyst, Ms. Holly Martin Esq., who, he explained, has been working on the "Public Charge" issue for the past year.

Ms. Martin stated that this is a total redo of the public charge test as it exists now. The new test creates time factors, threshold amounts of money accepted in the form of benefits etc.,. Different factors are weighted differently. There's a whole evaluation that has to be conducted. However, public housing benefits are a heavily weighted factor.

Ms. Martin also stated that when someone is applying for public housing benefits, an applicant has to provide information, such as citizenship status, and that keeping information from USCIS and ICE would be a tall order because NYCHA and HUD are extremely integrated. If ICE or USCIS wants to obtain information on the residents, they can just go directly to HUD which is a Federal agency. Ms. Martin also stated that there are Federal laws which would stand in the way of keeping information from HUD. She also confirmed that although a public housing resident can withhold citizenship information and would still be able to reside in public housing, non-disclosure is equivalent to stating that you are undocumented.

Mr. Slava Rar, representing UJO, asked if there might be a way to shift funding streams in a way to ensure that non-citizens receive benefits from local funding streams that would not be considered a "heavily weighted negative factor," under the proposed public charge rule. Ms. Martin responded that while this might be an interesting question for the City of New York (which has purely local funding streams) at NYCHA you cannot single out a family for a different kind of funding. In NYCHA, the funding is by the building and not by a family.

NEW HUD RULE

Mr. Honan explained that there is a new rule that is undergoing review prior to a final issuance. This new rule would prevent undocumented residents from actually living in public housing. Attendees expressed dismay at the fact that an undocumented immigrant, who has a child who is a US citizen, may then be kicked out of public housing despite the fact that their child has a legal statutory right to occupy the dwelling!

Ms. Martin explained that that is one of the arguments that NYCHA has used during the public comment period to challenge the rule.

Several attendees said they felt left out of the process because the NYCHA and the city has not been more public about this rule as it was going through the public comment period. Mr. Honan related that, unfortunately, the Public Charge debate has to a large extent drowned out the discussion on this rule and also that the City and NYCHA didn't want to panic residents over a rule that may or may not take effect.

Rabbi Niederman stated that the NYCHA should keep the Community Board aware of any federal rulemaking that they believe will affect public housing residents. Brian agreed that NYCHA will provide these updates to the community board.

Rabbi Niederman concluded this topic by expressing the need for community members to be educated on these issues so that they can make educated choices regarding benefits decisions.

PRIVATE MANAGEMENT AGREEMENT (PACT Conversion)

The committee discussed the private management agreement for Jonathan Williams Plaza, Independence Towers and Berry South 9th Street Houses that NYCHA is considering. Concern was raised, by Ms. Rachlin and Ms. Foster regarding the accountability that the private management company will have.

Mr. Honan assured the committee that there will be accountability and that the commitments that were made to the residents, especially the commitments to their rights, were included in the "Principles Agreement" that were provided to stakeholders with all of the financial documents.

Mr. Honan also stated that the process is on hold at the moment after residents raised issues that the new contracts they were asked to sign by the new management as the documents did not guarantee a renewal of the lease.

Note from the Committee Chair.

Following this meeting, on November 25th, 2019, NYCHA has issued a letter that confirmed a number of concerns that tenants and their advocates have expressed regarding the PACT conversion. NYCHA's November 25th letter is attached. In short, the letter confirms the following verbatim:

1. PACT will not displace any NYCHA households from Jonathan Williams Plaza and Independence Towers.
2. PACT will not raise rents.
3. PACT is not privatization.
4. Residents will be right-sized within the same development.
5. Senior and disabled will not be forced to move.
6. Authorized existing residents will have succession rights.
7. Residents will not be charged additional security deposits.
8. Households at Jonathan Williams Plaza and Independence Towers that do not currently pay for utilities will not have to pay for utilities after conversion.

Furthermore, by an earlier letter dated November 15th (also attached), NYCHA has committed to completely deleting paragraph 48 from the lease documents which had declared:

“It is expressly understood that the apartment which is subject of this Lease is not subject to the Rent Stabilization Law or any other rent regulatory laws. The Owner is not obligated to offer Tenant a renewal of this Lease and may alter any or all terms or conditions of this Lease in the event of a renewal.”

Taken together, these letters are an important win for tenants and their advocates in ensuring accountability by NYCHA and the private parties as the process moves forward. The Housing Committee Chair would like to commend the leadership of Mr. Joel Gross, Jonathan Williams Plaza Resident Association President, and a Member of the Housing Committee on this issue. Had it not been for Mr. Gross’s attention to detail the issues in the lease agreements would not have been discovered and had it not been for his resolute actions they would not have been remedied.

This breakthrough would also not have been possible without the leadership of Congresswoman Nydia Velazquez, Assemblyman Joseph. R. Lentol, Councilman Steve Levin, and Senator Julia Salazar who were each instrumental in bringing the stakeholders to the table and remedying tenant concerns. And, finally, it would certainly not have been possible without the diligent and thoughtful contributions made by theirs staff.

Thank you for your letter dated November 8, 2019 regarding the upcoming PACT conversion at Jonathan Williams Plaza, Independence Towers, and Berry South 9th Street Houses in Williamsburg. Section 48 of the lease documents currently reads as follows:

48. THIS APARTMENT IS NOT SUBJECT TO RENT STABILIZATION: It is expressly understood that the apartment which is subject of this Lease is not subject to the Rent Stabilization Law or any other rent regulatory laws. The Owner is not obligated to offer Tenant a renewal of this Lease and may alter any or all terms or conditions of this Lease in the event of a renewal.

Tenant Association (TA) leadership at the affected developments recently made us aware of resident concerns with the second sentence of Section 48. We are grateful for the partnership of the TA leaders in bringing this to our attention and agree the language does not reflect NYCHA's commitment to strong tenant protections, nor accurately reflect the terms of the PACT transaction and **will be deleted in its entirety.**

On November 5, 2019, Jonathan Gouveia, Senior Vice President of Real Estate, and Brian Honan, Vice President of Intergovernmental Relations at NYCHA met with TA Leadership. They provided Mr. Gouveia and Mr. Honan with a list of 15 additional questions. We are in the process of finalizing our responses to those questions and will follow up with an additional letter in the coming days.

Thank you for your ongoing partnership and attention to this matter.

Dear Residents of Jonathan Williams Plaza and Independence Towers,

The upcoming PACT conversion of your communities is an important step toward making much needed repairs to your buildings and enhancing property management and customer service for the long-term. The deal with our development partners is expected to close in the coming weeks. This letter serves to assure you of NYCHA's ongoing commitment to maintaining tenant rights and protections.

Tenant rights and protections are enshrined in a number of project documents that fit broadly into the following four categories: 1) Conveyance Documents, such as the lease between NYCHA and the development partner; 2) Restrictive Covenants and Regulatory Agreements, which are between the U.S. Department of Housing and Urban Development (HUD), NYCHA, and the development partner; 3) Subsidy and Management Documents, which are between NYCHA and the development partner; and 4) Organizational Documents, which are between NYCHA and the development partner. Based on questions from your Tenant Association leadership, NYCHA confirms the following:

- 1. PACT will not displace any NYCHA households from Jonathan Williams Plaza and Independence Towers.** No authorized residents will be required to move from these developments because of the PACT conversion. The tenant protections provided under the Rental Assistance Demonstration ("RAD"), which have been extended to all the properties in this conversion, prohibit the permanent involuntary displacement of residents as a result of the conversion. NYCHA will also require that the developer comply with the tenant protections through its lease of the land and the buildings to the developer (the "Lease Agreement"), a control agreement with the developer that provides NYCHA with certain approval rights over project operations (the "Control Agreement"), and the developer's organizational documents, among other transaction documents.
- 2. PACT will not raise rents.** Households will not pay more than 30% of household income for rent, ensuring permanent affordability. This cap on the resident-paid portion of the rent is a requirement of Section 8 program, and NYCHA will impose this requirement on the developer through the Section 8 Housing Assistance Payments ("HAP") contracts through which the developer receives the rental subsidies from NYCHA. This cap is also a RAD tenant protection, which will be imposed on the developer through the documents described in paragraph 1.
- 3. PACT is not privatization.** NYCHA will continue to own the land and buildings, and it will lease the building and improvements through the Lease Agreement. NYCHA will also remain actively involved in your development by administering the Section 8 program and through

various contractual agreements with the developer, including the Lease, Section 8 HAP contracts, Control Agreement, regulatory agreements and the developer's organizational documents.

4. **Residents will be right-sized within the same development.** Pursuant to HUD regulations for both public housing and Section 8, over-crowded/severely over-crowded families will be given priority to transfer to an appropriately sized unit when one becomes available before any outside tenants. This requirement is also a RAD tenant protection, which will be imposed on the developer through the documents described in paragraph 1.
5. **Senior and disabled will not be forced to move.** Pursuant to HUD regulations for both public housing and Section 8, households must be right-sized when appropriately sized units become available. This requirement is also a RAD tenant protection, which will be imposed on the developer through the documents described in paragraph 1. In addition, NYCHA's Leased Housing will evaluate reasonable accommodation requests on a case-by-case basis.
6. **Authorized existing residents will have succession rights.** Household members not on the tenant lease may be added, with NYCHA approval, in two ways prior to the PACT conversion: 1) attend Lease Addition days; and 2) visit the Management Office.
7. **Residents will not be charged additional security deposits.** Existing security deposits will be transferred from NYCHA to the new property manager at the time of conversion pursuant to an assignment to be entered into by and between NYCHA and the developer at closing.
8. **Households at Jonathan Williams Plaza and Independence Towers that do not currently pay for utilities will not have to pay for utilities after conversion.** The new property manager will not change the existing approach to billing and payment for utilities. NYCHA will impose this requirement on the developer through the Section 8 HAP contracts.

I hope this letter has addressed any concerns you may have about your rights in connection to the upcoming PACT conversion. To provide further clarity and assurance, we plan to post on our website several of the relevant project documents.

The PACT conversion is an exciting opportunity to dramatically improve your buildings and living conditions. I look forward to working with you and addressing other concerns you may have. Thank you for your ongoing partnership.

(1.) Presentation-Brooklyn Public Library- Renovation Plans for the Leonard Branch:

Ms. Naila Rosario, Manager, Government & Community Relations, Brooklyn Public Library presented. Ms. Rosario will attend the next full board meeting and will give the complete presentation again at that time. Therefore, this report will just summarize the details.

Ms. Rosario is asking for a letter of support to the Public Design Commission for planned renovations to the roof, the HVAC system on the roof, and the steps at the

front entrance; and the addition of an ADA accessible ramp with railings which will allow access to the first floor of the building as well as to the outside garden. Although renovations will involve internal and external repairs, the scope of this letter of support involves only changes to the outside of the building.

The roof repair is funded in part by Councilmember Reynoso. The existing membrane roof will be replaced by a liquid applied roof. The new roof will be better adapted to future solar panel installation. The new HVAC is smaller, more attractive, quieter, and more efficient than the unit that is being removed from the roof. As an aside, the roof repair will allow for a return of the higher ceiling height and restoration of the style of lighting that was present in the original décor.

The entry stairs repair will include repairing the brick wall and installing new drainage. The ADA accessible concrete ramp at the rear yard will be surrounded by attractive railings and will be accompanied by new lighting.

Recommendation:

The five members present agreed that the project deserved a letter of support. As chairperson of the committee, I recommend approving a letter supporting the project.

STIPULATIONS FOR OUTDOOR USAGE – For any applications that have “any access into the outdoors” you must meet the following:

- A.) Close 11PM Sun. – Thurs.; 1AM Fri. & Sat.
- B.) No speakers or live music in backyard. No background music.
- C.) Only ambient lighting is to be used.
- D.) Self closing mechanism is to be used on every door leading to the backyard.
- E.) Umbrellas and/or soundproofing to be installed.
- F.) 8 Ft. fence to be installed at the perimeter of backyard.
- G.) Must observe NYC Fire Dept. Codes (no open flame, no fire pits, no BBQ); No Smoking regulations; Department of Health Codes and Building Department Codes (C of O) and Public Assembly Codes; and the NYC Department of Consumer Affairs regulations regarding sidewalk cafes.

WINTER & HOLIDAY FIRE SAFETY

The winter season brings about many changes in your home. The heating system kicks on and you prepare for the holidays by decorating and cooking holiday feasts. **The winter and holiday season is also the fire season.** More than one-third of home fires occur during the months of December, January and February. Most fires and injuries are preventable by taking precautions that can make the difference between a happy and safe holiday or a holiday tragedy.

FIRE REMAINS THE MAJOR CAUSE OF DEATH IN THE HOME, WITH YOUNG CHILDREN AND OLDER ADULTS MOST OFTEN THE VICTIMS.

FUEL CONCERNS

Keeping warm in your home should fuel concerns for the safety of your family. During the months of December, January and February, home-heating equipment (central heating units, portable and fixed space heaters and fireplaces) is the second leading cause of home fires.

The major causes of home heating fires are poorly maintained systems, placing space heaters too close to combustible items and flaws in construction and installation of the heating units.

SAFELY HEAT YOUR HOME BY FOLLOWING THESE GUIDELINES:

- Have a qualified technician install all new equipment.
- Have a qualified professional inspect your equipment annually. The inspection will ensure that the system is maintained in proper working order and identify any parts that require repair or replacement.
- Schedule regular cleaning of your boiler, furnace and hot water heater, including the chimney and chimney connectors.
- Have your wood-burning stove or fireplace, including the chimney and connectors, inspected every year by a professional.
- Keep a glass or metal screen in front of fireplace openings to prevent embers or sparks from jumping out.

ELECTRIC SPACE HEATERS

When purchasing an electric space heater, look for heaters with automatic shut-off features.

GIVE SPACE HEATERS SPACE

Heaters should be placed at least three feet from any combustible material, such as bedding and furniture.

- **Never use an extension cord** with a space heater.
- Inspect the electrical cord for damage before each use.
- Keep young children and pets away from space heaters.
- Only use equipment that has the Underwriters Laboratories (UL) Mark.
- Avoid using electric space heaters in bathrooms or other areas where they may come in contact with water.
- **Turn off/unplug the space heater** whenever you leave the room or go to sleep.

Never use the kitchen oven or gas range to heat your home or apartment. Such improper use could cause dangerous levels of carbon monoxide to accumulate, causing severe illness and possible death.

The use of kerosene or propane space heaters is strictly prohibited and illegal in New York City. The use of these types of space heaters poses a high risk of death and injury.

ELECTRIC BLANKETS

With the rising costs of heating energy, you may choose to use an electric blanket to help keep you warm on a cold winter's night. However, **misused or damaged blankets can easily become an ignition source for a fire.**

FOR A SAFE NIGHT'S SLEEP, follow these recommendations for using electric blankets:



- Use only electric blankets that have the Underwriters Laboratories (UL) Mark.
- Replace all electric blankets that are more than 10 years old. (99% of blanket fires have been caused by blankets 10 years or older.)
- Purchase blankets with an automatic safety shut-off. (The device will shut off the blanket if the temperature gets too high.)

- Always buy new electric blankets; second-hand blankets may not be safe.
- Replace any electric blanket that has broken or frayed cords or scorch marks.
- Avoid tucking the electric blanket in at the sides of the bed.
- Avoid placing other blankets or comforters on top of an electric blanket while in use.
- Warm the bed with your electric blanket and turn it off before going to bed.

Electric blankets also present a burn risk to those who cannot feel heat or are unable to react appropriately. Therefore, never place an electric blanket on babies, small children or those with physical limitations that may prevent them from turning the control off or removing the blanket from their body.

BE ELECTRICALLY SAFE

Worn, damaged or improperly used electrical cords cause most home electrical fires.

Take a few minutes this season to INSPECT THE CONDITION of your electrical cords, extension cords, plugs and outlets to make your home as safe as possible.

- Do all the electrical appliances and cords have the Underwriters Laboratories (UL) Mark?
- Are cords out from beneath furniture and rugs or carpeting?
- Do extension cords carry more than their proper load?
- Are any outlets or switches unusually warm or hot to the touch?

- Do all outlets and switches have cover plates?
- Is any cover plate discolored? (Discoloration could indicate that the wiring behind the plate is overheating.)
- Do all electrical plugs fit snugly into their outlets?
- Are any outlets overloaded with more than two appliances?

Carefully inspect new and used holiday lights for cracked or frayed wires. Do not use broken bulbs on Christmas trees.

Remember, extension cords are for temporary use only and not to be used as a permanent extension of a home's wiring system.

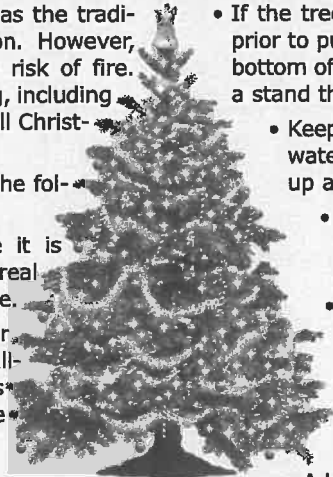


CHRISTMAS TREE SAFETY TIPS

Christmas trees are enjoyed in many homes as the traditional centerpiece of the holiday celebration. However, both real and artificial trees pose an increased risk of fire. Christmas tree fires do happen. Defective lighting, including electrical cords and plugs, cause almost half of all Christmas tree fires.

Protect your family and your neighbors with the following fire prevention tips:

- When choosing an artificial tree, be sure it is labeled as fire-retardant. When choosing a real tree, select the freshest-looking tree available.
- Select a tree that is an appropriate size for the room. Keep in mind that trees look smaller when they are outside and tree toppers and stands will add to the final height of the tree.



- If the tree has been stored for more than three days, prior to putting it up, make another one inch cut off the bottom of the trunk and immediately place the tree into a stand that holds at least a half-gallon of water.
- Keep the water level above the cut and check the water level daily. (Initially, a fresh tree may soak up a gallon of water per day.)
- No water additives, such as aspirin, sugar or commercial fire retardant, are necessary. Plain tap water is best!
- Place the tree away (at least three feet) from heating system air registers, fireplaces and other heat sources.
- Try to position the tree near an electrical outlet to minimize use of extension cords.
- Adequately support the tree with a sturdy stand designed not to tip over.

REAL Trees

- Test for freshness by gently grasping a branch between your thumb and forefinger and pulling it toward you. Very few needles should come off.
- Shake or bounce the tree on its stump. If an excessive number of green needles fall to the ground, the tree may not be fresh.
- Buy your tree early. Most tree lots receive only one shipment of trees. Trees don't become fresher sitting in a lot.
- If you don't plan on putting the tree up right away, make a one half inch fresh cut off the bottom of the trunk and place the tree in a five-gallon bucket of warm water. Store the tree in cool temperatures, but above freezing.

- Do not use electric lights on metallic trees. (Use remote spot or reflective lights.)
- Do not use lighted candles or other flaming devices on or near your tree.
- Whenever possible, use decorations made with flame-resistant, flame-retardant or non-combustible materials.
- Unplug the tree lights when out of the room and before going to sleep.

Even if you keep your tree properly watered, it will naturally start to dry out. Discard the tree immediately after the holiday.

HOLIDAY FEASTING

The holidays are a time for celebration and that means more cooking! Regrettably, cooking fires remain the leading cause of home fires and fire injuries. Unattended cooking accounts for 33% of these fires. Other leading causes are placing combustible items too close to the heat source and various electrical defects.

There are a variety of situations that lead to unattended cooking fires. The most common is when the cook becomes distracted and leaves the kitchen.

In order to drastically reduce your risk of a cooking fire, follow this recipe for safety:

- Stay in the kitchen; don't leave cooking food unattended. (Stand by your pan!)
- Wear short or tight-fitting sleeves. (Long, loose sleeves are more likely to catch on fire or get caught on pot handles.)
- Enforce a "kid-free zone" of three feet around your stove.
- Keep the area around the stove clear of towels, papers, pot holders or anything that could burn.
- Cook at indicated temperature settings rather than higher settings.
- Keep a pot lid handy to smother a pan fire. Do not attempt to pick up the pot or pan. Shut off the heat and cover the fire with a lid.

DO NOT USE WATER!

It will cause splashing and spread the fire.

- Treat burns immediately with cool running water.

Don't Let Your Turkey Fryer Fry You!

In recent years, deep-frying turkeys has become increasingly popular; however, this new tradition is a recipe for a holiday tragedy!

The use of turkey fryers are considered a serious injury and fire risk because:

- As the turkey is placed in the hot oil, oil may spill from the fryer onto the burner, causing a fire.
- Turkey fryers can easily tip over, spilling the hot oil onto anyone nearby.
- Most turkey fryers do not have an automatic thermostat control. With no temperature control, the oil could overheat to the point of combustion and cause a fire.
- The turkey fryers, including the lid and handles, get extremely hot and may cause burns.
- Partially frozen turkeys placed into the fryer can cause a spillover effect.

Underwriters Laboratories (UL) has decided not to safety certify any turkey fryers due to the increasing number of fires and burn injuries related to their use.

HOLIDAY ENTERTAINING AND SMOKING MATERIALS

More people die in fires started by carelessly discarded smoking materials, such as cigarette butts, cigarette ashes, lighters and ashtrays, than any other type of fire. The most common materials to ignite first are mattresses and bedding, followed by trash and upholstered furniture.

Fires caused by smoking materials often smolder, sometimes for hours before the first flame.

When planning your holiday party, also plan to take precautions to prevent a fire in your home.

- Provide plenty of large, deep ashtrays and check them frequently.
- After entertaining in your home, always check on, between and under upholstery and cushions and inside trashcans for cigarette butts that may be smoldering.
- Completely douse cigarette butts with water before discarding.
- Don't smoke in bed or lying down, especially if you are drowsy, medicated or have been drinking alcohol.
- Consider additional smoke alarms in your home; specifically a photoelectric type, which is the most reliable for smoldering-type fires.
- Smokers are seven times more likely than nonsmokers to have a fire in their home.

Candle Light!

Candle fires have tripled in the past ten years. In fact, candle fires peak on Christmas day, followed by New Years and Christmas Eve.

How does a little flame become so dangerous?

More than 33% of candle fires occurred when the candles were left unattended or abandoned. Roughly 25% of the fires occurred because something combustible, such as curtains or paper was too close to the flame. Half the people killed by candle fires in the home were younger than 20, with most of the victims between the ages of five and nine.

If you burn candles for decorative or ritual purposes, make your home safer by:

- Using candles with flame-protective, non-combustible shades or globes.
- Using a sturdy metal, glass or ceramic candle holder.
- Avoiding the use of candles with embedded combustible decorative items.
- Placing candles at least 4 feet away from curtains, draperies, decorations, blinds and bedding.
- Placing candles out of reach of small children and pets.
- Refraining from using decorative/floral candle rings.
- Extinguishing candles before leaving the room.
- Extinguishing candles when they burn within two inches of the holder.
- Never leaving burning candles unattended.



The Silent Killer, Carbon Monoxide!

Carbon monoxide (CO) is a colorless, odorless, tasteless and toxic gas. Nicknamed "**the silent killer**," carbon monoxide is totally undetectable by human senses.

Since carbon monoxide is a by-product of incomplete combustion, any fuel-burning appliance, vehicle or tool that is inadequately vented or maintained can be a potential source of carbon monoxide gas.

People are at an increased risk of carbon monoxide poisoning during the winter months. Well-insulated, airtight homes (primarily newer construction) and **malfunctioning** heating equipment can produce dangerously high and potentially deadly concentrations of carbon monoxide.

Protect yourself and your family by purchasing and installing carbon monoxide detector alarms. A properly working carbon monoxide detector alarm can provide an early warning, before deadly gases build up to dangerous levels.



Effective November 2004, City Law mandates the installation of a CO detector in all City homes and apartments.

Is Your Smoke Alarm Working?

A smoke alarm is the single most valuable lifesaving device you can have in your home. An operable smoke alarm will cut nearly in half your chances of dying in a fire.

While 97 out of 100 homes have a smoke alarm, more than 33% of these homes are not protected **because the smoke alarms don't work.**

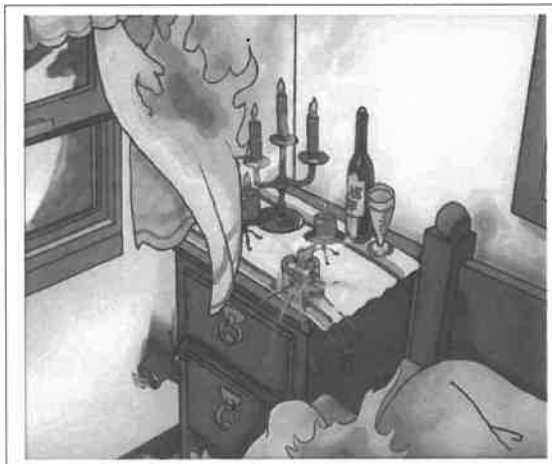

CANDLE SAFETY CHECK LIST



If you burn candles for decorative or ritual purposes, make your home safer:

- ◆ use candles with flame protective non-combustible shades or globes.
- ◆ use a sturdy metal, glass or ceramic candle holder.
- ◆ avoid the use of candles with embedded combustible decorative items.
- ◆ place candles at least 4 feet away from curtains, draperies, decorations, blinds and bedding.
- ◆ place candles out of reach of small children and pets.
- ◆ refrain from using decorative/floral candle rings.
- ◆ extinguish candles before leaving the room.
- ◆ extinguish candles when they burn within two inches of the holder.
- ◆ never leaving burning candles unattended.

Candles should always be placed out of reach of children and don't allow teens to have candles in their bedrooms.

IN CASE OF AN EMERGENCY, DO NOT USE CANDLES TO LIGHT YOUR HOME.

One-third of the people killed in candle fires were using them for light due to no power.

- Use flashlights and batteries available in your home.
- Have the flashlights readily accessible in the kitchen and bedroom.
- Carry a flashlight in your car and a small light on your person.

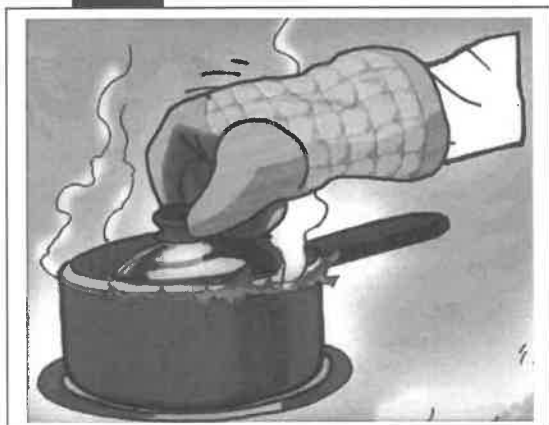

KITCHEN COOKING FIRE SAFETY

The preparation of the home cooked meal is the leading cause of home fires and fire injuries. Unattended cooking accounts for 33% of these fires. Other leading causes are placing combustible items too close to the heat source and various electrical defects.

There are a variety of situations that lead to unattended cooking fires. The most common is when the cook becomes distracted and leaves the kitchen. The most common distractions are attending to children, answering phone calls, watching television and answering doorbells.

Use a lid or baking soda to smother a pan fire!



In order to drastically reduce your risk of a cooking fire, follow this recipe for safety:

While cooking,

- ◆ stay in the kitchen, don't leave cooking food unattended. (stand by your pan!)
- ◆ wear short or tight fitting sleeves. (Long loose sleeves are more likely to catch on fire or get caught on pot handles)
- ◆ don't become distracted.
- ◆ enforce a "kid-free zone" of 3 feet around your stove. Turn pot handles inward facing the wall to prevent burns caused by overturning or spills.
- ◆ keep the area around the stove clear of towels, papers, pot holders or anything that could burn.
- ◆ cook at indicated temperatures settings rather than higher settings.
- ◆ regularly clean your cooking equipment so that there are no cooking materials, food items or grease accumulation.
- ◆ have a pot lid handy to smother a pan fire. **Do not attempt to pick up the pot or pan.** Shut off the heat and cover the fire with a lid.
- ◆ Do not use water. It will cause splashing and spread the fire.

Have Working Smoke/Carbon Monoxide (CO) Alarms

In recent years, 70% of fire deaths have occurred in homes where there were no working smoke/carbon monoxide alarms.

Your risk of dying in a fire is cut in half when there are working smoke/carbon monoxide alarms in your home.

Working smoke and carbon monoxide (CO) alarms save lives by quickly giving you and your loved ones an early warning signal that something is wrong. Fire spreads fast and carbon monoxide is a silent killer. Working alarms are the most critical component of your escape plan.

- Be sure to have the right type of alarm. Alarms must be approved by Underwriters Laboratories (look for a UL mark) and have an audible end-of-life warning. All new and replacement smoke alarms should have a sealed 10-year battery that is non-replaceable and non-removable.
- Have both a smoke alarm and a CO alarm (or a combination smoke/carbon monoxide alarm). One type of alarm is not a substitute for the other.
- If your alarm still uses removable batteries, be sure to change them twice a year. A great reminder is changing batteries on days clocks are changed for daylight saving time. Replace these alarms with ones that contain sealed 10-year batteries as soon as possible.

Alarm Installation

- Install alarms where you sleep and on every level of your home, including basements.
- Locate alarms on the ceiling, preferably near the center of the room, but not less than four inches from a wall. If the alarm must be installed on a wall, it should be placed between four and 12 inches from the ceiling.
- Consider installing interconnected alarms so that when one alarm sounds, they all sound.
- Special alarms should be installed for those who are hard of hearing or deaf. Strobe lights and bed shakers are available.

Alarm Maintenance

- Test your alarms regularly by pressing the test button.
- Replace alarms every 10 years or when the alarm signals that it has reached the end of life and needs to be replaced.
- Keep alarms clean by regularly dusting or vacuuming.

When an Alarm Sounds

- If a CO alarm sounds, you and your family should get out immediately and call 911.
- If a smoke alarm sounds, be sure to execute your escape plan.
- If an alarm is set off accidentally, quiet the alarm by pushing the hush or reset button. Open windows and turn on vent fans to clear the air.
- Accidental alarms often are triggered by bathroom steam or cooking vapors. Consider relocating alarms that often sound by accident.

- ✦ **DON'T LEAVE YOUR PROPERTY/PURCHASES UNATTENDED.**
- ✦ **Stay alert and aware of your surroundings. Secure bags and valuables before exiting or entering parked vehicles and public transit facilities.**
- ✦ **Avoid leaving valuables in your car. Whenever possible, place items out of sight prior to arriving at your destination. (GPS, Electronic Accessories ect.)**
- ✦ **Travel on populated, well lit streets. Plan your trip in advance.**
- ✦ **Avoid cell phone usage while walking, this is a prime time for a thief to grab your phone and run off in an opposite direction.**
- ✦ **Carry only the cash and credit cards you will be using on your shopping trip. Divide the cash between your purse, pockets and wallet. Keep a record of account numbers for each card.**
- ✦ **Carry your purse close to your body. Never wrap the strap around your body. A wallet should be carried in front pants pocket or breast pocket of your jacket.**
- ✦ **While dining or shopping don't leave your handbag over the back of a chair or stroller.**
- ✦ **Don't wait until you have reached your front door to look for your keys. Have them ready in your hand.**

HOLIDAY SAFETY TIPS



With the holiday season upon us, most people are preoccupied with the details of holiday plans and shopping. Unfortunately, the safety precautions which we normally take are sometimes forgotten or the excitement of the season causes us to let down our guard. The Police Department wants this to be a SAFE holiday season for all, so we remind you to follow these safety tips and enjoy the City and the season.

- *Be alert and aware of your surroundings at all times. Criminals often confront people who are distracted.
- *Whether driving, walking or taking public transportation, plan the trip in advance. Know how to get to your destination by the most direct and safest route.
- *Travel on populated, well lit streets. If possible, travel with a friend.
- *When driving, keep your doors locked and the windows closed. Make sure the gas tank is full and maintain your car in good working order to avoid breakdowns.
- *If you are taking the subway, look for the red or green lights outside the entrance. A red light means that you cannot enter the subway system at the location. Look for an entrance with a green light before going down the stairs.
- *If possible, stay in the view of the token booth while awaiting your train. Never walk near the edge of the platform.
- *Plan your purchases in advance and carry only the amount of cash necessary to make the purchase. If you must carry a large sum of money, divide the cash between your purse, pockets and wallet.
- *Record the numbers for each of the credit cards you own. This will facilitate reporting the theft or loss of the card.
- *Carry your purse close to your body. Place one end of the purse in the palm of your hand and the other in the bend of the elbow. Never carry a purse by the handle or wrap the strap around your body.
- * Always lock your car. Before getting into your car check the back seat to make sure no one is hiding.

*If you are carrying a wallet, carry it in the breast pocket of your jacket or in your side pants pocket. The rear pants pocket is one of the easiest to pick.

*When in a restaurant, don't leave your handbag or packages unattended.

*If you must place packages in your car, put them into the trunk and make sure the trunk is locked. The trunk lock should be protected by a cylinder guard plate. Never leave packages in the passenger compartment unattended.

*Don't wait until you have reached your front door to look for your keys. Have them ready in your hand. If a stranger is standing near your door, it may be a good idea not to go in until the situation is safer.

*Lock your front door immediately upon entering your home.

*If you live in an apartment building, don't buzz in someone who rings your bell until you have verified who they are. This will help protect both yourself and your neighbors.

*Be wary of con artists. Con artists use a number of ploys to scam you and steal your property. Some divert your attention while another picks your pocket, some pose as utility workers or a tradesperson to gain access to your home, while others conduct scams that are more elaborate involving several con artists. As a consumer you should also be wary of illegal vendors selling goods on the street. Purchase merchandise from only licensed vendors or reputable stores. Follow your instincts and remember, "If it seems too good to be true, it probably is".

RE: Committee Report from Wednesday, December 4, 2019 Meeting

The Transportation Committee met Wednesday, December 4, 2019 (CALLED TO ORDER: 6:48 PM; ADJOURNED: 8:14 PM) in the CB #1 DISTRICT OFFICE 435 GRAHAM AVENUE BROOKLYN, NY 11211 (CORNER OF FROST STREET).

A quorum was not met.

ATTENDANCE:

Absent: Weiser; Argento; Gangone; Goldstein; Green; Schlesinger; Stuart.

AGENDA:

1. CALYER TRIANGLE INTERSECTION. Recap of onsite walk-thru with Elizabeth Adams & NYC DOT.

Following up on the presentation by Mr. Dan Keezer, the following group met to discuss the conditions on site at the intersection of Calyer, Franklin & Banker Streets, Wednesday, December 4th: Ms. Elizabeth Adams, CM Stephen Levin's Office; Ms. Jessica Cronstein, Ms. Emily Weidenh, Ms. Ronda Messer of NYC DOT; Mr. Dan Keezer; Mr. Philip Leff of Transportation Alternatives; Mr. Brendon Nicholas of Silk Road Cycles; Mr. T. Willis Elkins and myself.

The group discussed the current conditions and options for making the location safer for all users. The committee reviewed the notes from Ms. Adams email (below) for follow up in the coming months:

On Dec 4, 2019, at 4:48 PM, Adams, Elizabeth <EAdams@council.nyc.gov> wrote:

Hi everyone,

Thanks for a great meeting! Really excited to move this forward with all of you, and thanks to Dan for the presentation and vision.

Appreciate the commitment everyone is putting in to make this happen.

Sharing brief notes/next steps below. Ronda, please add Emily to the email as well.

1. Slip Closure Analysis —

- DOT will conduct network analysis with Bike/ped team staff for broader network considerations.
- Also examine street directions (Nearby Quay/Calyer); truck route; and traffic speed/vehicles per hour that may be impacted by change.
- DOT will follow up with network design options to this group for discussion/review.

2. Agreement needed to close the slip—

- DOT to send form to Brendon @ Silk Road to review.
- Street Seat options for the triangle include: filling in gravel; adding permanent benches; Bike parking (will assess demand, but folks shared it would be used); Planters; moveable tables and chairs (with new development, there seems significant support for). May also need to expand sidewalk space by the bushes to avoid pedestrians walking in the street, along with including a marked bike lane.
- Street Seat Maintenance would include plant watering; sweeping; some snow removal.

- Brendon will review for approval/agreement.

3. Next Steps:

- DOT study & proposals to come.
- Agreement for Street Seat
- Group to review proposals & DOT will present finalized version to the CB early/mid March for approval.
- Goal of implementation mid-April!

GRAND STREET REDESIGN – Recap of latest walkthru with CM Reynoso, Grand Street BID & NYC DOT.

Ms. Karen Nieves detailed a November 15th walk-thru on Grand Street with Council Member Antonio Reynoso; Mr. Alexis Rodriguez (CM Reynoso's Office); Borough Commissioner Keith Bray and Ms. Ronda Messer of NYC DOT; Ms. Erin Piscopink of Grand Street BID and Mr. Philip Leff of Transportation Alternatives:

- CM Reynoso was very upset with the condition of Grand Street, and was clear with DC Bray that NYC DOT should have had a much better plan in place before moving ahead with stop gaps from the L Train non-closure fall-out.
- It is still necessary for delivery vehicles to double park in travel lanes. And more loading zones must be sited to resolve this issue.
- Moving flexible delineators cannot be relocated due to Department of Sanitation need to access curb with mechanical brushes. DSNY is looking at smaller mechanical brushes (as are used in other cities) to make moving the delineators possible and solving problem of vehicles parked in the bike lane. CM Reynoso is looking for funding for this purpose. There is also the possibility that more delineators can be added to make it impossible for vehicles to park.
- Ms. Piscopink is in communication with Mr. Ted Write (NYC DOT) to work on bike lane fixes that do not negatively impact businesses.
- There is a plan to relocate a construction trailer in the Industrial section of Grand St to Maujer St so cyclists do not have to travel in traffic lanes to avoid it.

COMMENTS

Committee:

Ms. Ryan Kuonen suggested that the mini car the NYPD 90th Precinct uses to patrol the Williamsburg Bridge bike/pedestrian path would be better used patrolling Grand Street. Since

NYPD enforcement is especially at a premium in the 90th Pct., and complaints are more numerous on Grand than on the bridge the car should be deployed on Grand St.

Public:

Mr. William Vega, in his capacity as a city employee at the NYC Dept. of Business Services has fielded numerous complaints regarding delivery issues. Businesses are also noticing that many of the illegal parking issues are disproportionately out of state license plates. He also noted that Access-a-Ride could be impacted if NYC DOT does not install a better solution for curb access.

2. OLD BUSINESS

Mr. Kevin LaCherra brought up the issue of traffic cameras within the district. He is working with local elected officials to inform the committee as to the number of new cameras already installed or proposed now that new legislation has made it possible to finally get the cameras we need. His email below details his latest efforts. The committee will continue to discuss additional cameras in the district:

Hey Eric,

Just called and spoke with Melissa in Salazar's office and Emil in Lentol's office. They are both checking in with DOT as to whether or not any cameras have already been installed at schools in the community and if any are scheduled to be installed.

The bill was signed May 10th and came into effect May 26th after which the responsibility was with DOT to install the cameras where they saw fit. Not a hundred percent clear where they did (or will) saw fit to put them but this is more info than we had before with more on the way. Will keep you updated.

Phil will be sending you the Make Meeker Move Street scan materials today or tomorrow.

As part of a Make Meeker Move conversation Mr. Philip Leff (who was not able to attend) sent the results of an informal study of the McGuiness Humboldt exit of the BQE. His email and Mr. Kevin LaCherra's additional comments are below. This is an ongoing issue for the committee and the chair is grateful for the input of both Transportation Alternatives and other members of the public taking action to address the conditions along the Meeker Ave corridor:

Hi Eric,

Great to see you on Calyer St, and looking forward to West St tomorrow.

Here are some of our observations from our Street Scans, done on the afternoon of Saturday, November 10, and the evening of Thursday, November 21 at Meeker Av and McGuinness Blvd.

Our observations confirmed that this is an extremely inhospitable intersection for pedestrians and cyclists, that does not work particularly well for cars either.

- Pavement on Meeker is in rough shape, with many potholes, especially in the crosswalk
- Limited time to cross the eastbound lanes of Meeker, with turning conflicts from drivers on southbound McGuinness
(At the only signalized crossing before Kingsland Av, 4 blocks away)
- Cars on westbound Meeker blocking the crosswalk and curb cuts
- Cars parking on the sidewalk of Meeker

We observed many issues relating to the gas station on the NE corner

- Multiple curb cuts with many vehicles on the sidewalk
- No clear path in and out of the station, vehicles going in conflicting directions, with near misses on the sidewalk
- Vehicles making U-turns from southbound McGuinness to access the gas station

Vehicle gridlock from those turning South onto Humboldt conflicting with those coming from the BQE ramp.

Kevin, please feel free to chime in with anything that I missed.

Phil covered it all pretty thoroughly. A few other observations:

- in the area between McGuinness Boulevard and North Henry Street less than *half* of the parking spaces were in use during both observations
- The area underneath, despite having alternate side parking doesn't look like it has been cleaned in quite some time, there is a lot of buildup at the drainage locations which could lead to flooding and generally leads to filthy conditions throughout the space
- the constant loud noise of cars moving through the area both above (on the highway) and below along Meeker Avenue, cars that are blocking the intersection at the turn sounding their horns contributes to the unpleasant atmosphere
- most cars along Meeker Avenue wanting to make a turn stop far ahead of the stop line in the crosswalk that is already difficult to get all the way across before the lights change.

New 'gates' have been installed on the cyclist/pedestrian path off the new Kosciuzsko Bridge. Ms. Karen Neives suggested that the board send a letter to NYS DOT asking for clarification/justification for this installation. They seem to be installed to slow cyclists however they are causing an unsafe condition that could be more easily/safely be remedied by a surface treatment.

3. NEW BUSINESS

Mr. Kevin LaCherra mentioned efforts to prevent the proposed National Grid pipeline from disrupting local streets in the near future.

There are many issues associated with this project and the committee will take it up in early 2020.
