### **PUBLIC HEARING**

### **ROLL CALL**

Chairperson Ms. Dealice Fuller requested District Manager Mr. Gerald A. Esposito to call the roll. He informed the chairperson that there were 18 members present.

### APPROVAL OF THE AGENDA

Ms. McKeever made a motion to approve the agenda as written. The motion was seconded by Mr. Caponegro. The motion was unanimously carried.

**DCA - UNENCLOSED SIDEWALK CAFÉ**, Sampa Restaurant LLC, dba BECO, 45 Richardson Street, aka 715 Lorimer Street, #18413-2018 ASW, 9 tables, 20 chairs. NEW A presentation was made by Ms. Blair Papagin, representative from Mr. Kelly's office. There is a new owner of the restaurant. The seating and the hours will remain the same. There were no comments made at this time for this application.

<u>DCA - UNENCLOSED SIDEWALK CAFÉ</u>, 258 Franklin LLC, dba 258 Franklin Street, Application #688-2019-ASWC, 10 tables, 20 chairs. NEW. The application is for changing the seating. They will not be having seating on Franklin Street anymore. The business has been open and operating for 6 years. It is on Eagle Street and Franklin Street. They are applying for an unenclosed sidewalk café. No questions were raised at this time.

**DCA - UNENCLOSED SIDEWALK CAFÉ**, Juicerie IV LLC, 271 Metropolitan Avenue, Application #717-2019, ASWC, 15 tables; 54 Chairs. NEW. Mr. Steve Wygoda, architect, presented on the application. They were reapplying for the location. They had previously withdrawn their application. They are now applying for a reduced number of seats. The location is at the intersection of Metropolitan Avenue and Driggs Avenue. They have been opened since July. The owner was present. A question was raised about their previous application, why was it denied. Mt. Wygoda noted that about six months ago, there was opposition. They voluntarily withdrew the application. They have refiled with the Department of Consumer Affairs. There will be 54 seats, at the entire corner of Metropolitan and Driggs Avenues. They has 72 before. This was a brand new application. Mr. Weiser asked if they had signatures from the neighbors. It was noted not yet. No other questions were raised at this time.

PRESENTATION - RE: Temporary Liquor License for KansasExp-NYC LLC, at 470 Driggs Avenue. They will be presenting a temporary immersive gaming experience which promotes the upcoming James Cameron and Robert Rodriguez film, "Alita: Battle Angel." The experience itself is called "Passport to Iron City: Explore the World of Battle Angel".- by representative, Michael Woloz, Connelly McLaughlin & Woloz. It was noted that the SLA Review & DCA Committee requested the item to be presented. Mr. Woloz began the presentation. The location of the establishment was at 470 Driggs Avenue. He noted that the facility was a gaming experience. It is called Passport to Iron City. He noted that he would turn the presentation over this his colleague. He wanted to tell why they were present this evening. They are seeking a temporary beer and wine licenses for the experience. The event ends March 17th. There is a timing issue. Ms. Annie, she was a co-producer of the event. The film is opening on Thursday. The film is about a teenage cyborg girl "Alita". The concept is that people are immersed in the event and experience the events in the film. It is a gaming experience and the participants experience things such as movement and smells from the "market place". It was noted that the person will be there to gather and then go it. It the evenings they would be closing at 10:30PM. They are seeking temporary licenses right now, but they will be applying for a seasonal permit. Next time, when they plan this kind of an event, they will be starting earlier. Mr. Burrows related that the committee has checked into the location. This is a pop up immersion event. The committee had the FDNY check to location and the site was inspected. The event space was the former location of a large failed restaurant. They were seeking 24 temporary permits. The committee noted that they were in touch with both the FDNY and NYPD to make sure that they pass safety inspections. A series of questions were asked of applicant. The applicant had responded to the questions satisfactorily.

**PRESENTATION** – Waterfront Alliance's Waterfront Edge Design Guidelines (WEDG). A tool that can assist communities with ensuring that all projects along the waterfront are developed in a way that is resilient to flooding, ecologically healthy, accessible to the community, and community driven.

Mr. Dalal presented on the item. A written presentation was submitted and distributed. He noted that their materials were available on line for free. The focus of the efforts for the design guidelines is that it is community driven and accessible. They have included a "Harbor Score Card" which rates the NYC Waterfronts to see if the they are strong, healthy and open. The Waterfront Alliance is a coalition of more than 950 organizations working together to bring about real change to city's 520 miles of shoreline. The alliance include businesses and nonprofit organizations throughout the New York, New Jersey, Connecticut and beyond. They represent a unified voice for the shared waterfront, building consensus on policy and planning. The Waterfront Edge Design Guidelines (WEDG) seek to set standard guidelines for NYC. Mr. Dalal noted that all want a great waterfront. The Waterfront Alliance is composed of 200 professional and community activists. They work with LEED certification. Their guidelines are a strong tool to learn from. There is an incentive for developers as they can show their work off. He noted that they are seeking the board to support a resolution regarding the guidelines and standards. They are seeking for all waterfront projects in the district refer to WEDG's standards from the beginning of the design process for potential application to new construction and renovation in the community. Ms. McKeever asked if the matter could be brought to the Parks Committee. Mr. Chesler agreed that the committee should review the guidelines. Chairperson Fuller referred the request for signing onto the guidelines to the Parks and Waterfront Committee for review and recommendation at its next meeting. The committee is planning to have a meeting at the beginning of March.

### **COMMITTEE REPORTS**

<u>**Transportation Committee**</u> – Mr. Bruzaitis submitted a written report on behalf of the committee. He read the report and reviewed each item. The report is attached. The next meeting of the Transportation Committee will be: Tuesday, February 19, 2019 (6:30PM) at the Board Office.

Mr. Bruziatis spoke about an item that was taken up at a previous meeting. It was a proposed plaza for the area by the. CB #1 is in receipt of a letter that the church is now in favor of the plans. Last week DOT had a meeting on it. In order to progress the project, the board's support is requested. A new vote is needed for this. Mr. Bruzaitis made a motion to approve the plaza plan. The motion was seconded by Mr. Caponegro. The motion was unanimously carried.

**Land Use, ULURP & Landmarks (subcommittee) Committee** – Ms. Teague discussed the committee's report. There was just one item addressed at the committee meeting.

BSA Application # 2018-191-BZ; 215 North 10<sup>th</sup> Street. Ms. Teague noted that Mr. Ben Stark presented this application for a special permit to reduce parking for use Group B Office Use in this proposed mixed-use building comprised of 64, 793 sq. ft. of new residential, office, and retail space. The requested permit will affect the parking requirements for only the spaces designated for office use. Without the permit the developer would be required to provide 102 spots for the office spaces; the permit will allow a reduction to 51. The developer is offering to provide the 51, plus the 16 required for residential units, 3 required for retail, and an additional 7 spots, totaling 77. There will also be ample provision for bike parking. The study for peak demand found there would not be an expected need for more than 45 spots for all uses. There will be 31 residential units on the 4<sup>th</sup>, 5<sup>th</sup>, and 6<sup>th</sup> floors. None of these units will be marketed as affordable, but inclusionary housing certificates will be purchased, so there will be affordable units in perpetuity elsewhere within this community board. The 36,000 sq. ft. of office use will be on the 2<sup>nd</sup> and 3<sup>rd</sup> floors. There will be 800-900 sq. ft. of retail on the ground floor, along with a garage entrance and the residential lobby. Any parking spaces that are not used will be available to the public for a fee. In light of the city's plan to reduce the current parking requirements for office usage, because of findings that the current requirements are outdated, the committee voted unanimously for approval. The committee recommends that the board vote to approve the project. Ms. Teague made a motion to support the committee's recommendation. The motion was seconded by Ms. Iglesias. The vote was as follows: 32 "YES": 0 "NO": 1 "ABSTENTION" (Mr. Needelman). The motion was carried.

**Women's Issues Committee** – Ms. Peterson submitted a written report. She noted that a letter was received from the elected officials about the women's swim hours, requesting that they be restored at Metropolitan Pool. Ms. Peterson read the letter. There was not a quorum at the committee's last meeting, so the committee will bring a request to the board in the future seeking another letter of support for the extended hours at Met Pool. She spoke about women, safety, issues of violence, and sexual harassment. Things have started to turn around up in Albany. Bills on sex and violence are coming up and there are hearings that will be going on. She related that a letter to the Borough President, commending him on his honoring of Congresswoman Shirley Chisolm with a statue, should be sent. March is Women's History Month, and she noted there is a need to raise awareness. Perhaps something could be done at the board's next meeting. The committee will be meeting next on March 5<sup>th</sup>.

### PARKS DEPARTMENT MINUTE

Ms. Mary Salig submitted a written report that was distributed for review. The report is attached. She noted that the Parks Department would like to bring the project for improvements for the

McCarren Park's Field 3 (aka Gilroy Field) to the Parks Committee and the full Board for review.

**<u>PUBLIC SESSION</u>** (Reserved for the Public's expression. Board Members will not be allowed to speak.) Each scheduled participant for this session will have an allowance of two (2) minutes. (No questions will be entertained. <u>Speakers are requested to submit their testimony in writing</u>) There was one person who signed up to speak.

Ms. Cory Kantin, from "Friends of the Northside Waterfront", spoke about concerns with development at the former Con Edison property at North 3<sup>rd</sup> Street and River Street. They are opposed to the site's potential rezoning. She said that there are groups of people in the area, and they are coming together to have a unified voice.

Mr. Burrows spoke about the need to know who the groups are. Ms. Teague spoke about the importance of having a unified voice on matters for the waterfront. People need to show up to any meetings on this

### **CHAIRPERSON'S REPORT**

A written report regarding the chairperson's correspondence was distributed for review. She urged all to be diligent with their committees. The committees need to have quorums. She suggested that those committees that haven't met, that they begin to do so.

### DISTRICT MANAGER'S REPORT

A written report was submitted and distributed for review.

### ANNOUNCEMENTS: ELECTED OFFICIALS

Mr. Pierre, from the Comptroller's office, addressed the members. He noted that the Comptroller is concerned about affordable housing. A housing plan is being issued and the report is on line. There are questions about affordable housing, is it really affordable? The Comptroller is offering some suggestions to help create more affordable housing. He is talking about tax cuts and reforming the mortgage recording tax and other policies. This will help to make apartments more affordable.

Mr. Resnick, from the Brooklyn Borough President's Office, noted that the reapplication process is now taking place and applications are due this Friday. The Borough President is supporting the Timber Bridge project, which would connect Greenpoint to Long Island City. He related that they were having a meeting on the hate crimes (Swastikas painted on buildings) in north Greenpoint. He noted that the "L" train smells that have been going around is being investigated. It may be coming from several sources.

Mr. Rodgriguez from Council Member Reynoso's Office, made a few announcements. He related that there were ventilation fans placed around North 7<sup>th</sup> Street. The source of the smell is still being investigated. He raised concern about the MTA scheduling meetings because they are

conflicting with the Council's stated meetings. Participatory budget is now underway. He announced an event being held at Jennings Hall.

Mr. Boris Santos, from Senator Salazar's office, provided some updates. They have a temporary office at this time at 1068 Broadway. Albany is negotiating an office for her. He spoke about monies that are due the district's schools. There is a need to close the loopholes. They have passed this first bill, regarding contraceptives. They need to work on bills regarding housing and other important issues.

Ms. Danielle Zuckerman, from Senator Kavanagh's Officem, spoke about gun violence bills. They have passed a lot of laws so far in Albany. They are addressing some air quality issues in the area (i.e. the smells on the L train line).

### **OLD BUSINESS**

Chairperson Ms. Fuller called for old business. No old business was raised.

### **NEW BUSINESS**

Chairperson Ms. Fuller called for new business. No new business was raised.

### ADJOURNMENT

Chairperson Ms. Fuller noted that agenda was completed. She called for a motion to adjourn.

Ms. Iglesias made a motion to adjourn. The motion was seconded by Ms. Teague. The motion was unanimously carried. The board meeting was adjourned.

### IN SUPPORT OF THE WATERFRONT EDGE DESIGN GUIDELINES STANDARD FOR NEW YORK CITY

WHEREAS, sea levels are rising across the globe, and will continue to increase the extent, frequency, and duration of storms and coastal flooding. These risks come with increasing costs, both event-based and day to day. WHEREAS, by 2050, NYC's average temperature is expected to tise between 4.1 and 6.6°F, and annual precipitation is expected to increase between 4% and 13%, which could exacerbate flooding<sup>3</sup>; and

WHEREAS, despite these rapidly increasing risks and costs, new waterfront development is occurring at a rapid pace. Over 400,000 New Yorkers have a 50% chance of experiencing a major flood in their homes by 2060, and over 41% of those are economically and socially vulnerable<sup>4</sup>. And, increasing density in neighborhoods across Brooklyn, such as Greenpoint and Williamsburg, calls for smart choices about how we prepare for storms through design and management of developments in the floodplain; and

WHEREAS, the Waterfront Alliance has a tool, the Waterfront Edge Design Guidelines (WEDG®), which can equip Community Boards to make more informed decisions on smart design, coastal resiliency, and improved access to the waterfront; and

WHEREAS, WEDG is a nationally recognized standard to enhance resilience, ecology, and access in waterfront development. Any waterfront project which touches the waterfront edge – residential, industrial, mixed use or park, is eligible for WEDG certification. There are eight WEDG Certified projects in New York City including Greenpoint Landing, Domino Sugar, Brooklyn Bridge Park, and Sunset Park Materials Recovery Facility in Brooklyn; and

WHEREAS, WEDG is a toolkit that empowers communities, builders, and decision-makers to consider factors such as hard infrastructure, green infrastructure, ecology, best practices in design and waterfront access options including kayaking, walkways, parks, waterborne transit (ferries) so that the whole community benefits; and

WHEREAS, WEDG is a powerful, simple, and freely available communications tool, and grassroots movement to empower communities to protect their homes and build stronger, more equitable and resilient neighborhoods. From the Bronx to the south shore of Staten Island, WEDG has already made a strong impact on improving waterfront communities, and the movement is growing; and

WHEREAS, as Communitγ Boards are on the forefront of reviewing major projects and reshaping local waterfronts, Waterfront Edge Design Guidelines can help hold developers to a higher standard, improve

**THEREFORE, BE IT RESOLVED THAT** Brooklyn Community Board 1 supports the requirement that all waterfront projects in the Brooklyn Community Board 1 district should refer to WEDG standards from the beginning of the design process and implement to the best of their ability design standards which maximize resilience, ecology, and access; and

**BE IT FURTHER RESOLVED THAT** Brooklyn Community Board 1 encourages a full WEDG certification process for potential application to new construction and renovation in the community; and

**BE IT FURTHER RESOLVED THAT** Brooklyn Community Board 1 urges other Community Boards and Borough Boards in New York City to leverage this freely available resource to enhance resilience, ecology, and access by adopting resolutions of their own:

### -1- BSA APPLICATION # 2018-191-BZ; 215 North 10th Street

Ben Stark presented this application for a special permit to reduce parking for use Group B Office Use in this proposed mixed-use building comprised of 64, 793 sq. ft. of new residential, office, and retail space. The requested permit will affect the parking requirements for only the spaces designated for office use.

Without the permit the developer would be required to provide 102 spots for the office spaces; the permit will allow a reduction to 51. The developer is offering to provide the 51, plus the 16 required for residential units, 3 required for retail, and an additional 7 spots, totaling 77. There will also be ample provision for bike parking. The study for peak demand found there would not be an expected need for more than 45 spots for all uses.



williamsburg

There will be 31 residential units on the  $4^{th}$ ,  $5^{th}$ , and  $6^{th}$  floors. None of these units will be marketed as affordable, but inclusionary housing certificates will be purchased, so there will be affordable units in perpetuity elsewhere within this community board. The 36,000 sq. ft. of office use will be on the  $2^{nd}$  and  $3^{nd}$  floors. There will be 800-900 sq. ft. of retail on the ground floor, along with a garage entrance and the residential lobby. Any parking spaces that are not used will be available to the public for a fee.

In light of the city's plan to reduce the current parking requirements for office usage, because of findings that the current requirements are outdated, the committee voted unanimously for approval.

Recommendation - Approval by unanimous vote.

A meeting of Brooklyn Community Board #1's Public Safety & Human Services Committee was held at the offices of the Community Board, 435 Graham Avenue, on Wednesday, January 30, 2019 at 6:30 PM.

Attendance: Present - Thomas Burrows, Dana Rachlin. Absent: Barrost; Barros; Cabrerea; Chirichella; Foster; Gangone; Iglesias; Indig; Kaminski; Katz; Landau; Leanza; Low; Viera. A quorum was not present. Also in attendance were Sgt. Brown, DHS, Det. Qiao, DHS and PO Farley, DHS.

The meeting was held on a very cold day and was preceded by a snow squall that resulted in a number of people not being able to attend.

1. Homeless Service:

At the prior meeting of the Committee we had been unable to get the attendance of representatives of DHS and it was recommended by Erin Drinkwater, Deputy Commissioner, Intergovernmental and Legislative Affairs, that we reach out to her, Shane Cox or Matt Borden. DI Dooley of PSA3 had also mentioned Shane Cox, who we believe is with the Street Homeless Solutions Division.

DI Dooley, who is no longer at PSA3, also advised the Committee of the great efforts undertaken in the NYCHA Housing sites within PSA 3. There were three peace officers from DHS in attendance at our meeting this month. The





Captain had called the day before and suggested they attend our meeting. However, these three officers worked at the Bedford/Atlantic Armory site.

For our next meeting we must reach out and contact the Street Homeless Solutions Division, Street Smarts and the Site Commander for the BRC/66 Clay. This includes Shane Cox, Matt Borden and Lt. Gourdine of DHS PD.

2. Project Renewal:

A request had been made by Richard David, AVP, Nonprofits, at Kasirer, to present to the Committee. Unfortunately our meeting date corresponded to the date of the Project Renewal Board meeting. We will invite to our next meeting.

### 3. Combatting Violence:

Dana Rachlin reported that Capt. Skretch of the 90<sup>th</sup> Precinct is working with Los Sures to assure the safety of residents in the NYCHA facilities. Ms. Rachlin explained that there has been a tremendous reduction in crime. The program was developed through a conversation among Councilmember Reynoso, Ms. Rachlin, Capt. Skretch and Los Sures. It is funded with Crisis Management money from either the Mayor's office or the Councilmember.

Mr. Burrows reminded Ms. Rachlin that they both had met with Los Sures in the past regarding supporting their efforts and funding of a program. If the program is seeking the support of Community Board #1 the Committee and the Board would need a better understanding of what the program is, who it serves and what support we might provide.

Susan Unger, of the Youth Leadership Council at NYCHA had reached out to CB#1 about the program she is operating in Bushwick Houses. Similar to the above concerns regarding the Los Sures program, a presentation to the Committee with a report to the Full Board would be beneficial in educating the Board and community about what services are available and what efforts are taking place. This meeting might also include the NCO's from PSA3.

### 4. NYPD:

The representatives of the 94 Precinct, the Executive Officer Captain Jimmy Koutroumanos and Community Affairs Officer PO Molina updated the committee on issues and concerns and the committee members raised issues with them. Both representatives participated in the discussion regarding the homeless and reported no issue at both BRC and 66 Clay. There had been a homicide in Cooper Park and the precinct had identified a person of interest. Trucks being off route and parking overnight was discussed and it was reported that the precinct has a new traffic officer.

### 5. DYCD NAB:

The Brooklyn BP's office held an information meeting for interested parties to attend who wished to become members of the Department of Youth and Community Development's Neighborhood Advisory Board. Mr. Burrows is a present member of the NAB and explained that the NAB is to consider needs in our area. Meetings have been held very infrequently and Mr. Burrows will follow-up.

The next meeting of the Community Board #1, Public Safety & Human Services Committee is Wednesday, March 27, 2019, at 6:30pm. Hopefully notice can be sent out to the above mentioned City and Non-profit agency representatives for them to attend the meeting. If you have any agenda items or issues of concerns please advise the Committee.

A quorum was not met.

### AGENDA:

### 1. Film Street Abuses: System Dynamics Complaint Letter to Councilman Steven Levin

Ms. Vera Zhun appeared representing Safety Dynamics to discuss the excessive use of streets in front of their facility as well as recent changes to signage by NYC Dept. of Transportation. She reiterated many of the complaints listed in the December 11<sup>th</sup> 2018 & January 24<sup>th</sup>, 2019 emails from Christian Bittar, Director of Safety & Quality, to Councilman Levin "Grave injustice in District 33"/"Here we go Again" (respectively)

• Recent installation of DOT 'No Standing' signs (for day-lighting) have been installed without notice.

• Parking for clients has been seriously impacted due to this change.

• Production vehicles have been using the block multiple times per month which has also restricted parking for their clients, and crews have been holding spots for non-production vehicles.

,

- Production crews have also blocked the sidewalk and left messes on occasion.
- Ms. Zhun was very clear that they have had a positive relationship with Broadway Stages, but the use of the street in front of there facility more than once a month is excessive.

Safety Dynamics is working with Council member Levin's office and Everygreen to establish a "Hot Spot" for their block, to reduce the number of days that production vehicles can be issued permits.

Mr. Anthony Argento of Broadway Stages, in addition to submitting a letter addressing Safety Dynamic's email point by point (attached), defended accusations that Broadway Stages was responsible for the items in Safety Dynamic's complaint.

Mr. Michael Fucci & Mr. Frank Covino of CBS "Blue Bloods" & Mr. Tom Dunn of "Billions" Possible Productions Inc., whose productions were sited in the complaint letters from Safety Dynamics appeared to defend the legal process of siting their production vehicles at the disputed location.

After some discussion among the committee & the public, these productions pledged to work with the Community Board to address Safety Dynamics concerns going forward, but could not make a commitment to not use the disputed location.

The Chair will follow up with these productions for future meetings.

Mr. Sol Kjok of NO Sphere Arts; Mr. Richard Mazur of Milton Street Block Assoc. & Ms. Dawn Witbiek, all spoke on behalf of Broadway Stages as good neighbors who have been helpful to the community in ways both financial and practical.

Police Officers Molina & Rivera of the 94<sup>th</sup> Precinct attended. They were asked by Mr. Elkins of the cmte what can be done to address issues of alleged bad actors on the block, such as 5 Star Carting who block parking with their trucks and also bike lanes. The officers noted that they always make the best effort to summons those vehicles, and encouraged the community to inform the precinct when they see illegal behavior.

Mr. Warren Cohn, of Herald PR, who has worked with the Transportation Cmte in the past, suggested to renew calls on the New York City Council to enact laws that specifically target the over-use of particular streets.

The Committee with will work with Mr. Cohn, Council members Levin & Reynoso to consider what legislative fixes are appropriate and possible going forward.

The Chairperson also made it clear that the purpose of this agenda item was not to single out Broadway Stages in any way, but to continue the community's dialog with the film industry to address the abuses that do occur, particularly around production parking.

The chair also noted that there is no explicit right to on street parking for private vehicles or businesses beyond those permitted by law. However, if there is an historic expectation of available parking in a particular location, the city must respect that and take steps to work with the community to ensure some reasonable level of parking access.

The committee will continue to monitor the efforts at the location around Safety Dynamics and work with the NYC DOT to address the concerns specific to them in the complaint.

### 2. Grand Street Redesign

Discussion on "permanent" changes to Grand Street in light of Governor Cuomo announcement to cancel April L Train shut down.

Since many of the plans for Grand Streets express bus service are now on hold following Governor Andrew Cuomo's announcement that the scheduled April L Train shut-down will not happen. There are a number of issues with the current state of Grand Street. The situation as it currently stands must be addressed by NYC DOT & the MTA to ensure that business, residents and the community at large has safe access to and use of Grand Street.

Ms. Erin Piscopink of the Grand Street BID appeared to list the BID's members concerns:

• 70% of the new bus lanes were installed before the end of "painting season" by the DOT which has led to much confusion regarding use.

• Vendors making deliveries to businesses often have little other choice than to park in the bus or bike lane...or double park causing significant safety concerns.

• Congestion on Grand Street has resulted (and exacerbated by the delivery parking issues)

• Grand Street was scheduled to be resurfaced after L Train Service was restored. There has been no update on the status of the resurfacing since the announcement.

• Aggressive enforcement has unfairly targeted businesses who are still adjusting to the new plan.

• There have been suggestions from Council member Reynoso that the redesign to keep protected bike lanes and bus lanes will remain. The Grand Street BID is asking that now that the L Train Mitigation Plan is void to some degree, that as with any other bike lane siting, the NYC DOT MUST hold appropriate public process hearings.

Mr. Alexis Rodriguez from Council member Reynoso's office noted that their office:

• Has been meeting with the stakeholders (BID, Transportation Alternatives & constituents) since 2016 and will continue to do so.

• There have been many accidents on Grand Street and cyclist and pedestrian safety will allays take priority over parking concerns.

Mr. Phil Leff of Transportation Alternatives noted:

• Parking is less important than cyclist & pedestrian safety since most patrons walk or take the train to Grand St.

- TA supports Grand Street Businesses but feels that safety must take precedence
- There have been 4 fatalities in recent years, making protected bike lanes necessary.

• DOT has not created the best plan for Grand Street, and feels they have more work to do to improve the overall plan.

• Agrees with the BID that a public process is necessary to address all concerns.

Mr. Moses Fullman noted that as the owner of a driving school, he always emphasizes that motorists watch for cyclists and pedestrians.

Mr. Noel Hidalgo, a 15 year resident of CB1 noted:

- He is still mourning the loss of other cyclists killed on Grand Street.
- There is a lack of enforcement that is contributing to the safety issues
- Calls on the city to make safety improvements a priority.

Mr. Erik Pye, a BID member:

- Deliveries since the current redesign have been a huge problem for his business and the neighboring bakery
- He submitted drafts of a more workable plan that he was asked to draw up following a conversation with Council member Reynoso's office (attached).
- He is PRO- bike, but feels that the plan as is does not protect cyclists, pedestrians or motorists.

Ms. Cynthia Rogers or Williamsburg Animal Clinic:

• They see a lot of emergency cases, and the current street treatments make it impossible for patients to access the facility appropriately.

• Mentioned that Council member Reynoso has committed to fixing their particular situation, but as yet has not followed up. Mr. Rodriguez said that he would follow up with the clinic.

• As a general safety measure, bike signals should be installed to reduce the number of near missed accidents she has witnessed involving bikes. Under the current design, cyclists are protected but often unseen by motorists making turns. Additional signals will be very useful in the final plan.

Barbara Hertel mentioned that the 5<sup>th</sup> Street connector to Grand Street still needs work to improve safety.

Mr. Nick Gorksi, a Ridgewood Resident who frequents Grand Street to access the bridge noted:

- He was hit on Grand Street while on his bike.
- The unfinished design is causing confusion and creating safety problems

• Biking is a boon to businesses on Grand Street since he knows many other of his friends who use the corridor and patronize business there.

• There should be a full hearing of issues before the plan is full implemented.

Mr. Kyle Yakal-Krenski:

• Was involved in a serious crash on his bike due to an exposed grate IN THE BIKE LANE on Grand Street.

- The area around Key Foods has obstructed views for all and is very dangerous.
- There is a lack of enforcement on bike lane obstruction.
- Bakery dumpsters & Concrete trucks in the bike lane are a constant problem
- The new design as is is "almost worse" than before.

Committee Member Elkins noted that there were similar concerns and unnecessary hostility generated in Queens during the Skillman Ave Redesign which has not been helpful. He suggested that all stakeholders communicate as much as possible among themselves moving forward to ensure that the best possible final plan results. He also concurred with the BID that a proper public process is needed.

(The issue of pedal assist and e-bikes was brought up. Ms. Elizabeth Addams from Council member Levin's office noted that there are several bills in the pipeline to address safety for delivery workers and other. This was mentioned since many of the food establishments on Grand Street offer delivery. The chair will review any new bills and address there implications with the committee and board going forward.)

The Chair has made a commitment to all stakeholders to keep this item on the agenda indefinitely to work towards the best possible final redesign of Grand Street. With the permission of Board Chairperson Fuller, DOT & MTA will be asked to attend follow up meetings on this item.

### 3. DISCUSSION: Opening of Clymer Street Entrance to Brooklyn Navy Yard

Mr. Michael Gary Schlesinger, a Committee Member asked that the committee take up the possibility of opening the Clymer entrance to the Navy Yard:

- 1. It will improve congestion issues on Kent & Flushing Avenues & reduce drive times.
- 2. It is now considered a public use facility and access by cars and bikes are appropriate.

Mr. Moses Fullman also spoke on behalf of the proposal:

- 1. MTA buses use that access point...so why not residents.
- 2. Congestion on Williamsburg Street will be reduced.
- 3. If there was better access by bike to his shul on Kent/Hooper, he would bike.
- 4. Is aware of motorists lying to the gate to access Navy Yard to short-cut to Flushing/Washington Aves

Committee Member Elkins agreed that opening that entrance would cut a lot of wasted travel time currently experienced by going around the Navy Yard. Also noted that it is unfair that Steiner Studios had their own private redesign at this location and all their vehicles and employees have access.

The chair asked that Mr. Schlesinger organize a coalition to work on this issue and will make this item as regular on the agenda as necessary and appropriate.

NOTE: Mr. Robert Perris, District Manager of CB2 was invited to discuss this issue as a courtesy as the Navy Yard proper is sited withing that district. Mr. Perris declined to attend or participate. Mr. Perris' tone was unfortunate, however, as this item becomes more prominent, the chair will continue to reach out the representatives of CB2 for their input.



### **GreenThumb Updates:**

<u>I.S. 318 Project Roots</u>: I.S. 318 Project Roots is a 20+ year old food-producing garden founded in 1996. The garden is affiliated with the intermediate school across the street, I.S. 318 Eugenio Maria de Hostos School: Academy of the Arts & Sciences. In fall 2018, GreenThumb began a garden rebuild with I.S. 318, starting with dismantling broken structures, removing debris, and leveling the paths through two workdays with GreenThumb's Volunteer Program and with support from the GreenThumb Operations team. This winter, GreenThumb is continuing

### Metropolitan Pool & Fitness Center

Metropolitan Pool, & Fitness Center in the Williamsburgh section of Brooklyn, was built under the auspices of Borough President Edward Riegelmann in 1922. The pool and bath were designed by the noted Lincoln Memorial architect Henry Bacon (1866-1924). It was the eighth of nine municipal bath houses erected by the Department of Public Works, in order to promote public health, hygiene and recreation.

In 1922 annual use of the city's bathhouses was a remarkable 13 million visits: Overseeing Brooklyn municipal construction were Joseph A. Guider, Commissioner of Public Works and James J. Byrne, Superintendent of Public Buildings, each of whom later served as Borough President.

In 1935 the structure was turned over to the Department of Parks to operate as a recreational facility. At that time the pool had lockers for 248 males and 37 females. Average monthly attendance In the mid-1930s was 20,620 and shower usage was 7,675 a month. The building underwent repairs in 1936 and again in 1977, prior to the massive reconstruction completed in 1997. Architect Bacon was known for his interest in ancient Greek architecture, and his design in 1920 for Metropolitan Pool combined functionalism with certain neo-classical details, such as the pediment on the facade. The exterior of brick with limestone trim and a granite base, however, is modest in comparison with the interior's dominant feature, a soaring skylight supported by a vaulted steel frame above the pool area. Glazed terra-cotta was used as an interior finish for the natatorium (the name applied to indoor swimming pools in the early 20th century).

Metropolitan Pool & Fitness Center contains an indoor pool, weight room, cardio room, a multipurpose community space, as well as free classes for all of our members.

Young Adult Membership: Is \$25 for young adults ages 18 - 24 with access to all recreation centers, including those with indoor pools.



to remove broken raised beds and prepare the site for new raised beds. I.S. 318 Project Roots will be hosting two Visioning Sessions for students at I.S. 318 and another session open to the public in March 2019, in order to redesign the layout of new raised beds.

<u>Grand Street Community Garden</u>: With targeted support in 2018, GreenThumb worked with members of Grand Street Community Garden to clean up the garden, remove debris, replace the majority of the garden beds, and receive new infrastructure (new fencing and a new shed). For 2019, the priorities are to support the garden group in creating bylaws and establishing membership procedures (with translation assistance), provide more raised beds and soil/compost mix, and increase public access to the site.

<u>Berry Street Garden</u>: Berry Street Garden is a beautiful food-producing garden with flowers and trees in South Williamsburg. The main priorities for Berry Street Garden in 2019 are to formalize membership guidelines and bylaws, as well as work with the garden group to create a plan to fundraise for and build a new storage structure.







### WOMEN'S ISSUES COMMITTEE REPORT

TO: Chairperson Dealice Fuller and Members of Community Board No. 1

FROM: Janice Peterson, Committee Chair

RE: Committee Report from February 5, 2019

The Women's Issues Committee met on Tuesday, February 5, 2019, at 6:00PM, in the CB #1's District Office, 435 Graham Avenue.

<u>Attendance</u>: Present: Peterson; Gallagher; Leanza. Absent: Cianciotta; Bamonte; Kaminski; Torres; Wilson. Also present were members of the community and representatives from elected officials. The sign in sheet is attached. A quorum was not achieved. A copy of the agenda is also attached.

- Ms. Peterson opened the meeting. Each person at the meeting made an introduction.
- Ms. Peterson noted that there was a play off Broadway about Gloria Steinem. She said that it would be a good idea to try and catch the play.
- She spoke about the committee's work to date and noted that they were moving forward on raising awareness about the priority issues of women in



Williamsburg/Greenpoint step-by-step. We hope to identify women's priorities for each of the community board committees.

- It was noted that it would be good to learn about what the political leaders were doing with women's issues.
- Ms. Peterson spoke about concerns around the "women's swim" at Met Pool. There was an article in the New York Times that was erroneous about the issue. This information had two effects. It helped galvanize the Women's Swim Group that is now known for their struggle. Those opposed to women swimming without men had a short time signing statements on social media happening over two years ago. Since then the Women's Swim Group has had hundreds of people signing their petitions in favor of women's swim.
- It was noted that the persons who were fighting for the extended hours of the Women's Swim were finishing up depositions for the Human Right's Commission. There needs to be some more organizing. This is a big issue. Do women have a right to have their own space? Obviously large groups of women (Muslim, Jewish, older women who are modest) do not get to do a lot of athletic activities as their needs are not planned for. The committee will consider reaching out to renew support of the board.
- Additional hours in the evening would be good. The additional time would offer women more hours to swim when they are working or when they have time from their family obligations/responsibilities. She noted that diversity is needed in order to address these issues. NYC is multicultural. Staffing at the pool needs to have sensitivity towards the swimmers. One of the community women who swims there is a certified lifeguard and an experienced swimmer. The women have been noting the numbers of people at the pool and documenting it, with cameras and attendance sheets. They also did petitioning and getting signatures of the swimmers. It was noted that there is a matter of modesty with the swimmers. Swimming is important for a healthy life.
- It was important to learn about what the elected officials were pursuing in terms of women's issues.
- <u>Signage Saluting Women Leaders</u> (Shirley Chisolm, Irene Klementowicz.-Ms. Peterson noted that the City was working on the installation of a statue honoring Congresswoman Shirley Chisolm. She was an important leader for this community. Ms. Peterson reminded all that March is "Women's History Month". Ms. Peterson noted that other women leaders also need to be also commemorated. There should be something in the community for them. She noted Irene Klementowicz was a leader in the Polish Community. Ms. Gallagher said that a mural would be a good way to honor them.

Representatives from elected officials at the meeting provided some updates on what they are doing.

- Men's Support Group A group of men spoke at the meeting relating that they have formed a men's support group and that they were focusing on women's issues and sensitivity. Ms. Gallagher provided a brief report from her community group on Sexual Harassment and a report was provided on Alison Turkos who police promised to help when she reported her sexual harassment. A year later nothing happened and she has to start all over.
- There was a discussion on the City's budget and process.
- Finally, plans began to be made for "Women's History" Month in March.
- The meeting was adjourned.

## What I See: Gloria Steinem, Shoulder to Shoulder With Women of Color

A cultural critic reflects on pictures of the feminist icon that show a rare moral courage.

One of the things we have lost in the digital era — and we have lost a lot — is a tributary medium of sorts, the tangible practice of holding an image in our hands that maps an emotional bayou of truth. Still photographs capture the private determination and personal integrity of their subjects in a way that, upon revisiting, makes selfies and iPhone pictures feel fleeting, contrived and manufactured.

#### What I See: Glozia Steinem, Shoulder to Shoulder With Women of Color - The New York Times

In perhaps my favorite image from The New York Times photo archive — an elegant profile — Eleanor Holmes Norton is kneeling on a stage, with Gloria Steinem standing at her feet. It was the 10th anniversary of the National Women's Political Caucus, and Eleanor, a cofounder of the caucus, was set to deliver the keynote address. She's dressed in white, with sling-back heels, and wears her hair in a short-cropped Afro. Her mouth is slightly ajar, because she is talking. Gloria's mouth draws lip to lip, closed, because she is listening. She has always listened to black women. I know because it is evidenced in the photographs which are templates of integrity — but also because she has always listened to me.

I have struggled with trust in my interactions with white women. This is among the topics I'm exploring in depth in my upcoming memoir, "Surviving the White Gaze." So it is no small thing for me to say that Gloria Steinem, not so much the icon as the woman, is among the very few I trust resolutely, instinctively and without conflict or concern. And this was before I saw these archival photographs.

The Times's archives are rich with pictures of Gloria. They weren't edited to reflect a certain truth, and yet the truth of the images is evident. Photograph after photograph of Gloria show her with so many of the black women she worked with during the 1970s — Florynce Kennedy, Evelyn Cunningham, Eleanor Holmes Norton, Jane Galvin-Lewis, Shirley Chisholm, Fannie Lou Hamer — wherein we see the embodiment of intersectional feminism. In each photo, there is ease and intent, focus and fury and, perhaps above all, a nearly palpable, unprompted sense of racial solidarity that makes me wonder why it's still so hard for us to get it right today.

I first reached out to Gloria in an email over a decade ago. I was working on a project about race, racism and white accountability — not the accountability of white women expressly, but of whiteness (before we were regularly using that term in common parlance), and its role in shaping perceptions of race and perpetuating black stereotypes. I wanted to talk with white public figures from a variety of fields, who were smart, honest and self-aware, and who had created culturally important work that also contributed somehow to the national conversation about race, but not in a glaringly obvious way. Gloria was at the top of my list — others included Tony Kushner, Cindy Sherman and Agnes Gund — because in my early 20s, I loved New York Magazine, and she was among the magazine's first columnists.

Also, from reading about the genesis and early days of New York Magazine, I knew that she had written this very famous story in 1969, "After Black Power, Women's Liberation," in which she writes about black women and people as, well, human. And then, of course, that she founded Ms. Magazine with the black feminist and child-welfare advocate Dorothy Pitman Hughes. To be honest, I was actually a little skeptical of her intentions, as I was when I met my white husband 16 years ago, who was that day traveling to a conference on race at Harvard. ("Who is this white person who cares about race, who considers blackness and black culture, without expecting any accolades in return?" I remember wondering.) Gloria responded to my email immediately. We talked for about an hour, and she asked me as many questions as I asked her. Later, in a follow-up email, she recommended a book she was reading that had reminded her of me, "Cultural Memory: Resistance, Faith and Identity" by Jeanette Rodriguez and Ted Fortier, a book that only someone who had truly heard and understood the complicated origin of my specific interest in race and racial identity would recommend.

In the years since our first meeting, I have turned repeatedly to Gloria as I navigated my nonlinear career in media. At one point, when I was working at an online company, there was a white woman high up with a lot of power, who was both racist and constantly trying to sabotage me. At my wits end, I emailed Gloria, who wrote back: "Don't you dare let her take your confidence or peace of mind away for a millisecond!"

That's the kind of forthright pledge to black women — to me, to us, to our peace of mind — I see in these remarkable images, some sepia-toned from weather and wear, others blurry or maybe rushed, but never dishonest. There is testimony in these photographs. A vivid telling of something unsaid. Of women gathering each other up. A promise of no one's concern but their own. I learned that promise from Gloria.

## She Built NYC: De Blasio Administration Announces Shirley Chisholm, First Black Woman to Serve in Congress, Selected for New City-Funded Monument

November 30, 2018

#### Monument will be erected at the Parkelde entrance to Prospect Park in Brooklyn

NEW YORK—Today, First Lady Chirlane McCray, Deputy Mayor Alicia Gien, and the Department of Cultural Affairs announced that a monument to U.S. Rep. Shirley Chisholm, the political trailblazer who was both the first black Congresswoman and the first woman to seek the Democratic presidential nomination, will be erected at the Parkelde entrance to Prospect Park. This is the first monument commissioned as part of She Bullt NYC, an initiative to construct public monuments honoring the New York City women who have changed history which kicked off with an open call for nominations in June 2018. The announcement that Rep. Chisholm was selected as the first She Bullt NYC honoree comes on the 94th enniversary of her birthday and the 50th anniversary of her election to the House of Representatives.

"Congresswoman Shirley Chisholm's legacy of leadership and activism has paved the way for thousands of women to seek public office," said First Lady Chirlene McCray. "She is exactly the kind of New York woman whose contributions should be honored with representation in our public spaces, and that is now being realized with She Built NYC."

"Shirley Chisholm was an American original—a fearless trailblazer who broke barriers and had an univaled commitment to justice," said Aiicla Gien, Deputy Mayor for Housing & Economic Development. "From standing up to Congressional leadership to taking bold bipartisan action, Rep. Chisholm made sure everyone knew she was 'unbought and unbossed.' There is no one more deserving than Rep. Chisholm of a statue honoring her life and legacy; may New Yorkers of all backgrounds be inspired by her story."

"Monuments in New York City's public spaces do not reflect the full breadth of our rich history and diverse population, and that's something we're committed to changing," said Cuitural Affairs Commissioner Tom Finkelpearl. "In recognizing Shirley Chisholm – an inspiring leader, true trailblazer, and consummate Brooklynite – this new artwork will be an important step toward fulfilling Mayor de Biasio's call for greater representation in our public realm. We're committed to working with residents to create monuments that express more completely who we are as New Yorkers, and who we want to lift up as embodiments of our shared history and values."

At women nyc, members of the public submitted nearly 2,000 nominations of women, groups of women, and events in women's history they believed should be permanently memorialized through She Bulit NYC. Ninety-eight percent of respondents said they would like to see a woman honored who was committed to social reform or justice. The most frequently used word in the submissions was "first," followed by "leader" and then "advocate."

An advisory panel with individuals representing a broad range of expertise and backgrounds helped refine the public submissions list and provided recommendations to the City. The selected artist who will design Rep. Chisholm's monument in early will be announced 2019. The monument will be installed by the end of 2020.

"It was a privilege to chair the She Bullt NY Advisory Committee whose members reviewed 1812 unique nominations of women-identified leaders from every possible profession," said Pauline Toole, Commissioner of the New York City Department of Records and Information Services and Chair of the She Built NYC Advisory Committee. "I em grateful for the spirit, insight and creativity of the Committee. With this announcement, the nation's most diverse city is taking a big first step recognizing the many women leaders who transformed New York."

"Shirley Chisholm was a New Yorker dedicated to ensuring equal participation for all at all levels of society, regardless of gender, race, and socio-economic status. It is essential that we continue to honor her legacy and carry on her life's work," said Jacqueline Ebanks. Executive Director. Commission on Gender Equity.

"Before she became the first black woman elected to Congress, and before she co-founded the Congressional Black Caucus and the New York chapter of the National Organization for Women, Shirley Chisholm was a Brooklynite. A monument to her in her home borough and in a district she once served will make the perfect addition to the soon-to-be renovated Parkside entrance of Prospect Park," said NYC Parks Commissioner Mitchell J. As the first black Congresswoman In U.S. history, Rep. Chisholm was a both leader and advocate for residents of New York's 12th Congressional District and the country at large. During her time in Congress, Rep. Chisholm served on several House committees, including Agriculture, Education and Labor, Veterens' Affairs, and Rules (where she was the first Black woman and the second woman ever to serve). Her notable achievements in Congress include working to expand access to food stamps, helping to create the Special Supplemental Nutrition Program for Women, Infants, and Children, helping to pass Title IX, which prohibits gender discrimination in the funding of education and related programs, and extending minimum wage requirements to domestic workers.

Rep. Chisholm became the first black major-party candidate to run for President of the United States in the 1972 U.S. presidential election. She was elso the first woman to ever run for the Democratic Party's presidential nomination.

Shirley Chisholm was born Shirley Anita St. Hill on November 30, 1924 in Brooklyn, New York. She was the oldest of four daughters of Charles St. Hill, a factory laborer from Guyana, and Ruby Seale St. Hill, a seamstress from Barbados. Following her graduation from Brooklyn's Girls High School, now known as Boys and Girls High School, she studied sociology at Brooklyn College and earned her B.A. In 1948. She also earned an M.A. in early childhood education from Columbia University.

The recommendations of the Mayoral Advisory Commission on City Art, Monuments, and Markers, formed in 2017, emphasized the need for additive measures and public dialogue to ensure monuments and markers on City property are given accurate and inclusive historical context. It also called for expanding the stories, histories, and narratives currently represented on public property in New York. The Department of Cultural Affairs has committed up to \$10 million over the next four years to commissioning new permanent public monuments and commemorations. This monument is the first of more to come.

The Initiative is part of Women.NYC, which was launched in May 2018 to ensure that New York remains the best city in the world for women to succeed.





DISTRICT SERVICE CABINET JANUARY 17, 2019 435 GRAHAM AVENUE

#### MEETING CALLED TO ORDER

District Manager Mr. Gerald A. Esposito called the District Service Cabinet Meeting to order and noted the agenda. It was a round robin session. He asked the members to introduce themselves and report.

**SANITATION - DSNY/BK1 Garage** - Superintendent Justin Gormely spoke about the pending snowstorm. They are expecting one – three inches of snow. They have 42 workers on a split shift cycle. There will be 40 workers tonight with plows on standby. He noted that they were anticipating the snow on Saturday to be 3-5 inches. On Sunday, the temperature is expected to drop to 6 degrees. Fourteen pieces of equipment will be out working to address the conditions. Supt. Gormely noted that they have no plans to have a snow melting operation in CB #1.

**OFFICE OF EMERGENCY MANAGEMENT** – Mr. Kevin Clark, Operations Manager, provided a handout on Important Community Information for January 2019. It discussed the importance of creating an emergency plan. Guidelines could be downloaded from their website. Presentations were available for events. CERT trainings are planned for Brooklyn in May. He noted that on Monday, January 28<sup>th</sup>, the Department of Homeless Services (DHS) is conducting its homeless outreach population count (HOPE). Volunteers can register to help with the count.

**FDNY-** Chief Peter Gannon, from the 35<sup>th</sup> Battalion, provided statistics. He noted that fires are higher in the winter months. Ms. Sandra Sanchez, FDNY Community Affairs, said that all should be "fire smart" and practice for a fire event. She pointed out that generators should be kept outside. All heaters should be plugged directly into an outlet.

**CENSUS BUREAU** – Mr. James Tillmon, from the Census Partnership provided a briefing on the 2020 census. He noted that an office is opening near Woodhull Hospital and that they were looking to hire people. Interested individuals can apply on line. The applicant must be 18 years or older, be a US citizen, have no felonies, and should be able to count. Workers will be trained



and they will be using tablets instead of paper survey forms. He noted that with the Federal Government shutdown they were not fully operational yet. He noted that in the 2020 census, the question about citizenship (question #11) was removed. They have changed the process for the census to be an easier one. The questionnaire takes about 2 1/2 minutes. He related that the census effects everything. Workers will be issued ID's. He noted that they were looking for persons who have other language skills. The census is important because it brings money for the community. They are looking at \$53 billion for New York.

**DCA** – Ms. Marian Jones, Community Affairs, announced that they would be offering free tax preparation. A flyer noting the requirements was distributed.

The U.S. Constitution requires that each decade we take a count—or a census—of America's population. The 2020 Census goal is to count everyone once, only once, and in the right place.

The census provides vital information for you and your community.

- It determines how many representatives each state gets in Congress.
- Communities rely on census statistics to plan for a variety of resident needs including new roads, schools, and emergency services.
- Businesses use census data to help provide more local jobs and places to shop.

Each year, the federal government distributes hundreds of billions of dollars to states and communities based on U.S. Census Bureau data.

### How well do you know the 50 states?

The Census Bureau is the federal government's largest statistical agency. We are dedicated to providing current facts and figures about America's people, places, and economy. Federal law protects the confidentiality of all the information the Census Bureau collects.

#### **OUR STATISTICAL PROGRAMS**

#### Censuses

- The Decennial Census is the once-a-decade population and housing count of all 50 states, the District of Columbia, Puerto Rico and the Island Areas as required by the U.S. Constitution. The results of the decennial census determine the number of seats for each state in the U.S. House of Representatives and are used to draw congressional and state legislative districts and to distribute more than \$675 billion in federal funds each year.
- The Economic Census measures the nation's economy every five years, providing vital statistics for virtually every industry and geographic area in the country.
- The **Census of Governments** provides comprehensive data about the nearly 90,000 state and local governments in the nation every five years.

#### Surveys

- The American Community Survey (ACS) is an ongoing annual survey that shows what the U.S. population looks like and how it lives. The ACS helps communities decide where to target services and resources.
- **Demographic surveys** measure income, poverty, education, health insurance coverage, housing quality, crime victimization, computer usage, and many other subjects.
- Economic surveys are conducted monthly, quarterly, and yearly. They cover selected sectors of the nation's economy and supplement the Economic Census with more-frequent information about the dynamic economy. These surveys yield more than 400 annual economic reports, including principal economic indicators.
- **Sponsored surveys** are demographic and economic surveys that we conduct for other government agencies. They include the Current Population Survey, the National Health Interview Survey, and the National Survey of College Graduates.

What are we proposing? NYC Parks proposes to amend § 1-04(g) of Chapter 1 of Title 56 of the Rules of the City of New York. Under the amended rule, individuals will be prohibited from feeding all animals, including squirrels, pigeons, and other birds, in areas under the jurisdiction of NYC Parks.

When and where is the hearing? NYC Parks will hold a public hearing on the proposed rule. The public hearing will take place at 12:00 p.m. on March 1, 2019. The hearing will be in the NYC Parks hearing room at the Pelham Fritz Recreation Center, 18 Mount Morris Park West New York, NY 10027.

What authorizes NYC Parks to make this rule? Sections 389, 533(a)(9), and 1043 and of the City Charter authorize NY Parks to make this proposed rule. This proposed rule was not included in the NYC Parks regulatory agenda for this Fiscal Year because it was not contemplated when NYC Parks published the agenda.

Where can I find NYC Parks' rules? The NYC Parks rules are in title 56 of the Rules of the City of New York.

What laws govern the rulemaking process? NYC Parks must meet the requirements of Section 1043 of the City Charter when creating or changing rules. This notice is made according to the requirements of Section 1043 of the City Charter.

#### NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

#### Statement of Basis and Purpose of Proposed Rule

NYC Parks proposes to amend § 1-04(g) of Chapter 1 of Title 56 of the Rules of the City of New York. Under the amended rule, individuals will be prohibited from feeding all animals, including squirrels, pigeons, and other birds, in areas under the jurisdiction of NYC Parks.

The purpose of this proposed rule is to:

- Reduce food sources available to rats and other rodents, which are attracted to all types of food in properties maintained by NYC Parks.
- Prevent harmful interactions with animals in NYC Parks properties. Wildlife accustomed to feeding lose their wariness of humans and may exhibit aggressive behavior. Animals exhibiting aggressive behavior may then have to be lethally removed and tested for disease.
- Support the efforts of New York City's WildlifeNYC campaign to raise public awareness about urban wildlife.
- Promote compliance with the New York State Department of Environmental Conservation's guidance, which advises that wildlife feeding disturbs the healthy balance between wildlife populations and their habitats.
- Prevent the transmission of disease that occurs when animals congregate around feeding areas. In these areas, food may be contaminated with feces, saliva, and urine, promoting the spread of diseases. These diseases are often fatal to animal populations and some may be spread to humans. For example, a canine distemper outbreak recently led to the deaths over 300 raccoons in New York City's parks.
- Support healthy wildlife nutrition and behavior. Food given to wildlife does not contain the nutrients needed by New York City's wildlife and deters them from seeking the natural foods—like insects and plants—with nutrients they need. Young animals fed by park patrons may not develop properly and may lose the instincts needed (such as hunting and foraging) to survive on their own.
- Reduce the maintenance burden on NYC Parks staff responsible for maintaining a safe and clean environment for park patrons.
- Promote compliance with existing prohibition on feeding in NYC Parks properties.
- Clarify § 1-04(g) of the NYC Parks rules.

The Department's authority for these rules is found in sections 389, 531 and 1043 of the New York City Charter.

<u>New material is underlined.</u> [Deleted material is in brackets.] "Shall" and "must" denote mandatory requirements and may be used interchangeably in the rules of this department, unless otherwise specified or unless the context clearly indicates otherwise.

Section 1. Subdivision g of Section 1-04 of Chapter 1 of Title 56 of the Rules of the City of New York is amended to read as follows:

#### (g) Abuse of park animals.

(1) Except, pursuant to a permit for trapping issued by the Department, no person shall molest, chase, harass, injure, wound, trap, hunt, shoot, throw missiles at, kill or remove any animal, any nest, or the eggs of any amphibian, reptile or bird, or otherwise harm or intentionally take actions that could reasonably harm any animal, nest, or such eggs. Further, no person shall knowingly buy, receive, have in his or her possession, sell or give away any such animal or egg taken from or killed within the jurisdiction of the Department, including any zoo area. Violation of this paragraph constitutes a misdemeanor.

(2) No person shall feed animals [in any park (including any zoo area) except unconfined squirrels and birds, and] <u>except</u> where specifically authorized by the Commissioner. [The Commissioner may also designate certain areas where all feeding of animals is prohibited. It shall be a violation of these rules to feed animals in any area where such feeding is prohibited.] <u>This rule does not apply to feeding personal pets or service animals brought to an area under the Department's jurisdiction in compliance with its rules.</u>

#### DEP Wastewater Resiliency Program Newtown Creek Wastewater Resource Recovery Facility Summary for Brooklyn Community Board No. 1 Contract RLCY-NC-01 January 2019

The New York City Department of Environmental Protection (DEP) owns and operates one of the largest wastewater collection and treatment systems in the world, with 14 wastewater resource recovery facilities and 96 pumping stations to convey stormwater and wastewater to treatment. Many of these facilities are located in low-lying areas, as much of the system is gravity-fed, and along waterfronts. As a result, coastal flooding and storm surges pose a major risk for the City's wastewater infrastructure.

During Hurricane Sandy in October 2012, flooding caused over \$130 million of damages to wastewater facilities citywide. At that time, DEP had already been studying the impacts of climate change on wastewater resource recovery facilities, and, in October 2013, completed the NYC Wastewater Resiliency Plan. This plan evaluated flood pathways and vulnerabilities, likelihoods and impacts of failures, and appropriate adaptation strategies for DEP's wastewater facilities.

In order to address the at-risk facilities quickly without large-scale, facility-wide design contracts, DEP established the NYC Wastewater Resiliency Program to implement flood protection improvements. DEP has secured \$161 million from the NYS Environmental Facility Corporation Storm Mitigation Loan Program to fund the Resiliency Program, thereby limiting the cost to rate payers.

The Newtown Creek Wastewater Resource Recovery Facility in Brooklyn (see the attached map) is included in the Resiliency Program. The flood protection strategies proposed for this facility include water-proofing building walls, installing deployable flood barriers, elevating critical equipment above expected flood levels, and installing flood-proof equipment. See the attached site plan.


Construction costs for flood protection at Newtown Creek Wastewater Resource Recovery Facility are approximately \$7 million. Design completion is scheduled for January 2019 and construction completion for January 2021.



Dear Commissioner Silver and Chair Lago,

Over the course of the past year, it has come to the attention of community residents in North Brooklyn that Waterfront Public Access Areas (WPAA), which are required to be created by private residential tower developers along Greenpoint's Newtown Creek and East River waterfronts, are being designed by developers, advised and approved by the Department of Parks and Recreation, and certified by the Department of City Planning in ways that residents believe are indifferent to the Waterfront Access Plan (WAP), the Greenpoint Williamsburg Waterfront Open Space Master Plan (Master Plan), and the Waterfront Public Access Design Standards Text Amendment for Privately Owned Spaces (Waterfront Standards).

These documents codified rules and contained commitments made to the community regarding coherent and consistent design standards and elements for these waterfront spaces in order to promote quality design and an inviting, interactive experience for the public. The community's concern is that by not following through with those commitments, the City is breaking trust with the community. As is well known, the 2005 Greenpoint Williamsburg Rezoning Resolution has been a major black eye for the North Brooklyn community; the waterfront parks and open spaces promised to us as a part of that resolution were an essential amenity that our district expected to be created with maximum acreage and with adherence to standards. Residents and local organizations helped conceive the standards, putting in an incredible amount of personal time

and dedication, in order to help absorb the impact of a massive proliferation of high-density buildings and influx of residents on the waterfront and throughout the district.

The community remains concerned that, in general, the approved WPAA designs have been overly rigid designs with a predominance of hard surfaces and edges, railed-off straight wateredge platforms and recycled plastic furniture, all adding up to a less-than-inviting experience and an elemental design that goes against the rules and spirit of the above-mentioned documents.

Therefore, regarding Greenpoint-Williamsburg waterfront open space design and planning, this is to state and request that all components and elements of the open space design of the Greenpoint-Williamsburg waterfront must be consistent with 1) the Greenpoint-Williamsburg Waterfront Open Space Master Plan for public and private development of park and esplanade parcels and 2) the Waterfront Public Access Design Standards Text Amendment for Private Spaces.

These documents were created during, and in response to, the Greenpoint-Williamsburg rezoning of 2005 by NYC Department of City Planning, NYC Parks Department and the North Brooklyn Community; the components and elements of the Master Plan were chosen in consultation with the community. Community members spent many hours working together with these city agencies to select and approve aspects of the plan. The Master Plan and the subsequent Waterfront Standards were specifically created and approved by Parks and City Planning as a blueprint for the design and development of the North Brooklyn waterfront open spaces.

To this end, we are recommending and requesting the following:

- That all plan elements are consistent with the Master Plan and Waterfront Standards
- That proposed designs reference these documents and are consistent with these documents for all aspects of design, elements and materials
- That plan presentations prove adherence by showing the corresponding Master Plan and Standards details alongside the proposed design features
- That any deviations from the Master Plan and Standards are specifically illuminated and justified with the intent of seeking the approval for any inconsistencies with the responsibility of proof that any deviations are an improvement and/or necessary
- That any deviations from the Master Plan are specifically vetted by the community as in the original process; this relates to all elements from water-edge treatment to water fountains and includes the seating choices since the original selection, still in the Master Plan, failed and therefore must be specifically re-chosen in tandem with the community; it is requested that this selection take place within a CB1 Parks and Waterfront Committee framework and applies to all current and upcoming esplanade and park designs, including both Box Street Park and 50 Kent Park at Bushwick Inlet Park
- That parcels of private development must adhere to both the Master Plan and Waterfront Standards and must refer to both documents within plans and during presentations as above; Waterfront park plans must be consistent with the Master Plan.

The Master Plan and the Waterfront Standards were created by NYC Department of Parks and

NYC City Planning. They serve a purpose. They seek to ensure quality and consistency of waterfront design. The tenor of naturalism and quality of design, materials and the experience they seek to evoke must be enabled and followed. The North Brooklyn community, and all New York City, deserves to experience world class design and proof of the adherence to the plans it helped to create.

We would appreciate your communication to all parties that the above points are valid and must be honored and adhered to for the sake of all New Yorkers. Quality design in parks, with beauty and connections to nature, are essential to the health and well-being all.
