1. **PRESENTATION-306 RUTLEDGE STREET**: Application to allow a use variance filed pursuant to Section 72-21 of the Zoning Resolution of the City of New York ("ZR"), seeking a variance of ZR Section 32-00, within a C8-2 zoning district, to permit the development of twelve

two-family town homes (24 dwelling units), which will total 73,681 square feet (2.79 FAR). Presenter: Robin Gonzalez – Erik Palatnik, P.C., Attorneys at Law

2. PRESENTATION-17 FILLMORE PLACE: The project proposes to maintain the existing historical front street façade, while creating a single-family interior, which utilizes a three-story central atrium, to connect the individual floors together into a shared family residence. The design of the interior atrium is then translated to the rear elevation of the residence, which proposes to better match the adjacent building's rear extension in style. The floor area void created by the atrium, is recaptured by the extension of the upper two floors, which creates a cohesive rear elevation, not visible from the surrounding perimeter streets.
