- AGENDA: 1233 57th Street Rezoning Application The Applicant has requested to return to the Board with a revised application. The applicant seeks a zoning map amendment and a zoning text amendment to rezone the Project Area from R5 to R6B. The Proposed Actions would apply to Block 5690, Lots 51, 53, 54, 58, and 62.

The Proposed Actions would facilitate the development of a 75,534-gross-square-foot (gsf), 36-dwelling unit (DU) residential building at 1233 57th Street on Lots 54, 58, and 62, "Projected Development Site 1."

The Applicant proposes to develop a **four-story**, 75,534-gsf residential building containing 36 DUs ((1) 1BR 600 gsf; (1) 2BR 775gsf; (32) 3BR 1250 gsf; (2) 4BR 1800 gsf) and 58 enclosed accessory parking spaces. The building would contain 53,534 gsf of residential use and 22,000 gsf of accessory parking. It would have several setbacks for private terraces and building articulation and would rise to a roof height of 45 feet. The vehicle access and egress would occur from 2 new curb cuts on 57th Street on both sides of the lot line.

Projected Development Site 2 (Lots 51 and 53) is not Applicant-owned, and there is no specific development proposal for this site.
