PLEDGE OF ALLEGIANCE:

Board member, Dennis Vourderis led the meeting in the Pledge of Allegiance.

Chairperson Jeff Sanoff welcomed everyone to the final meeting of 2024.

PUBLIC HEARING: 2201-2227 Neptune Avenue Rezoning

This requires a zoning map amendment (M1-2 to MX – M1-5/R7-3), zoning text amendment (Appendix F and Article 12, Chapter 3), and Chairperson's Certification, to facilitate a new 18-story, approximately 161,500 square feet (149 Dus, 36 affordable) mixed-use development, including approximately 20,100 square feet of commercial floor area, is being sought by private applicant Neptune Avenue LLC in Coney Island, Community District 13, Brooklyn.

Carolyn Harris, OF Goldman Harris LLC, explained that to build the proposed building there must be a rezoning of the block to MX(M1-5/R7-3) which will allow for 162,595 square feet of additional floor area. Text amendment to add MIH and waterfront certification. The design of the project will take one year and the construction will take 2-1/2 years after the approval of the ULURP. The developers have contacted the NYCHA Tenants Association Presidents, the Alliance for Coney Island, Mark Twain Intermediate School, and the JCCGCI. Carolyn explained that the developers will reach out again to the Community Board as the project gets closer to construction. She gave an approximate timeline for the project. The developers will go before City Planning by the end of April, 2025 and before the City Council by mid June, 2025. The Borough President will review the project by the end of 2025.

Ida Sanoff discussed the area the project is going to be built on. There are two sites involved, but only one site is for development at this time. One site had been home to the Brooklyn Dyeworks and the other site was the Ida G. Israel Medical Center where there was a dental clinic where silver/mercury was used daily. This building was flooded during SuperStorm Sandy. If construction is to be done at this site, dust control measures must be taken during the construction. Ida asked if this site is developed will a shadow be cast over the creek and into Calvert Vaux Park. The developer had a study done about shadows. They will send a copy of the study to the community board. Ida thinks that something should be given back to the community, perhaps waterfront green space, if the additional property is developed.

Pat Singer questioned if the addition of this building would put more pressure on traffic using Neptune Avenue since there is only one way in/out of our community. Could a traffic study be done? (Traffic study was done and there would be no adverse impact on traffic). The developer is committed to making sure double parking will not be an issue.

Mark Mernyk asked if the WIN Shelter would lose bedroom windows due to the new building; (no, some apartments would be reconfigured and the residents of those apartments would have to be relocated while that was being done).

Angela Kravtchenko suggested that specific ideas for what the community would like to get from the developer should be submitted to the Land Use Committee.

Lucy Mujica Diaz asked if the homeowners across the street from the proposed building had been spoken to (not yet). She suggested that this be done before the Land Use Committee meeting on January 6th.

Miguel Naopf, a homeowner across the street from the proposed site stated that he had received a letter. He is concerned traffic will increase dramatically.

Leonard Maurice Robertson said he could not vote for this project because of how it was done. The people who live across the street from the site were not contacted, but the tenant leaders from the NYCHA buildings blocks away had been contacted. This was done backward.

Selina Grant asked how would the community benefit from this project, she believes they would benefit in a negative way. The community needs to know the long-term goals. The community must be proactive.

The community board will have a Land Use Committee meeting on January 6th and the full board will vote at the meeting on January 22nd.

PUBLIC SESSION:

Christian Molieri – He is a member of the Polar Bear Club, but he is speaking as a private citizen. He is against the casino.

Emmanuel Galitskiy – He is the President of the Luna Park Board of Directors. They have taken a vote and are against the casino.

Christopher D. Greif – MTA is coming out with a Reduced Fare Omni Card. There will be a webinar on Friday, Dec. 20th. The Holiday Train will be running. To find the schedule, check the MTA website.

Anna Daratany – She has resided in Coney Island since 1977. She is upset because businesses in Coney Island/Brighton Beach refuse to hire people over the age of 25. The area is full of problems. Coney Island USA may lose its location if the casino comes to Coney Island. No express trains stop at Stillwell Avenue, there are not enough lifeguards, and the area is full of illegal vendors.

Adam Rinn, Artistic Director Coney Island USA – He is against the casino coming to Coney Island. If the casino comes, it will undermine the amusement and entertainment area in Coney Island. If the casino comes and receives a variance, construction will be done that will obstruct the pedestrian walkway.

Marissa Solomon - She is against the casino coming and the demapping of the streets in our neighborhood.

Roman Gitis – He is against the casino coming to Coney Island.

Rachel Elizabeth Morrison – She is very concerned about the building that will be built at 2955 W. 29th Street. It will take away the green space and will block the sun. She has compiled a petition with many signatures. She is concerned about possible problems of fire safety, etc. She said this is happening due to the greed of the Russians who are involved with this building being built “as of right”. Board member, Yelena Makhnin, said that although the community board was asked for a letter of approval, we voted against such a letter. The building is being done “as of right” on private property and she feels nothing further can be done by the board. She believes this was discussed during a Land Use Committee meeting. She will further research this and asked Rachel to call her on Friday.

Tom Hoefel & Len Campbell – NIA – They thanked everyone who attended the tree lighting at Kaiser Park. Len is Director of the Cornerstone Program at Carey Gardens and invited everyone to visit the program.

Briana Harris – C.I. LIFE Learning Center – She said that they have three sites and are a not-for-profit organization which supplies free meals, among other things for the residents of Gravesend Houses and other NYCHA buildings. Charlene Davis spoke on how wonderful this organization is and that is a great place for children who reside in the Coney Island community. The board will vote at the end of tonight’s meeting to approve a letter of support for this community-based organization.

Lucy Mujica Diaz – She is against the proposed casino in Coney Island. She thanked Assemblyman Brook-Krasny for his letter against the casino coming to our community.

Max Mabadiv – He is against the casino coming to our community. There is not another safe space for LGBTQ+ and Coney Island USA is a safe place that would be lost if the casino came.

AM Alec Brook-Krasny – He thanked everyone for their words about his letter against the casino. He knows that what the community really needs is another way out of the community, perhaps a bridge of the creek. This is very important.

Olga Fiore – representing SS Spanton – She reported that the Senator has been working very hard to get some action on the problem of parking in the Municipal Lot in Brighton Beach. She is working on getting something done to keep the monthly paid parking spaces separated from the other spots, by a mechanical arm, so that the people who pay a monthly fee can make sure they always have a spot in the lot. In addition, the Senator is working on legislation to get a senior discount and perhaps increase the summons amount for illegal parking in the lot.

The Sheriff's Office in conjunction with DOHMH has closed a pizzeria in Manhattan Beach, located at 184 Oxford Street, where cannabis-infused pizza was being sold.

On Dec. 20th from 4-6 p.m. there will be a Toy Give Away with AM Brook-Krasny at his office. On Dec. 27th and 30th from 8 a.m. to 11 a.m. there will be free ice skating for children at Abe Stark Rink sponsored by Cong. Jeffries, Senator Spanton and AM Brook-Krasny and CM Brannan. Charlene Davis thanked Senator Spanton for making Thanksgiving special for her and her family. The Senator came to Charlene's house with all the items needed to make a Thanksgiving Dinner.

Zunera Ahmed – representing CM Justin Brannan- On behalf of the CM, she wished everyone a Happy and Healthy Holiday Season. Thanks to NIH for the multi-cultural celebration with tree lighting in Kaiser Park. Ice Skating on Dec. 27th and 20th from 8-11 a.m. All children are invited to skate. Their new office in Coney Island is finally opened. It is located at 1915 Mermaid Avenue and is open Monday – Thursday from 9 – 5 and Friday from 9-3. 718-373-0194.

Lucy suggested that Zunera ask the CM to attend the meeting about the proposed demapping of the streets, so he can hear firsthand what the community wants and feels they need.

Erica Koyfman – representing CM Inna Vernikov – She reported that the CM gave monies to both P.S. 100 and P.S. 370. She also gave a check to Luna Park Houses. The CM was able to assist in getting the homeless encampment near Grady cleaned up. On behalf of the CM, Erica wished everyone a Happy Holiday!
