- D.A. understand that vulnerable population will be exploited.
- Policies drive fear and fear drives the economy. •

• For ICE to enter a private home-they must have a Judicial Warrant. This type of warrant is issued by the court and must be signed by a judge. The warrant is very specific in what can be searched.

<u>Erica Koyfman – CM Inna Vernikov</u>- The CM has listened to the community. Although her district is not involved directly with the proposed Casino, she has come out against this project. The CM is sponsoring a Family Day from 12-3 pm on Sunday, May 18th. There will be a Bike Helmet Give Away at P.S. 255 Schoolyard from 11-2:30 p.m. If you are under 18, you must be accompanied by an adult to receive a helmet.

<u>Gabriel Blinder – AM Alec Brook-Krasny</u> – The AM is in Albany, working on getting the NYS Executive Budget for 2025 passed. The budget has increased by 6% from last year. The AM is focusing on health care and education, which has been increased by 15% for K-12 education and increased funding for higher education. The Public Safety budget has been increased by 4%. The transportation budget increased by 16% for the upgrading of infrastructure. The budget for capital projects has been increased by 8%.

<u>Roslyn Campbell-Office of Brooklyn Borough President</u>- The BP is holding a Climate Future Workshop at BH on April 28th & April 29th. There will be a Youth Summit on Friday, May 2nd. CHAIRPERSON'S REPORT:

Jeff explained that our committee meetings are hybrid. The committee members must be in person for quorum. All others may attend virtually. The dates of the committee meetings are posted in the newsletter and on our face book page. Our precinct is one of 6 precincts citywide to participate in the rollout of the Q Team (Quality of Life Team). They will follow up on 311 complaints on illegal parking, illegal vendors and all other quality of life issues that are reported. They will have operations for ticketing, and towing of illegally parked cars, etc. and summonsing, and confiscating merchandise from illegal vendors in both Brighton Beach and Coney Island.

Jeff Sanoff, Chair

Jeff announced that the community board wrote a letter to the Commissioner of DHS about the proposed homeless shelter to be built at 1605 Mermaid Avenue. We found out about the shelter, not from DHS but from Sheila Smalls, a board member and community resident. We are concerned as we don't think a homeless shelter is needed on Mermaid Avenue, a well-used shopping corridor. CM Brannan also sent a letter to the Commissioner. We believe that there are enough shelters in our community.

The Brooklyn Half Marathon will take place on Ocean Parkway from Prospect Park and onto the boardwalk to West 16th Street on April 26th.

The ULURP for 58 Nixon Court has been certified. This project will be built across from SBH. The Public Hearing will be held at the May Board Mtg. on Wednesday, May 28, 2025

DISTRICT MANAGER'S REPORT:

CM Brannan will have an Earth Day Celebration, weather permitting, on Saturday, April 26th at Surf Avenue and West 25th Street. Eddie attended the opening ceremony for all the rides in the amusement area. The kids enjoyed all the festivities. There was a Street Co-Naming for Frank Trapodi, which was well attended by friends, family and community residents. The office staff, Eddie, Jeff and several board members joined a Zoom meeting held by the Mgr. of Trump Village West about the cleanup of West 6th Street. Talks will be ongoing. Discussion of both long and short term solutions.

The Coney Island Library will be closed from May 5th to May 18th. Tomorrow will be the opening of Seeds in the Middle, the farm stand that will be opened on Thursday afternoons from 2-5:30 in front of the Coney Island Library. It will be open for the next ten weeks. Students and a faculty member from Liberation High School and Ann Valdez will man it

At our next Board meeting, there will be three presentations – Public Hearing for 58 Nixon Court, NYCDOS presentation on Composting and OEM presentation on the upcoming hurricane season.

There has been no information from the BP's office on the appointment/reappointment of board members. The Summer Detail will begin on May 12th and will be here until sometime after Labor Day. We will have 85 officers.

Construction on Surf Avenue will be done by May 15th. Mermaid Avenue from W. 16th to West 17th will be done in two weeks. Neptune Avenue will be completed after Surf Avenue. April 28th to May 2nd the milling will be done in Brighton Beach, and Ocean Parkway from Brighton Court to Avenue Y. Selina wants to make sure that all avenues are done before the moratorium takes effect. Eddie will contact them tomorrow. Pat Singer wanted to know when Brighton Beach Avenue will be paved.

After extensive discussion about the moratorium which was put in place many years ago for events from Coney Island Avenue to Brighton Beach Avenue, including side streets and knowing that SAPO has a moratorium on all new multi-block events, Lucy suggested a motion be made to extend the old moratorium to include events on BBA from Brighton 7th St. to Ocean Parkway including the side streets to Brightwater Court and Oceanview Avenue. The new moratorium should extend to Neptune, Mermaid and Surf Avenue from West 37th Street to Stillwell Avenue.
