## PRESENTATION:

**GUESTS:** 

Rachel Amar, Senior Advisor to the Commissioner, NYC Office of Administrative Trials and Hearings (OATH). She explained that OATH is an enforcement agency, where people come to fight the summonses they have received. In this agency, which is impartial and independent, there are several divisions – the Trial Division and the Special Education Hearing Division. Fighting a summons is a two-step process. The most important step is to check the hearing date, and only to fight the summons if you think it was wrongly issued. You do not need a lawyer, the Help Center can assist you. You must contact them two weeks before your hearing date.

There are several ways of fighting a summons, one way is one-click submission. All ways of submitting information on summonses can be appealed, this includes one-click submission. If the person answering the summons is not satisfied with the initial appeal then an Article 78 can be instituted, which allows the information to be heard by a higher court.

An issue was brought up by Michael Russo. He had been given a summons, appealed it, won the appeal and then the agency (DOB) which gave him the summons, appealed the appeal. They were granted their appeal and Michael had to pay the fine. Ms Amar is going to follow up with Michael on the process.

#### Seeds In The Middle - Ann Valdez / Nancie Katz

Ann explained that Coney Island needs a place to purchase fresh/good fruits and vegetables. Nancie is the Executive Director of Seeds in the Middle explained the process and how hard it has been to find a location. The Coney Island Branch of BPL has been good enough to agree to allow this stand to be IFO the library.(really off to the side, IFO a vacant building). The stand will be manned by students from Liberation High School along with a school staff member. The stand will be open once a week, probably on Thursday from 2-5 p.m. As of now, the stand will end at the end of June unless it becomes self-sufficient. CM Brannan has given the "start-up" funds. The 60<sup>th</sup> Pct did have some reservations, but it was agreed that if there is a problem, that cannot be resolved, the stand will be closed immediately.

Dennis Vourderis asked who would regulate the stand. How do we know the food sold is ok to sell. Nancie will send information from Consumer Affairs. Selina Grant asked what would be done with items that are left when the stand closes for the day. (Will be taken to the refrigerated space the organization has). Milagros Quiles asked if they will have liability insurance (Yes). Pat Brown again stated that the community needs a fish store, bakery, book store. We need the "simple things".
