PRESENTATION: Parking Summonses Advocate Office Jean C. Wesh, Esq. Mr. Wesh explained what his office is about. The office helps constituents with parking ticket related issues. The office assists the public navigate the system by:

- Informing the public about the rules and regulations of the office.
- Reports and recommends how to fix certain problems.
- Each office is in a business center. The headquarters is in Manhattan. The office hours is listed on the website
- On line assistance will get a response within 48 hours.
- Walk ins accepted at any of the offices.
- Office can assist constituent in preparing the appeal.
- If constituent has representation by attorney or broker, this office cannot assist them.
- Give information on how to dispute summonses nyc.gov/parking advocate, Call 311
- Call business center.

Board member, Selina Grant, stated that there is a problem reading some of the parking signs. Some places the signs are conflicting. Could the Parking Advocate's Office contact the DOT about this? Mr. Wesh said that if they are given specific locations for the conflicting signs, they would reach out to DOT for assistance.

PRESENTATION: Brooklyn Bus Network Redesign Project

Mr. Gonzalez explained that they are here tonight to get community input on the existing conditions of bus transportation - Schedules, ridership problems, etc. This project will:

- Remap the bus network
- Engage and empower employees
- Take blank slate approach to remediate situation.
- No preconceived notions on change.

The MTA has distributed 17,000 pamphlets to inform the public about the redesign. They received 2300 responses.

- Bus priorities-select bus routes.
- Reduce number of bus stops that are close to each other.
- Reduce using narrow streets and making fewer turns (done on case by case basis).
- Improve bus connections.
- Decrease wait time.
- Decrease travel time.

MTA

- Will work with DOT.
- Develop Draft Plan with proposed route changes. The Draft Plan will be available within the next few months.
- Will ask community for their feedback.

Board member, Lucy Acevedo suggested that the Draft Plan be sent to the Community Board in PDF so it can be emailed to all board members.

Board member, Kumali Zairee reported that the B74 buses generally are very dirty. Also, the last stop instead of being under the subway station is on Mermaid Avenue the comer of Stillwell Ave. Across from McDonalds. All riders who need to go to the station must cross Stillwell Avenue, which has become hazardous due to streets that are rough and still under construction, cars that drive without knowing where to go, due to construction-all of which makes for a very dangerous crossing.

Board member, Zunera Ahmed requested that the time schedules which have been removed from bus stops be reinstalled. Many people don't know how to use the MTA app on their phone, if they have a phone.

Board member Lolita Divilova remarked that they need additional express buses. Also need more bus lines coming into Coney Island.

Chavez Gonzalez discussed the next phase of the Culver CBTC which begins on March 20th. The F train service will be suspended between Church Avenues. Shuttle bus will be available or take the Q train to Coney Island. This will go on until late October-weekends only.

PUBLIC SPEAKING:

James Neimeister — NYC Census 2020- Doing outreach hopefully we will get a full and accurate count of all people. In the past, Coney Island and Brighton Beach had the lowest self response rate in the 2010 census. This time around the Census will be safe, easy and can be filed out on line, on the phone or in person. As a result of the Census, \$650 billion in federal funds usually go to the states. There will be a community outreach event from 3/8 to 3/11/2020. Discussion about the fact that is a good idea for workers to come from the area that they live in.

<u>Ida Sanoff</u> – <u>community resident</u> – She stated that East Northport schools have been closed due to elevated degree of mercury and benezene. She feels that dredging for the ferry pier will be unsafe and mix up toxic materials into the air.

<u>Jahi Rose</u>, <u>Deputy Director Outreach CCRB-</u> He announced a Police and Young People's Art Contest. See flyer for rules. He also said that people can make a complaint about police officers by calling CCRB at 917-208-9320

Craig Hammerman-community resident. See his comments attached.

Joshua Trost-community resident – He suggested that when residents throw away items that they no longer need, they should put a sign "Free" on it, so people would know it was okay to take it.

Elizabeth Torres-UNS – She explained that UNS is a multiservice community based organization that has partnered with NYC Cares to give residents who have low or no income health care. Most Primary Care physicians are part of the network, covers most specialists and most medications. They are working to get dental coverage in the future.

Alex Gurevich- Office of Brooklyn District Attorney Eric Gonzalez — Using Precision Policing from 2017 to 2019, there has been a decline in homicides in PBBS from 54-34, a 40% decrease. In PBBN there has been an increase in shootings. There was a major gang take down, which resulted in a 122 count indictment. Thirty-four individuals from two rival gangs have been arrested.

Inna Guzenfeld-Brooklyn Borough President's Office — On behalf of the Borough President she thanked NYCares for mentioning the Borough President in their statement on nutrition and healthy foods. The BP is working with Downstate and Montefiore Hospitals on a plant based diet plan.

Sam Chuprik-Congressman Hakeem Jeffries – State of the District Address was a big event. The Congressman is now working on a proposal to get faster generic drug availability.
