### **STAFF MEMBERS PRESENT:**

Eddie Mark, District Manager, Hanna Glikman, Community Associate, Barbara Santonas, Secretary

<u>PRESENTATION</u>: Test & Trace – Monique Chandler Watters, Brooklyn Outreach Director She discussed the various places that Test & Trace can be set up. It can be set up in the office of a CBO, where staff can be trained to assist with the testing, or people from Test & Trace can come to a event and set up for testing. Test should be taken at least once a month, even if no symptoms, no charge. Call Ms Watters for further information.

Pat Brown questioned whether in a City Housing Complex, there is a rule that residents cannot have outside company until they present with a negative test result (Ms Watters to discuss offline).

Barbara Teitelbaum asked how many Rapid Tests can be taken (this is insurance questions-Ms Watters will get back to her with answer). Also, she wants to know is there accommodations for dog walking, if someone is COVID positive. (Mariyah Markh said there is PAWS that has been contracted by the City to walk dogs in this eventuality. When Test & Trace calls they should be advised that this is needed).

Ida Sanoff said there was a party in an apartment in her building, with many people. She asked what can be done in reference to enforcement. (Mariyah will get back to her). Barbara Teitelbaum is very concerned about enforcement on all fronts.

#### **ELECTED OFFICIALS/REPRESENTATIVES:**

<u>Councilman Mark Treyger</u> wanted to make sure that when Test & Trace makes call they speak in the language of the person contacted (Ms Watters said there are people who speak many languages in Test & Trace). The CM has worked very hard to get testing site at Ida G Israel Medical Center and a Rapid Testing site at Coney Island Cathedral. Regular testing takes 1-2 days for results and rapid testing takes about 15 minutes for results.

The CM visited Carey Gardens where is saw an unsafe entry way. He alerted NYCHA and they have responded by installing overhead covering and additional lighting. He has also received heat complaints and contact NYCHA. He thanked everyone including the Alliance for assisting with food distribution in the community. Shirley Aikens asked if the dinner being served on Wednesday at the Amphitheater is a sit down or grab and go (Grab & Go).

The CM discussed the situation with school reopening and getting more learning devices to students who do not have them. He also discussed that Food & Nutrition will continue to distribute meals, hot and cold as grab & go.

<u>Mariyah Mark, CAU</u> discussed the fact that Blood donations are really needed, as there is not a large amount of blood on hand.

Assemblymember Frontus thanked Lucy for good wishes on her re-election. She wished everyone a Happy Thanksgiving and hopes they will stay safe. Her office is open and she is in touch with City and State daily. She hopes we are not on the brink of a second wave. This week, because of the holiday, her staff is working remotely. She extended her condolences to the families of Alfie Davis, Ali King and Charlotte Taylor on their passing. Pat Singer added that Boris Talis, well known in the Brighton Beach community had passed yesterday. Mathylde extended her condolences to his family as well.

Inna Guzenfeld, representing Borough President Eric L. Adams wished everyone a Happy & Safe Thanksgiving. She said the BP is working to make sure that all city shelters have Wi-Fi access for the children to do remote learning.

<u>Sergei Chrupik</u>-representing Comptroller Scott Stringer wished every Happy Thanksgiving and suggested they look at the website for updates.

#### **PUBLIC SESSION:**

<u>Ida Sanoff</u> – requested C.B. write letter to ACE to extend the comment period for the Deepening New York Harbor Project. The comment period ends on Dec. 19<sup>th</sup> and we should request an 120 day extension to give the public time to comment.

<u>Craig Hammerman</u> – He thanked Lucy, Queenie and Shirley for doing due diligence. He believes that whatever comes to the facility will be better then what's there now. He hopes that the Board will support the committee's decision. He also thanked the Community Board staff, board members and elected officials. Discussed about Local law to amend law of City of New York Masters BH-CUNY-1283-2018. This law has to do with the teaching of nutrition as part of the Physical Education curriculum. Most schools do not teach it, 42% of the schools in Brooklyn do not have this program. The DOE has no information available as to which schools have it. The DOE should be held accountable. Christopher Greif – discussed the mandate to wear face coverings on City buses and trains and that people who do not wear these coverings will be given ticket.
