PUBLIC MEETING HELD VIA WEBEX

Chairperson Genese Morgan called the meeting to order at 7: 05 p.m. and an invocation was given by Mr. John McCadney, Jr.

Chairperson Morgan noted that representatives for the public hearing were not present.

The floor was opened for public comments and announcements.

Ms. Deborah Williams asked if the fire hydrant that Mr. McCadney reported was repaired?

Mr. Jimmi Brevil stated that it was reported to the Department of Environmental Protection which responded that they are awaiting parts to repair the hydrant.

Ms. Melanie Mendonça read the Community Resident Planning Work Group report. A copy of the report is on file in the Community Board office. A quorum was not present to vote.

Ms. Deborah Williams read the City Services Planning Work Group report. A copy of the report is on file in the Community Board office. A quorum was not present to vote.

Captain Hamilton of the 73<sup>rd</sup> Precinct stated that she was recently assigned as the Executive Officer. During the 28-day period, traffic injuries to pedestrians were up 50%. Pedestrians are hit by vehicles not yielding the right-of-way and fleeing the scene of the accident. The top three locations for pedestrian injuries are: Rockaway Avenue at Chauncey Street, Broadway at Conway Street, and Hegeman Avenue at Amboy Street.

Ms. Kelly Lee-McVay requested that Captain Hamilton provide crime statistics in the 73<sup>rd</sup> Precinct.

Captain Hamilton stated that during the 28-day period from November 29<sup>th</sup> to December 26<sup>th</sup>, we are up in robberies, shootings, domestic violence, and grand larceny auto.

Mr. McCadney asked what is being done to abate the crimes?

Captain Hamilton stated that the public safety teams are out day and night patrolling the community. Community Affairs Officers are also engaging businesses in the community.

Ms. Luz Ortiz asked if burglaries are occurring in apartments, houses, or businesses?

Captain Hamilton stated that they are mostly commercial burglaries. There are cases with UPS packages being delivered to a building lobby and being removed by someone other than the addressee.

Ms. Mendonça called the roll of Board members. A quorum was not present.

Chairperson Morgan read the public hearing item regarding 211 Tapscott Street. The matter was tabled because no one was in attendance to present.

Ms. Adrainer Coleman read the Equity Planning Work Group report. A copy of the report is on file in the Community Board office. A quorum was not present to vote.

Mr. Jimmi Brevil read the District Manager's Report. A copy of the report is on file in the Community Board office. A quorum was not present to vote.
