REGULAR MEETING

A quorum was present to begin the meeting.

7:10 P.M.

Chairperson Naomi Hopkins asked if there were any additions or corrections to the minutes of the meeting held on May 21, 2025. There being none, a motion to accept the minutes passed unanimously.

7:14 P.M.

PUBLIC HEARING

Chair Naomi Hopkins introduced Attorney Adam Rothkrug representing the owners of 5502 Flat LLC, the triangular property at 5502 Flatlands Avenue which is in an R3-2 zoning district that has been vacant for several years. They previously filed a zoning application to add a C2-4 commercial overlay to the property to permit development of a one-story retail building. After consultation with the Department of City Planning the rezoning request was modified to propose a rezoning to R6A/C2-4 and to add the mapping of a Mandatory Inclusionary Housing (MIH). Under the current R3-2 zoning district regulation is not economically viable, and we believe that the modest commercial development along Flatlands Avenue would be appropriate. The irregular configuration of the site does not lend itself to residential use, and as noted, was not the original intent of the owners - which is the development of a one-story commercial building. Board Member Grace Zwillenberg moved the motion to approve only a C2-4 commercial overlay to the property at 5502 Flatlands Avenue. Board Member Maria Garrett seconded the motion. The motion passed with35 yes and 1 abstention votes.

GUEST PRESENTATION

Chair Hopkins introduced John Pelaez, Project Manager of Stantec for the NYC DDC reconstruction of Avenue J. The reconstruction project will address damaged curbs, cracked sidewalks, overgrown tree roots, and uneven surfaces. The back pitched sidewalks and garages which are below grade and have insufficient drainage will be upgraded to prevent flooding events. The project goals are to reduce flooding, by elevating sidewalks, installing new catch basins and upgrading sewer lines. In addition, pedestrian safety will be targeted with new traffic signals, narrow roadways and raised crosswalks. Existing healthy historical trees will be preserved by expanding tree pits and removing unhealthy trees. The anticipated construction timeline is Summer of 2028-2030.

- The back of Canarsie Park will be cleared for a pumptrack, a track for wheeled sports equipment that, when ridden properly, does not require pedaling or pushing, but a "pumping" action to maintain momentum pedal bikes, BMX, etc.
- Continued dumping at Flatbush Ave. and Hendrickson Pl. prompted a meeting with Sanitation, Marine Park Golf Course, Parks, the Marine Park Alliance and myself.
 Improved lighting and a new working with the existing business Raymour & Flannigan and the business coming in.
- The School Construction Authority performed an inspection and testing of existing caulking material during a recent school recent school renovation project. Soil testing indicated PCB's ranging from slightly below to slightly above regulatory levels. As a precautionary measure, SCA has planned a soil remediation project at JHS 68 for June 30th.
- Trees are a major issue in the area. Heavy rains are causing limbs to fall and mold on the bark. Parks has been inspecting the trees as we send them the requests. Pruning begins in CB18 on July 1st for the new Fiscal Year. Hopefully, forestry will be able to tackle these issues.
