## **PUBLIC HEARING**

Chair Naomi Hopkins introduced a representative from the NYC Department of Cultural Affairs

Percent for Art Program. They have been commissioned to select a design for the second-floor terrace of the Canarsie Library once the renovation is completed. They are seeking input from the community, local elected officials, and art professionals to participate. Information about submitting artwork is available on social media and the Artists Directory. Eligibility for artists is 18 years or older and they must be registered NYC vendors. The chosen artwork will be unveiled in 2027, and the selected design artist will receive an honorary stipend. Board Member Barbara Bieber made a motion to approve the art project. Board Member Julius Stukes, Jr. seconded the motion. The motion passed with 42 yes and 1 abstention vote

#### TREASURER REPORT - DAVID PRICE

Our FY 2026 budget was approved at \$40,292. The office staff has requested \$20,000 to cover internal operation needs for the year. Treasurer Price said we will vote on approving the \$20,000 allocation for office supplies, contracts etc. If approved this would leave \$20,292 available for committee use.

To ensure a fair and transparent allocation process for the remaining funds, the Budget Committee has created a standardized Funding Request Form outlining proposed projects, purposes, community impact, estimated costs, and overall feasibility.

- Each committee will meet over the next month to discuss their anticipated needs for the year.
- Committee chairs will present their funding requests during their subcommittee updates if possible.
- All formal funding requests must be submitted to the Budget Committee by November 1st, so they can review them and make recommendations at the November board meeting for a full vote.

Treasurer/Budget Chair David Price moved that the Board approve an allocation of \$20,000 from the FY2026 budget to be designated for internal office operational needs. Board Member Greg Borruso seconded the motion. The motion passed with 40 yes and 1 abstention vote.

The NYC Council has an upcoming public hearing regarding **battery energy storage**. I will provide testimony on behalf of the Board and plan to submit a **sign-on letter** reflecting our shared priorities. **ASSEMBLYMEMBER JAIME WILLIAMS** – Reminded everyone about the 9/11 memorial service that evening at Marine Park.

<u>DDC- B82</u> – Remsen & Flatlands Aves. watermains are 95% complete. Reinstating bus stops along Kings Highway up to MTA & DOT. Workers will return to complete street & sidewalk restoration at Mt. Sinai Hospital and the medians along Kings Highway.

**FDNY** – September is National Preparedness Month. People are encouraged to "Make a Plan," & "Build a Kit," to become more resilient and self-sufficient when emergencies strike. FDNY also has a mobile CPR

unit for community events and will be implementing a public course called How to Stop the Bleed. **NYC OFFICE FOR THE AGING** – Needs Assessment survey for older adults received over 9.000

responses. Major issues identified include caregiving and bill payment challenges.

**DOT** – Marine Park lights are out around the oval. Disability Permits are backed up 10 months.

<u>Jamaica Bay/Greenway Project</u> – Water main work continues at Flatlands Ave. & East 76<sup>th</sup> St. Residents & businesses emailed to notify about water shutdowns and restricted parking.

The Board notified the local elected officials, civic associations, and the 69<sup>th</sup> Precinct. Chair Carryl made the motion to table. Board Member Maria Garrett seconded. The motion to table Halsey Bar & Grill passed with 29 yes, 5 abstentions, 1 no vote.

## **OPEN DISCUSSION**

Assemblymember Monique Chandler-Waterman updated the Board on resources addressing gun

violence, wellness and trauma services for victims.

**Sabrina Dieujuste, representing Councilmember Farah Louis,** provided updates on DSNY and NYPD Town Hall meetings, Amersfort Park dumping, Kings Highway weeding, Avenue H & E. 45<sup>th</sup> St. bus stop restoration, and the East 80<sup>th</sup> St. repaving delay. She also discussed efforts to restrict cannabis stores from opening near parks and youth facilities and noted new funding for cameras to deter dumping.

**Sgt. Edmond, from Q-Teams,** addressed quality of life issues throughout the 69<sup>th</sup> Pct.

**Sharon Long, representing Assemblymember Jaime Williams**, discussed community farms and the Assembly Member's reintroduction of the bill restricting Ion-Battery Storage facilities to industrial areas.

**Jennifer Horsford, representing Senator Roxanne Persaud,** spoke about partnerships with the Canarsie Merchants Association and the Brooklyn Chamber of Commerce to promote small businesses.

**Alleyna Matthews, representing Councilmember Mercedes Narcisse**, shared updates on allocations: \$3.3 million for the creation of a Community Urban Farm at Floyd Bennett Field, \$3.5 million for renovating South Shore High School athletic fields, and \$500,000 for upgrading electrical infrastructure at P.S. 207.

The Canarsie/Kings Plaza Kiwanis Club invited all to join them. October is Youth Empowerment Month.

H.E.S. Parent Support Group offers bereavement and disability support and suicide awareness programs. The Montrose Family thanked the Board for approving the co-street naming for their son Enough-Anti-Gun Violence Organization continues interventions for at-risk youth.

School District 18 hosted a Back-to-School Giveaway and announced afterschool program at P.S. 276.

Man Up-Anti Gun Violence Organization continues intervention efforts for at risk youth.

Canarsie Merchants Association encouraged local shopping, held a clean-up event removing over 36,000 lbs. of garbage, planted along Rockaway Parkway, and completed a new mural in the municipal parking lot.

Brooklyn College Student Volunteers helped beautify 82 gardens along the B82 corridor.
