The meeting was called to order by Chair Anthony Buissereth. He read the agenda into the record.

## **First Roll Call:**

There were 23 members present and 27 absent.

An informational presentation was made by Andrew Inglesby, MTA on the G Train Modernization Upgrade Project. Beginning July 5<sup>th</sup> to August 12<sup>th</sup> there will be no G train service between Court Square and Bedford-Nostrand Avenue Stations. Free B98 shuttle buses will run between Court Square and Bedford-Nostrand making all G-Train stops.

He stated that this upgrade is necessary since the Crossline used by the G Train is the original system from over 90 years since its inception. The new system will bring Communication-Based Train Control (CBTC) Technology that will make the system more modern and reliable for 160,000 riders.

A public hearing was given by Jonah Rogoff, DCP and Eric Acosta, HPD on the <u>City of Yes for Housing Opportunity</u>. City of Yes will change the zoning rules.

Questions were asked and answered about the AMI, and other locations with affordable housing units

#### 2<sup>nd</sup> Roll Call:

There were 30 members present and 20 absent. There was a quorum.

#### Chair's Report

The Board will be on recess for the summer however, the office will be open. The next board meeting will be held on Monday, September 9<sup>th</sup> at 7:00 p.m.

# **District Manager Report**

- Attended a meeting about term limits for board members.
- The Department for the Aging (DFTA) would like everyone to complete a survey to help gauge the needs of the elderly. The deadline to complete is September.
- The office will be getting two SYEP interns for the summer.

## **Action on the Public Hearing:**

Monique Antoine made a motion to suspend the meeting so that the members of the committee could caucus. After caucusing, Evelyn Collier stated that the vote was unanimous. The committee voted NO on the City of Yes and recommends that the Board vote NO for the following reason:

The proposal for increased density without planning for infrastructure does not benefit the community.
