The meeting was called to order by Chair Anthony Buissereth. He read the agenda into the record. Chair Buissereth introduced the new District Manager, Nadeen Gayle and the eight new board members: Joseph Sortland, Gerald Huggins, Cheryl Wright, Timberly Wilson, Frank Bradshaw, Monique Powell, Asher Tapuchi and Ty'East Alleyne-Bobb. He also thanked the members who have resigned from the Board for their service: Oma Holloway and Karen Rhau.

Dr. Sandra Scott, the new CEO of One Brooklyn Health, and Charlie Beauvais, Executive Director introduced themselves to the public and gave a brief update on what is happening at the hospital. The ER is being renovated and there will be a new behavioral unit at Interfaith & Brookdale Hospitals.

Nicole Bryan announced that the Macon Branch Library will be closing for 4-6 weeks to remediate a mold condition. The last day for public service will be May 21st. Patron can utilize the Saratoga Branch during the closure.

Danna Dennis, Senior Organizer with Riders Alliance gave a presentation on the MTA's Fair Rare Program.

Presentation:

Bryce Peterson, an artist who created the artwork gave a brief synopsis of the <u>Hanging Gardens</u> installation. He stated that the artwork is a pavilion with a built-in hanging garden, the speaker and lighting system is solar powered for events. Herbert Von King is the second installation; the first installation was located at Highland Park. The artwork will officially open on June 8th to the public and will run until November.

The committee also voted on two liquor license applications: Rep Music Café and Understudy Hospitality. The Committee voted to give a letter of support to Rep Music Café. However, they voted to give a letter of non-support to Understudy Hospitality. **Rep Music Café** will be a coffee house. **Understudy Hospitality** will be a bakery during the day.

Vote for Rep Music Cafe: 31 – In Favor; 4 – Objections; 4 – Abstentions

Vote for Understudy Hospitality: 30 – In Favor; 5 – Objections; 5 – Abstentions

Michael Catlyn, Chair of the CAURD Committee gave a report on Happy Buds Brooklyn application. They are currently open and operating at 225 Malcolm X Blvd. They currently sell CBD products. He stated that the committee recommendation is to give a letter of NO OBJECTION. The motion was seconded by Aboubacar Okeke-Diagne.

VOTE: 26 – In Favor; 10 – Objections; 3 - Abstention

A motion to accept the minutes was made by Douglas Williams and seconded by Alex Abarbanel-Grossman.

The next Board meeting will be held on June 3rd.

A motion to adjourn the meeting was made by Edna Johnson and seconded by Timberly Wilson. The meeting was adjourned at 10:02 p.m.
