The meeting was convened at 7:10 p.m. by Chair Anthony Buissereth. He read the agenda into the record.

There were 20 members present at the beginning of the meeting and 29 were absent.

The Parks, Arts & Culture Committee presented a public hearing to co-name Hancock Street between Throop Avenue & Marcus Garvey Blvd to P. O. Tyreon W. Cook Way. His daughter, Sheila Williams gave a heartfelt presentation about his life as a police officer, a dad and a resident of Hancock Street. A few of his colleagues also spoke about his character.

TJ Wilson and Aboubacar Okeke-Diagne, Budget Co-Chairs held a public hearing on FY2026 Preliminary Budget Responses. He discussed the top five requests and responses for Capital and the top five Expense:

**CHAIR REPORT:**

Chair Buissereth made a motion to remove the following members for non-attendance: Aline Estefam, Carroll “Rusty” Fields and Jerome Nathaniel. The motion was seconded.

**Action on Public Hearing:**

**1. Co naming of Hancock Street**

TJ Wilson stated that the committee voted to support the co-naming of Hancock Street to P. O. Tyrean Cook Way. A motion was made, and it was unanimously passed.

**Vote: 28 – In Favor; 0 – Objection; 0 – Abstention**

**2. The Landmarks Committee presented two applications:**

**a) 3 Hart Street**

Evelyn Collier stated that the committee voted to NOT SUPPORT the application with the stipulation that there be no further construction on the project that is out of compliance with LPC-approved plans and specifications.

**b) 348 MacDonough Street**

Evelyn Collier stated that the committee voted to SUPPORT the application with the stipulation that there be no further construction on the project that is out of compliance with LPC-approved plans and specifications.

A motion to accept the committee’s recommendation was made and seconded. Both applications unanimously passed.

A motion was made to accept the February minutes was made by Edna Johnson and seconded by Dr. Adesola Tella.

A motion to adjourn the meeting was made by Miari Roberts and seconded by Yvonne Cummings. The meeting adjourned at 9:09 p.m.
