Alcohol Beverage Control License Application for Brooklyn Burger Inc (DBA Brooklyn Burger Bar Bed Stuy) located at 1227 Fulton Street between Bedford & Arlington Place.

Applicant was a NO SHOW.

# B. Economic Development Committee:

Alcohol Beverage Control License Application for Upper Level Bar & Grill Inc (DBA Treehouse) located at 417 Marcus Garvey Blvd between Halsey & Macon Streets.

Robert Romano Esq, Legal Representative stated that there are 22 seats in the restaurant with a backyard patio however, the patio will not be used. The restaurant name is the same however, the owners are Mr. Thompson and Mr. Wilson are new. This will be a pub like atmosphere. There are four televisions, there will be background music. The hours of operation will be seven days a week until 2:00 a.m. There will be Sunday brunch.

## **Question and Answers**

**Christine Parker:** How many people will be hire from the community? **Mr. Thompson**: 100% of the employees well we hire from the community about 5 to 11 people.

# C. Economic Development Committee:

Alcohol Beverage Control License Application for Spudz LLC located at 1460 Fulton Street between Kingston & Tompkins Avenues

The owner, Forest Greene stated that he will be serving Gourmet French Fries as the main dish. The hours of operation will be 12:00 pm to 10:00 p.m. seven days a week. They are currently open for takeout with eight staff members. There are 15 seats with two bar stools. He provided a scholarship of \$1000.00 to a student going to Howard University. He will continue to give back to the community with more scholarships.

# D. Economic Development Committee:

Alcohol Beverage Control License Application for Vibe LLC located at 1281 Bedford Avenue between Atlantic Avenue & Herkimer Street.

The owner, Xavier Ezell stated that this is a three-story building, there will be a stage area for artist to perform live music on the second floor. The menu will be catfish, calamari, mac & cheese and wings. The hours of operation will be Monday, Tuesday and Wednesday 12:00 p.m. - 12:00 a.m.; Thursday, Friday and Saturday: 12:00 p.m. - 4:00 a.m.; and Sunday: 12:00 p.m. 2:00 a.m.

The first floor is the bar with 22 seats a team is seating. Presently, they are open for takeout only. There is elevated seating outdoors seating for 20 people. The third floor is storage and an office space, a total of 4,200 square feet Mr. Ezell is also the Co-owner of Bedford Manor.

The owner must submit a statement letter detailing that all issues with the Department of Buildings are cleared. the stipulation will state that a letter of recommendation is given on non-use of the backyard outside area.
