He reported that there will be COVID-19 Testing and Vaccine at 485 Throop Avenue on January 3-7, 2022, from 8:30 a.m. – 6:00 p.m.

I. INFORMATIONAL PRESENTATION

A. Health & Social Services Committee

Ms. LaRay Brown, Chief Executive Officer, One Brooklyn Health Center and President & CEO, Interfaith Medical Center gave an update on the progress of work at the hospital.

Ms. Brown informed that there are several Capital funding projects that is being done at the hospital. Currently they are in the design phase of the for a new Emergency Room. There are five phases of this project which is scheduled to be completed in 2024. There will be an upgrade to the ambulatory services which is scheduled to be completed in May 2022. The three Psychology units is being upgraded while the hospital is being operating.

Ms. Brown announced that a testing site will be setup at Harmony Park between Troy and Atlantic Avenues, Monday to Friday from 9:00 a.m. -6:00 p.m. She added that over the last year Interfaith has distributed over 40,000 vaccines.

Questions were asked and answered.

II. PUBLIC HEARING

A. Health & Social Service Committee

Edna Johnson introduced Dr. Julian Watkins who gave an update on the Impacts of COVID-19 Omicron Variant, Testing, Vaccination & Boosters

Dr. Watkins stated that the Omicron variant is spreading rapidly because it is spread through respiratory droplets. 80% of people have gotten their first shot. There are 20,000 positive test per months and a rise in hospitalization. There is a national shortage on test kits so there are no plans to

distribute the kits presently. He added that cloth mask is not effective. He suggested that it is best to use N95, KN95, and surgical masks or double up masks.

There were questions and answers.

Ms. Johnson informed that Woodhull Hospital has closed several departments because of COVID.
