### I. INFORMATIONAL PRESENTATION

### **Housing & Land Use Committee**

Michael Sadler, Asst. Commissioner for Neighborhood Development & Stabilization from the NYC Dept. of Housing Preservation & Development (HPD)) gave an update on the Bedford-Stuyvesant Housing Plan.

The plan was released in 2020. 20 non-profit organizations participated in the workshops along with 9 City and State agencies and over 200 community residents. 360 surveys helped create the goals to support tenants and homeowners who are struggling and under pressure to sell their homes.

The goal is to reduce illegal housing activities in the neighborhood, to promote safe and healthy housing, to enhance resource delivery to homeowners and tenants and to create new affordable rental and homeownership opportunities. The homeowner help desk was launched to help homeowners with free housing, counseling, financial assistance, and legal services. It was funded by a \$800,000 grant.

The plan is also advocating for Cease and Desist Zone, renovate 700 NYCHA apartments, plan more tenant Clinics with Bedford-Stuyvesant Restoration Corp, Bridge Street Development Corp, HPD, DOB, Brooklyn Legal Services and CAMBA. However, a major part of the plan was to develop affordable housing on City owned land.

A RFP was issued last year for two City owned sites:

Fulton-Howard East was designated in December and the Fulton & Saratoga site will be designed in the spring. The Fulton Howard East/The Norma will be developed by Almat and Bedford-Stuyvesant Restoration Corp. It will be 44 apartment, 11 stories homeownership opportunity with a sale price between 80 - 116 median incomes, \$86,000 - \$125,000 for a family of three. This will be a sustainable building.

The Fulton-Saratoga site will have 200 - 220 affordable apartments with a requirement for 80-100 apartments be affordable for seniors and the ground floor for Fresh market. Future RFPs will be issued for Myrtle-Marcy site, Fulton-Utica site and the Fulton-Howard site which is adjacent to the Bed-Stuy Multi-Service Center and run by CAMBA. There is talks to potentially redeveloped both sites together creating a new Multi-Service Center and more affordable housing
