Chair Anthony Buissereth welcomed everyone. He read the agenda into the record and gave brief remarks: He encouraged everyone to go out and vote. He also acknowledged all the veterans in the community and wished everyone an early Happy Thanksgiving

Updates:

- Community Board applications period will open on November 15th through February 14th.
- Constituent Services are offered every Wednesdays at Borough Hall and every Thursdays at Grand Army Plaza Library from 9:00 a.m. 3:00 p.m.
- Updates were given by Councilmembers Osse and Restler and Hudson. In addition, representatives from the 55th and 57 Assembly Districts and District Leader Butler
- The Buildings Department will be moving from 210 Joralemon Street to 345 Adams Street on November 21, 2022.

The Civic & Public Safety Committee Chair Monique Antoine introduced Sandra Sanchez, FDNY Assistant Director of Community Affairs who gave an Informational presentation on fire safety. She discussed the Dos and Don'ts in case of a fire such as closing the door behind you when escaping a fire, how to securely store of lithium batteries and utilizing UL rated products.

FDNY has partnered with the Red Cross for the Get Alarm Program. Resident may call 877-REDCROS (733-2767) for free smoke alarms and carbon monoxide alarms.

The Health & Social Services Committee presented two Public Hearings:

A. Exponents, Inc. is seeking a letter of support to the NYS Department of Health Overdose Prevention Initiative to operate a mobile van within Bedford-Stuyvesant. Present for the presentation was President & CEO Joe Turner, Executive Vice President, Samantha Lopez, and Director of Programs & Development, Donald Powell.

Exponents, Inc. provides the following services: recovery, education, and training for people with substance abuse by meeting them where they are. The funding they received will allow them to offer services via a mobile van. They are proposing to offer Narcan overdose reversal kit training and distribution, Fentanyl drug testing strips and distribution, access to clean syringes, and HIV testing. The proposed location would be near Throop Avenue and Fulton Street.

B. Phoenix House of NY/LI is also seeking a letter of support for to the NYS Office of Addiction Services & Supports to operate a Supportive Crisis Stabilization Center within Bedford-Stuyvesant. The presentation was done by Ann-Marie Foster, MPA, FACHE, President & CEO

Phoenix House has nine (9) facilities within Brooklyn, Queens & Long Island. The local center is located at 20 New York Avenue. They are a community recovery center that provide peer driven drug and alcohol support. The proposed Supportive Crisis Stabilization Center will provide 24/7 access to crisis intervention, a center that is designed for families with mental health and help remove barriers.
