I. INFORMATIONAL PRESENTATION

A. Housing & Land Use Committee:

Addison Vawters and Michael Sandler, Director of Neighborhood Planning from HPD made a presentation about the Bed-Stuy Housing Initiative

Bed-Stuy Housing Initiative goal is to address the housing challenges in the neighborhood by providing more affordable housing using City-owned property. There is also limited home ownership opportunities. HPD has over 850 new construction sites and affordable homes in the pipeline scheduled in the next 2-3 years. 130 developments will be homeownership opportunities. HPD has preserved 2,300 affordable homes in Bed-Stuy since 2014 to present. HPD has also completed 86 surveys of zombie (vacant/abandoned) homes and is holding the owners accountable.

There are five sites in Bedford-Stuyvesant: 1) Myrtle & Marcy Avenues (170 affordable units); 2) Utica Avenue & Fulton Street (150 affordable units; 3) Fulton Street & Howard Avenue (65 affordable units); 4) across the street at Fulton and Howard (50 affordable units); 5)Saratoga Avenue & Fulton Street (240 affordable units).

There was a workshop in June and there will be another one scheduled for Wednesday, January 15^{th} , at 6:30 - 8:30 p.m., at 1368 Fulton Street. Flyers were available. All the information obtained will be used to confirm the community vision for the sites and create a RFP. The RFPs will be issued next year.

Questions were asked and answered.

1) PUBLIC HEARING

A. Housing & Land Use Committee:

In the matter of an application submitted by the Department of Housing Preservation and Development (HPD) -

- 1) Pursuant to Article 16 of the General Municipal Law of New York State for
 - a. The designation of property located at 421-423 Herkimer Street (Block 1864, Lots 48, 49), 440-444 Herkimer Street (Block1871, Lots 42 and 43), 35-37 Rochester Avenue (Block 1709, Lots 9 and 10), 18-22 Suydam Place (Block 1709, Lots27,28 and 29)816 Herkimer Street (block 1710, Lot 9), 329-331 Ralph Avenue 9Block 1556, Lots 7 and 8) and 335 Ralph Avenue (Block 1556, Lot 3) as an Urban Development Action Area; and
 - b. Urban Development Action Area Project for such area; and
- 2) Pursuant to Section 197-c of the New York City Charter for the disposition of such properties to a developer to be selected by HPD; to facilitate the construction of seven new buildings containing approximately 78 affordable housing units, Borough of Brooklyn, Community District 3. *C. Doris Pinn, Committee Chair introduced Felipe Cortes, HPD Planner*

Felipe Cortes stated that the Rochester/Suydam Project was certified on October 18, 2015. This project will be 100% affordable homeownership. There are 13 vacant city-owned lots with 78 affordable homeownership units for household

earning incomes between 80-110% AMI. There will be 34 one-bedroom units and 44 two-bedroom units. Each unit will have a dishwasher, washer and dryer. Some buildings will also have an elevator, a bike storage and a shared backyard. The project will be financed through the HPD Open Door Program.

Douglas Williams asked about the parking requirements?

HPD stated that there will not be any parking. The buildings are in close proximity to the bus and subway. They are required to provide outdoor space

Dr. Debra Lamb asked for clarification of the AMI. **Olga Jobe** explained that 17 units will be at 80% AMI and 24 at 110% AMI

Lisa Lewis: How long does an owner have to stay in the home?

Olga Jobe: They are still working out the terms, it might be 20-40 years. There is an affordability restriction.

Alcohol Beverage Control License Application for BK Lobster located at 535 Nostrand Avenue between Herkimer Street and Atlantic Avenue

Presentation was made by the owner Rodney Barnes. He explained that he has been operating without alcohol however, his customers have been requesting alcohol. The hours of operation are 11:00 a.m. - 11:00 p.m., and 9:00 p.m. on Sunday. The capacity 75-100 people.

Section VI: General Election Process

- A. Nominating Committee:
 - During Brooklyn CB3's regular monthly business meeting in October, the first order of business shall be the formation of a Nominating Committee consisting of seven (7) Brooklyn CB3 members.

A. Term of Office:

 The tenure of all elected officers of Brooklyn CB3 shall be no more than *four* consecutive one-year terms, except by a majority vote of the seated quorum of Brooklyn CB3 members.

Proposed Amendment:

- 1. During Brooklyn CB3's regular monthly business meeting in October *of an election year*, the first order of business shall be the formation of a Nominating Committee consisting of seven (7) Brooklyn CB3 members.
- 2. The tenure of all elected officers of Brooklyn CB3 shall be no more than *two* consecutive *two-year terms*, except by a majority vote of the seated quorum of Brooklyn CB3 members.
