DISTRICT MANAGER'S REPORT – Henry L. Butler

Mr. Butler informed the audience that the Town Hall with the Mayor will be held on Thursday, March 9th, at P.S. 23, 545 Willoughby Avenue between Marcy and Tompkins Avenues. Those who have already RSVP do not have to do it again. The RSVP is now close.

I. PUBLIC HEARING

A. Landmarks Committee:

The committee hosted a public hearing on a LPC application for 524-540 Halsey Street. The request is to alter a three-story Queen Ann Style garage, designed by Axel S. Hedman and built in 1904 with a one story Utilitarian Style garage building built at an unknown date. Application is to demolish the one-story garage building and construct a new building, alter the rear and front facades of the three story garage building, alter the front areaway, replacement of sidewalks, excavation at the rear areaway, and construct a rooftop addition.

Evelyn Collier, Committee Chairperson stated that this location used to be the Brown & Brown Car Service. She introduced Rick Azar, Legal Rep. along with the Architects, Ronald Ron, James Driscoll, and Community Liaison Director Tamara Silver, ROART Architects

A PowerPoint presentation was done to show the proposed plan for the site. Mr. Azar stated that 524 Halsey Street is actually two buildings: the larger of which is an early 1900 combination of two 1890s stables. The building was converted as a car garage. It is a three-story building. The other building is a one-story building which was also used as a garage. The proposed plan for the three story building is to convert the garage into condos and apartments. In the rear the building will be cut back to allow light and open space.

Questions & Answers

Dr. Debra Lamb: What is the affordability of the apartments?

Ronald Ron: There will be 40 units, 5 units in the front will be condos. He does not know the price of the units.

Gregory Glasgow: Will the developer be receiving public funding? **Rick Azar:** No, there will be no public funding

Gregory Glasgow: If there is no public funding, the developer can charge whatever price he wants.

Rick Azar: Yes

Terry Johnson: The block association is concern about the smaller structure not blending in with the block? What have you done to address that concern?

Rick Azar: These are modern buildings. They are bridge buildings which will connect the car garage and the rest of Halsey Street. We took certain elements such as the bay windows, the height in order to conform to the block.

Rebecca Wolfe: We do not care if this is modern. It does not reflect the aesthetics of the block. This is a R6B district and as such you are required to provide parking for up to 50% of the units. What will you do about the parking?

Ronald Ron: As of Right, this is a conversion of an existing building if the number of units is less than the density allowed by code, then we do not have to provide parking however, we are changing the sidewalk. It will no longer be a driveway which means that 160 feet will become available for parking (10 more parking space).

B. Economic Development Committee:

Alcohol Beverage Control License Application request for a letter of support by Bravi Regazzi BK LLC, 570 Putnam between Throop Avenue & Marcus Garvey Blvd Tywan Anthony, Committee Chair introduced Michael Bancale. He added that a site inspection was conducted.

Mr. Bancale stated that he is the General Manager of Bravi Regazzi. It will be a traditional Neapolitan Pizzeria. It will be restaurant with a full bar. He would like to bring the original taste of Neapolitan pizza. To keep tradition alive. He was born and raised in Napoli, Italy.

He will use a wooden fire oven with a pollution control system called "smoky". There will be no smoke or ash. The chef will be from Italy and he will cook and teach anyone who will like to learn how to make traditional pizza. He has another restaurant in South London. He will offer a casual service with delivery and full bar with craft beer and cocktails.

There will be two entrance. The bar area will have 11 seats. There will be outdoor seating in the future. It will be kids and family friendly. The space can also be used for private parties.

Questions & Answers

Simone Pratt: Where will the outdoor seating be, on Marcus Garvey or Putnam Avenue? Talk more about the live band.

Michael Bancale: The outdoor seating will be on Putnam Avenue. There is a pre-existing stage area.

Resident: What are the hours? **Michael Bancale:** Mondays – Thursdays: 12:00 p.m. – 11:00 p.m.; Fridays – Saturdays: 12:00 p.m. – 12:00 a.m.; Sundays: 12:00 p.m. – 10:00 p.m.

Michael McCaw: Did you apply with Department of Consumer Affairs? **Michael Bancale:** No, it is for the future.

Babatunde Akowe: Did you get a letter of support from the block association? **Michael Bancale:** I spoke with some people but not with the block association

C. Economic Development Committee:

Alcohol Beverage Control License Application request for a letter of support by Tallboys Inc., 1452 Fulton Street between Tompkins & Kingston Avenues Tywan Anthony, Committee Chair stated that a site inspection was conducted.

Alexandra Escamilla and Shane Feirstein are the owners of Tallboys Inc. This will be their second venture in the community. They are also the owners of Lovers Rock on Tompkins Avenue and Hancock Street and Halsey Streets. Lovers Rock have been opened for a year and a half.

Tallboys will be neighborhood Grill with a full kitchen and menu. They both live within blocks from the business for over 10 years. They have created 14 new jobs for residents of Bedford-Stuyvesant. They have supported other organizations and events in the community and will continue to bridge partnerships. The hours of operations will be Sunday – Thursday: 11:00 a.m. – 2:00 a.m.; Friday – Saturday: 11:00 a.m. – 4:00 a.m.

They are doing to a full gut renovation of the location. The space will include a 60 person dining area that includes a small bar, new bathroom and a full kitchen.

Questions & Answers

Resident: Have you address the issues that the residents are concern with. There does not seem to be any concern about the residents since you will be closing late? **Alexandra Escamilla:** We have spoken to the residents in the building next door.

Paulette Morehead suggested that they change the closing time on Sundays.

A. Civic & Public Safety Committee

The committee hosted a presentation by Bedford Stuyvesant Anti-Violence, who will speak about "Her Life a Program for Young Women" a workshop for young women Stacey Ruffin, Committee Chair introduced Hailey Nolasco, Founder

Ms. Nolasco announced that in partnership with the Sadie Nash Leadership Project there will be a series of workshops for young women ages 16-20 years old who would be categorized as mid to high risk. Some of the workshops will focus on: identity and community building, systems of oppression and its effects on women of color, building relationships with other women, trailblazers etc. The Mayor's Office to Combat Domestic

Violence will also be on hand to conduct workshops. Job training and resume writing assistance will be given.

The program will meet on Tuesdays at the Brooklyn Action Center, 47 Throop Avenue and on Thursdays at 256 Kingston Avenue from 4:30 p.m. – 6:30 p.m. A stipend will be given along with a MetroCard. Education & Youth Committee:

The Brooklyn Tech High School Alumni Foundation presented their outreach efforts to increase the number of African American and Hispanic students' ability to take the specialized High School test.

Oma Holloway, Committee Chairperson introduced Faye Moore, Brooklyn Tech Alumni Ms. Holloway stated that she will discuss the outreach effort to increase the number of black and Hispanic students to take the Specialized High School Test.

Ms. Moore stated that the population of Black and Hispanic students has dropped drastically to 18%. Some parents are not aware that the test is available to their child.

Ms. Elizabeth Scarvara, Executive Director, Alumni Association. She invited parent to a Forum on April 4th, at Brooklyn Tech High School at 6:30 p.m. The forum will focus on helping students prepare for the test and sharing resources. The have partnered with National Grid to provide the STEM Program to 6th Grade Middle School students.

Sam Adewemi is a Math teacher at Brooklyn Tech and he also operated a test prep program. Several test prep companies will be on hand.

B. Economic Development Committee

The committee hosted a presentation by the Bed-Stuy Cooperative Business Project, who look to help local residents develop wealth. Mr. Flateau introduced Ashleigh Eubanks and Bianca, Food Justice Director, Northeast Brooklyn Housing Development Corporation (NEBHDCo)

NEBHDCo has developed cooking programs and the gardening internships program. They also operate a food pantry. She in turn introduced Scott Trumbull

Scott Trumbull, Working World stated that this is a non-profit Loan Fund. The have worked in Latin America and the Unites Stated to give people access to capital and the tools they need to become business owners. There are two things that distinguish Working World:

- 1) They only work with worker owned or community owned enterprises,
- 2) They have non-extractive financial model (they only get repayment on the loan after the business becomes profitable and the workers are getting paid.

Smiley Rojas Nunez explained what a Worker Cooperative is. He stated that it a democratically run workplace. All the workers are co-owners of the business. They have an equal share in the business at the end of the year. This program help to distribute wealth on the community.

They would like businesses to become co-owners with their workers.
