REMARKS FROM THE CHAIRPERSON – Richard Flateau

Mr. Flateau read the agenda into the record.

DISTRICT MANAGER’S REPORT – Henry L. Butler

Mr. Butler informed the audience that the Organic Recycling Program will begin in Bed-Stuy next year. It is currently in Community Boards 1 and 16.

In addition, DOT will conduct a study on tractor trailers parking on residential streets in order to come up with a solution to the problem. The Board would like to have a designated enforcement unit for Brooklyn North and South.

Mr. Butler announced that that the Department of Sanitation Volunteer Clean-up Program is now providing supplies for block clean-ups.

He also gave an update on the Rose Castle Rezoning application. He stated that he along with the Board Chair and the Land Use Committee's Chair and Co-Chair met with Council Member Levin to discuss their concerns. Council Member Levin took the Board's concerns into consideration and was able to secure a 60% AMI on the smaller site and 85% AMI on the larger site.

I. INFORMATIONAL PRESENTATION

A. Civic & Public Safety Committee:

The NYC Fire Department discussed recruitment initiatives

Stacey Ruffin, Committee Co-Chair introduced Firefighter Dasul Andrews

Firefighter Andrews informed the audience about the upcoming Firefighter Exam. The exam is given every 4 to 5 years. It is open to individuals between the ages of 17 ½ to 28 years.

In addition, the FDNY will be hosting Open House throughout the City on May 6th. He encouraged everyone to visit their local fire houses to meet the firefighters, EMT's, Paramedics, take a tour and learn more.

II. PUBLIC HEARING

A. Parks Art & Culture Committee:

The NYC Parks Department is seeking a letter of support for the proposed renovation of Weeksville Playground (location is Howard Avenue between Atlantic Avenue & Herkimer Street)

Marion Little, Committee Chairperson introduced Kevin Boyle

Mr. Boyle explained that this project is funded by the Mayor. The project will upgrade the play equipment for 2-5 year olds, the seating, the sprinkler, trees will be added, and the lightning. There will be fence surrounding the plants. A PowerPoint presentation was done highlighting the upgrade.

Questions and Answers

Dr. Williamson: What is the price of the project?

K. Boyle: \$900,000

Felicia Alexander: Why was a lower fence used, it makes the playground more accessible?

K. Boyle: Commissioner Silver goal is to have parks without borders.

Chinyelu Udoh: Why is there no restroom?

K. Boyle: The budget does not allow. Comfort stations cost \$3 million to build.

Tarisse Iriate: I do not see any historical markers as part of the plan? Why

K. Boyle: We can look into adding something.

Oma Holloway: Did you get feedback from Weeksville?

K. Boyle: There was a listening session.

B. Housing & Land Use Committee:

NYC Housing Preservation & Development has submitted the following application for ULURP:

- 1) Pursuant to Article 16 of the General Municipal Law of NY State for:
 - a) the designation of property located 1616 and 1624 Fulton Street, and 20R Troy Avenue (Block 1699, Lots 35, 39, and 43), as an Urban Development Action Area; and
 - b) an Urban Development Action Area Project for such area; and
- 2) Pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer to be selected by HPD; to facilitate the construction of an 11 story mixed use building approximately 96 dwelling units and ground floor commercial space, Borough of Brooklyn, Community District 3

C. Doris Pinn, Committee Chair introduced Juan Barahona, SMJ Development & Daniel Moran, HPD Brooklyn Planning Unit

Oma Holloway recused herself from the project because she works at Bridge Street Development Corp. and they are part of the project.

Daniel Moran informed the audience that this is a UDAAP application. The site is a R7D with a small portion being R6. The proposed building will be 11 stories with a total of 96 units and 13,000 sq. ft. of retail space and 60% - 130% AMI.

Mr. Barahona stated that the site consist of eight lots, five of which are privately owned. The other three lots are City owned. SMJ Development will be working with Bridge Street Development Corp. on the Marketing aspect of the project.

Question & Answers

Joe Gonzalez: How many resident will live and work on this project?

Juan Barahona: Through Housing Connect 50% -100% preference will be given to the residents. Local contractor will be used as part of MWBE buildup.

Ray Ray: What is affordable?

Juan Barahona: Half of the project is affordable. 60% was private land. A 3 bedroom can cost \$1200; a studio \$1000. This project does not provide parking.

Chinyelu Udoh: I have a quality of life issue, 356-400 sq. ft. for a studio is a shoe box and not acceptable for anyone to live in.

Randy Jackson: Does HPD accept the lowest bidder?

Daniel Moran: HPD puts out a RFP which is a very competitive process.

C. Johnson: What is HPD's role in this process?

Daniel Moran: HPD determines how many units, they provide loans, and they have a regulatory agreement. HPD also contributes the land to bring down the AMI.

C. Economic Development Committee:

Alcohol Beverage Control License Application request for a letter of support by 461 Dekalb Avenue between Taaffe Place and Kent Avenue. (entity to be formed by Juan Vasquez).

There were no representation from this business.

D. Economic Development Committee:

Alcohol Beverage Control License Application request for a letter of support by Acoustic Garden LLC, located at 1515 Atlantic Avenue between Kingston & Albany Avenues
Tywan Anthony, Committee Chair introduced Heather-Sky McField, Owner

Ms. McField stated that the concept behind Acoustic Gardens LLC is Havana Outpost meets corner social. The hours of operation will be Tuesday to Thursday & Sunday: 4:00 p.m. – 2:00 a.m.; Friday to Saturday: 4:00 p.m. – 4:00 a.m. There will be three kitchen staff, one bartender and two server. The menu will be tapas, and specialty cocktails.

There will be an outdoor bistro seating. Ms. McField added that she will also be offering financial literacy workshops, Indie movies and other events.

Questions & Answers

Ray Ray: My family lives on the corner and they do not want this establishment there.

Ms. McField: I can sit down with your family to discuss any issues they may have.

Paulette Moorehead requested that the closing time on Sunday be changed. Ms. McField stated that she take that into consideration.

V. COMMITTEE UPDATES & RESOLUTIONS

- A. Landmarks & Preservation Committee is seeking support for a LPC application at 158 Halsey Street between Nostrand and Marcy Avenues.

Ms. Collier reported that the committee met with the owners on April 10, 2017. They are proposing to add a three level rear extension, remove the historic rooftop dormer and add a rooftop addition. The committee voted unanimously to **DISAPPROVE** the oversized 3-level rear extension because of the excessive bulk.

A motion was made to accept the resolution by Felicia Alexander and seconded by Douglas Williams.

- B. Landmarks & Preservation Committee is seeking support for a LPC application at 82 Chauncey Street.

Ms. Collier stated that the committee met with the owners on April 10, 2017. They are proposing to install a deck. They voted to **APPROVE** the proposed application to install a rear yard extension and deck.

A motion was made to accept the recommendation by Felicia Alexander and seconded Anthony Buissereth.

- C. The Landmarks & Preservation Committee is seeking support for a LPC application at 207 MacDonough Street between Throop Avenue and Marcus Garvey Blvd.

Ms. Collier stated that the committee met with the Architect on April 10, 2017. They are proposing to restore the front of the building including the façade, pavement, and fencing. They will be using the 209 MacDonough Street as a guide. The committee voted **unanimously** to support the project.

A motion was made by Babatunde Akowe and seconded by Edna Johnson.

Oma Holloway

VI. ACTION ON THE PUBLIC HEARING

- A.** The NYC Parks Department is seeking a letter of support for the proposed renovation of Weeksville Playground.

The committee recommended giving a letter of support as long as the Parks Department provide a historical, cultural and artistic contribution of Weeksville. A motion was made by Edna Johnson and seconded by Douglas Williams.

- B.** The NYC Housing Preservation & Development is seeking support for UDAAP – Disposition of land to a developer to facilitate the construction of an 11 story mixed use building located at 1616-1624 Fulton Street

Ms. Pinn stated that the committee met four times on this project. She explained that the “D” designation does put a cap on the height of the building. However, the Mayor’s Plan which is law added two additional stories.

In addition, affordable development does not require parking. The committee voted to give a letter of support. A motion to accept the recommendation was made by Taina Evans and seconded by Hardy “Joe” long.

- C.** Acoustic Garden LLC request for a letter of support for an Alcohol Beverage Control License Tywan Anthony stated that the committee recommendation is to give a letter of support with the following three stipulations:

- 2) 11:00 p.m. on Sunday
- 3) The establishment at 12 Midnight on Sunday

He added that he has received a signed letter from Ms. McField agreeing to the stipulations.

A motion was made to accept the recommendation with stipulations was made by Douglas Williams and Tarrise Iriate.
