Felicia Alexander proposed amendments to the following sections of the CB3 By-Laws:

## **Section VI: General Election Process**

## A. Nominating Committee:

1. During Brooklyn CB3's regular monthly business meeting in October, the first order of business shall be the formation of a Nominating Committee consisting of seven (7) Brooklyn CB3 members.

#### C. Term of Office:

2. The tenure of all elected officers of Brooklyn CB3 shall be no more than *four* consecutive one-year terms, except by a majority vote of the seated quorum of Brooklyn CB3 members.

## **Proposed Amendment:**

- 1. During Brooklyn CB3's regular monthly business meeting in October *of an election year*, the first order of business shall be the formation of a Nominating Committee consisting of seven (7) Brooklyn CB3 members.
- 2. The tenure of all elected officers of Brooklyn CB3 shall be no more than *two* consecutive *two-year terms*, except by a majority vote of the seated quorum of Brooklyn CB3 members.
