I. INFORMATIONAL PRESENTATION

A. Economic Development Committee:

Carpenter Contractor Alliance of Metropolitan New York gave a presentation on their Pre-Apprenticeship and Direct Entry Programs

Tywan Anthony, Committee Chair introduced Amir Abbady, Director of Community Relations.

Mr. Abbady introduced two carpenters from the union: Charles Bullock and Kurt McCarthy who spoke of the benefits of being in the union, their salary and their accomplishments since learning the trade.

He added there is a lottery process to enter the union. There are 500 openings. The deadline to apply is Monday, July 1st, for the pre-apprenticeship program. Building Works is a direct entry program dedicated for carpenters. It is a four-year program. There are also non-traditional trades for women. B. Economic Development Committee:

Rebecca Rodriguez, NYC MWBE Alliance gave a presentation on becoming a Certified Minority Women Business Enterprise vendor for New York City. She stated the organization was started to provide assistance and bridge the gap between businesses and the City agencies. They have several programs that are free. She added that being certified is essential to growing your business.

C. Health & Social Services Committee:

Adina Segal, Caregiver Program Director, from Heights and Hills gave a presentation on the caregiver and support services they offer to older adults/seniors. They provide assistance with navigating the application process for Medicare and other medical forms.

In addition to the Caregiver Program, they provide supportive services, counseling, shortterm respite, and community education workshops. There are also telephone support and dementia groups, they have a program at Methodist Hospital, and in-house services at 81 Willoughby Street. The programs are funded by the Department for the Aging. All of their services are free.

II. PUBLIC HEARING

A. Transportation, Sanitation & Environmental Committee:

The Dept. of Transportation and the MTA presented their plan to make the B46 bus stop on Malcolm X Boulevard between Chauncey and Fulton Streets, a full curbside bus lane from 7:00 a.m. to 7:00 p.m. This will also apply to the Utica Avenue bus stop between Fulton Street and Atlantic Avenue.

Gregory Glasgow, Committee Chair introduced Kyle Gebhart & Ryan Feller, DOT Representatives Ryan Feller stated that the B46 bus is one of the busiest bus routes in Brooklyn. However, the speed that the bus travels from Chauncey Street to Atlantic Avenue is very slow at 3.4 mph, compared to the average at 6.7 mph between the hours of 7:00 a.m. - 7:00 p.m., when ridership is at its highest. DOT will plan to remove parking spaces.

The plan aims to increase bus speed by 25%. It will create a curbside bus lane from Fulton Street to Atlantic Avenue Southbound. It will improve the traffic flow especially since the B46 will be upgraded to a longer, articulate buses by 2020. Overnight parking will remain.
