REMARKS FROM THE CHAIRPERSON - Richard Flateau

Mr. Flateau read the agenda into the record. He then read a press release regarding an incident that took place at The Strand Café, 492 Nostrand Avenue on Halloween. Oma Holloway also gave a statement about this statement.

Mr. Flateau thanked the police for the quick arrest in the home invasion at 160 Decatur Street of the two elderly people which led to the death of the husband.

ACKNOWLEDGMENTS OF ELECTED OFFICIALS AND COMMUNITY PARTNERS

Nicholas Perry – Hon. Scott Stringer

Nicholas Perry stated that Comptroller Stringer is currently working on a Rent and Credit Initiative which will provide benefits to tenants.

Shakti Robbins – Hon. Velmanette Montgomery

Shakti Robbins reminded everyone to vote especially on propositions for a Constitutional Convention. Copies of the State Constitution were left on the table.

Amanda Robinson - Hon. Tremaine Wright

Assembly Member Wright will host a Thanksgiving Day Turkey Trot, 5K and Family Fun Run at Herbert Von King Park. It will begin at 9:00 a.m.

She added that Assembly Member Wright is trying to spread the word about the STAR Program which will allow Homeowners to save a lot of money on their taxes.

Matthew Pitt - Hon. Laurie Cumbo

Mr. Pitt informed that Council Member Cumbo's office continues to offer Immigration Services. Please call the office at 718-260-9191.

LaMeane Isaac – Macon Branch Library

Ms. Isaac informed the audience that all NYC libraries have waived the fees for students starting on October 19th.

In addition, she mentioned that the Brooklyn Public Library is partnering with Bard College to offer adults free classes towards a degree at the library. Tuition and books are covered by grants and scholarships.

On November 30th, at 6:00 p.m., the Macon Branch Library will present "Chasing Light", a photo exhibition and book discussion on Michelle Obama by former White House Photographer Amanda Lucidon.

Vanessa Smith – NYC Mural Arts Project

Ms. Smith stated that the project is a collaboration with the NYC Department of Health and Mental Hygiene. 1-in-5 New Yorkers live with a mental health disorder. The project was created to start a new conversation about mental health in the community. Through the mural making process, they try to reduce the stigma and foster new social interactions.

Eifreda Bell - Services for the Underserved

Ms. Bell is a mental health client at the Club House, 1125 Fulton Street. She stated that the Club House helps its clients live a productive life.

Olanike Alabi – 57th Assembly District Leader

District Leader Alabi reminding everyone to vote on all three proposals which are equally important.

Oma Holloway - Bridge Street Development Corp.

Ms. Holloway informed the audience that the Movement for Black Lives and the Electoral Justice Project is hosting a Town Hall upstairs in the Board Room from 7:00 - 9:00 p.m.

On November 9^{th} , there will be a free legal clinic at Bridge Street Development Corp., 456D Nostrand Avenue. It will be held from 4:00-6:30 p.m. This clinic will focus on tenant/landlord issues.

Ms. Holloway informed that there will be a workshop on "How to Become a Certified MWBE". It will be held on November 13th, at 6:00 p.m.

Stefanie Zinerman - Hon. Robert Cornegy, Jr.

Ms. Zinerman read a statement from Council Member Cornegy regarding the Halloween incident at Strand Café.

On November 20th, a Citizens Preparedness Corps Training Program will be held at Restoration Plaza at 6:00 p.m. She invited everyone to come out and learn emergency preparedness in case of a disaster.

On November 13th, there will be an "A.S.K for Your Life" workshop to help African Americans get the best health care when they visit their doctor. It will also be held at Restoration Plaza.

DISTRICT MANAGER'S REPORT – Henry L. Butler

Mr. Butler gave an update on La Quinta Hotel on the corner of Atlantic and Nostrand Avenues. He stated that the Department of Homeless Services originally reported that they were only using 34% of the hotel for their clients however, it was reported that they now have 100% of the hotel for homeless services.

LIRR is upgrading the Nostrand Avenue Station. This is a \$28.1 million project. The upgrade includes two new elevators, new platforms, staircase and overpass. There will also be new LED lighting, benches, signage, Wi-Fi, charging ports, etc. The project is scheduled to be completed by April 2019.

He added that a new traffic light will be installed by P.S. 40 at Ralph Avenue and Marion Street. This request was made because there are no traffic signals from Bainbridge Street to Fulton Street. This is scheduled to be completed by February 2018.

Mr. Butler reported that there will be an Envisioning meeting for 638 Myrtle Avenue on November 15th, from 6:00 – 8:00 p.m. DEP owns a lot at this location and they are planning to build housing on the lot. It will be held at Brooklyn Community Arts & Media High School. He recommended that residents attend this meeting to make their voices heard. Flyers were available.

There is a rat problem in the neighborhood and the City in partnership with the Departments of Health, Parks, Sanitation and NYCHA will be implementing the "Neighborhood Rat Reduction Program". Flyers were available.

Mr. Butler advised seniors to get their own attorneys when attending meetings and signing documents pertaining to their homes. There are a lot of resources available, such as Brooklyn Legal Services.

I. INFORMATIONAL PRESENTATION

A. Health & Social Service Committee:

Update on One Brooklyn Health Plan for Interfaith Hospital Edna Johnson, Committee Chair introduced LaRay Brown, President & CEO, Interfaith Hospital

Ms. Brown gave an update on the One Brooklyn Health System which covers Interfaith, Kingsbrook and Brookdale Medical Centers. These three hospitals are considered to be safety net hospitals because they serve people who are on Medicaid, Medicare, other government programs and a small percentage of commercial insurance. They have all struggled financially over decades. The State of New York have made a commitment that if the three hospitals work together, they will make a capital investment to the hospitals and 30 community based healthcare centers (ambulatory care centers).

Ms. Brown stated that State Legislator enacted the Kings County Transformation Program in 2015. In May, One Brooklyn applied for \$700 million which will cover improvements to the elevators, the heating and air conditioning ventilation system. One Brooklyn also applied for an expansion of the Emergency Room and the Psychiatric Unit. At Brookdale, the Intensive Care Unit. At Kingsbrook, they applied for the Center to become a Medical

Village. To invest in the Ambulatory Care and Long Term Care services for physical rehabilitation. One Brooklyn is seeking to open various locations that would be accessible to people who do not have a primary care doctor. Many people go to the emergency room for that reason.

B. Veterans Committee:

The U.S. Dept. of Veterans Affairs made a presentation on Homeownership, Business Start-Up and Government contracting opportunities for Bedford Stuyvesant Veterans Douglas Williams, Committee Chair introduced Lyn Johnson, V.A. Outreach Specialist

Mr. Johnson informed the audience that the Department of Veterans Affairs (VA) helps veterans and their spouse obtain home loan guaranty. The current home loan guaranty for Bedford Stuyvesant is \$739,000. The VA also helps veterans gain access to economic opportunities by leveraging government procurement. Veterans and their spouses can start a business, expand an existing one or apply for a contract with a government entity.

The U.S. Department Small Business Administration requires three percent of every dollar must be set aside for Service Disabled Veterans, so far they have only made one percent of the quota. They have never made the quota because veterans are not utilizing the service. Flyers with all information were available.

PUBLIC HEARING

A. Housing & Land Use Committee:

Board of Standards and Appeals application for 510 Quincy Street and 651-671 Gates Avenue requesting a special permit pursuant of ZR73-433 to reduce parking requirements for income-restricted housing units in two existing buildings from 106 to 18 accessory off street spaces

C. Doris Pinn, Committee Chair introduced Frank St. Jacques of Sheldon Lobel and Demetrius Moragianis, Owner

Frank St. Jacques stated that the owner is requesting a special permit that would allow a waiver of an existing parking requirement to build a 100 percent affordable housing. Presently there are two six-story building with a 100 parking spaces. The lot is under-utilized.

The proposed building that would be built on the parking lot is a seven-story 112-unit affordable housing building. It will have 85,000 sq. ft.; 70 feet in height with a 15 foot setback above 60 foot base. It will have 28 parking spaces in the rear of the building and it would be built pursuant to the Quality Housing Requirements. He showed several photos including an aerial view of the parking lot to reflect the lack of use. The building is "Asof-Right".

Questions and Answers

Jamella Swift: Are these 1-3 bedrooms and what is the income requirements? **Frank St. Jacques:** There are 111 units with one unit for the superintendent, equaling 112. There are 55 units with a mixed of studios, 1, 2 and 3 bedrooms and they are at 100 percent AMI. There are 32 units with the same distribution at 57 percent AMI and 12 units

with 47 percent AMI and another 12 units has a 30 percent AMI. The range for the units that are 100 percent AMI is \$1300 - \$2400 with an income of \$67,000; 60% AMI is \$760 - \$1300 with income of \$40,000 - \$62,000 and 50% AMI is \$620 - \$1100 with an income of \$20,000 - \$31,000.

Felicia Alexander: What is preventing the people in the 96 units from utilizing the parking lot?

Frank St. Jacques: There is a fee, however, as stated the residents were not utilizing the lot. According to the City this area is a transit zone. It has a low car ownership of 18 percent. The new building has a parking requirement and it is being met.

Ralph Sealy: They have not encouraged parking because there is no lights and security. It is not safe. They have no insurance.

Demetrius Moragianis: That is not true.

Gregory Glasgow: If you were to develop the building as of right now, how many parking spaces are you required to provide?

Frank St. Jacques: 28

There were a series a statements from homeowners on Quincy Street about the lack of parking spaces in the neighborhood.

B. Economic Development Committee:

Alcohol Beverage Control License Application for Lox & Schmear LLC, 165 Tompkins Avenue between Willoughby & Hart Streets

Tywan Anthony, Committee Chair introduced Alex Kleinberg, Owner

Alex Kleinberg stated that this will be a restaurant with a full bar. The space is 3,000 sq. ft.; 1,500 sq. ft. per floor with greenhouse and a backyard. The capacity will be 70 including the backyard. The greenhouse and the backyard will be table seating.

There will be 13 seats around the bar. The hours of operation will be 8:00 a.m. -2:00 a.m. Mondays to Thursdays; 8:00 a.m. -4:00 a.m. Fridays and Saturdays; and 10:00 a.m. -2:00 a.m. on Sundays. Fridays to Sundays there will be security to check IDs. The staff will be hiring from the community.

Ouestions and Answers

Questions were asked about security and noise.

C. Alcohol Beverage Control License Application for Noha Entertainment, 95 Halsey Street corner of Nostrand Avenue

Tywan Anthony, Committee Chair introduced Raymond Pierre-Louis, Owner

He stated that this will be a bar and lounge. He stated that there were issues in terms of noise and loitering from the prior business. He stated that he plans to address the issue by sound proofing.

Questions & Answers

Questions of noise, security, change in closing time and a DJ were raised by board members

and residents. Mr. Pierre-Louis stated that the security is a retired police officer.

D. Alcohol Beverage Control License Application for Lila Café LLC, 911 Dekalb Avenue between Marcus Garvey Blvd & Throop Avenue

Tywan Anthony, Committee Chair introduced David Young and Barbara Ann Hudson, Owners

This will be a family oriented Seafood Café with Caribbean, African & Southern Cuisine. They plan to open the café in early December. It is a family oriented restaurant.

Questions and Answers

Babatunde Akowe: Did you get support from the block association?

David Young: We were not able to locate a block association. I have 25 signatures and 4 letters from businesses.

Ms. Cobb: What are your hours?

David Young: Sundays to Thursdays the hours will be 5:00 p.m. - 10:00 p.m.; Fridays and Saturdays; 10:00 a.m. - Midnight. For brunch and dinner.

E. Alcohol Beverage Control License Application for Southern Comfort, 375 Marcus Garvey Blvd between Jefferson & Hancock Streets

Tywan Anthony, Committee Chair introduced Shawanna E. McDonald and Kirk McDonald Owners

Ms. McDonald stated they have three building 375, 377 and 379. The first building would serve as commercial kitchen and take-out and the other two buildings will be the sit-down restaurant. They had a prior business called Sublime Caterers. This is a family restaurant. They are very involved in the community.

The hours of operation are: closed on Mondays, Tuesday and Wednesday 11:00 a.m. – 10:00 p.m. Thursdays to Saturdays: 11:00 a.m. to Midnight and Sundays: 11:00 a.m. to 9:00 p.m. Fridays and Saturdays the menu will be seafood.
