Mr. Butler informed the residents that information pertaining to the five questions on the ballot is available on the table. One of the question is pertaining to community boards and the ULURP process and the amount of time The Board gets to review the application. The vote is to extend the time during the summer.

I. INFORMATIONAL PRESENTATION

A. Census Committee:

James Tillman, Partnership Specialist at the U. S. Department of Commerce gave a presentation on the upcoming 2020 Census

Mr. Tillman informed the audience that a form will be sent to every resident to determine how they would like to complete the census, whether it is by mail, computer or by phone. There are only ten questions. In 2010, children under 5 years were under-counted. Black men between the ages of 18-29 years were not counted. The information collected will not be shared with any other agency. In 2010 only 33% of people in Brooklyn responded.

He added, there are jobs available. A new office was opened on Myrtle Avenue between Broadway and Lewis Avenue. If you are looking for job or know someone, visit www.2020census.gov/jobs

Mr. Butler added, the Board has formed a Census Committee, anyone interested in serving on this committee, please see him.

II. PUBLIC HEARING

A. Capital & Expense Budget Committee:

The Budget Coordinators, Anthony Buissereth & TJ Wilson held a brief Public Hearing on Community Board 3 Fiscal Year 2021 Budget Request Priorities

Survey forms were distributed and TJ Wilson asked everyone to fill it out and submit after the meeting. Anthony Buissereth stated that the budget request deadline is the end of October and they would like to hear the ideas and opinions of the community to ensure a comprehensive request.

B. Parks, Art, & Culture Committee:

NYC Department of Parks & Recreation gave a presentation on the renovation of Charlie's Place Playground

Emmanuel Thingue, Landscape Architect presented the master plan for the park even though they are budgeted for a small phase of the project. The goal of the project is to create access to the park. They will be upgrading the play area, integrating more seating, adding synthetic turf and adult fitness, handball and basketball courts.

P.S. 73 is currently using the area as a parking lot however, they will be parking elsewhere. This was decided at the scope meeting. In addition, the community garden which was blocking access and view will be relocated to the school area. The playground is not part of the budget therefore, it will remain the same. The sidewalk is in good condition therefore, it will be no trees because there are sewer pipes running below. There will be an easement to allow DEP access.

Questions & Answers

Jamilla Swift: Will there be bathroom? Emmanuel Thingue: No, the budget does not cover. Reginald Sweney: Will the park be ADA accessible?

Emmanuel Thingue: The budget was not for the playground, it was mainly to reconstruct the basketball and handball court. In terms of the accessibility for the space, he stated that he will take it into account. However, even though there are no ADA accessibility on Ellery Street, the area will be sloped at 5%.

Anturo Branco: What is the budget and how long did it take to get the funding? Emmanuel Thingue: The total budget is \$1 million 76 thousand and all Capital funding is -4 years.

C. Parks, Art, Culture Committee:

NYC Department of Parks & Recreation gave a presentation on the renovation of Saratoga Park Playground

Patricia Clark, Landscape Architect gave a presentation on Saratoga Park Playground. The park was funded by Council Member Alicka Ampry-Samuel for \$2.183 million. The goal is to upgrade the active and accessible play features on the site and resolve the drainage issues. The project will focus on the playground, the lighting, the fencing, the drainage issue, and the trees.

Questions & Answers

Jamilla Swift: Will there be a dog run? Patricia Clark: The project is only for the playground.

Simone Pratt: Are the swings for specific age groups? Patricia Clark: It will only be bucket and accessible seats and Swings take up a lot of space and this is a small playground

David Matthews: What type of material are utilized for the up, over and through? **Patricia Clark:** The area is shaded which helps with the heat gain

Reginal Sweeny: What is the height of the slides? **Patricia Clark:** For toddlers, the height is 18 inches and for 2-5 year olds it is 3 feet.

Leah Asha Allen: The grass is dead, will you be replacing the grass? Patricia Clark: The grass that is damage due to construction will be replaced

D. Economic Development Committee:

The hours of operation at Sunday – Thursday: 5:00 p.m. - 2:00 a.m., Friday and Saturday 5:00 p.m. - 4:00 a.m. He added that they will be hiring 10-15 employees.

Mr. Joseph informed the audience that this will be a sports bar and event space. They have four restaurants and have hosted numerous events. The first floor will have two egress, there will be 19 seats around the bar and 15 for dining, and kitchen. The second floor will be used for special events and sports events. Weekdays they would like to open until 3:00 a.m. and weekends until 4:00 a.m.

They are looking to target "Out of School, Out of Work Youth" (18-24 years old). They have a partnership with the Door and willing to work a re-entry program and other groups.
