We address income crises by helping New Yorkers access tens of millions of dollars in benefits and unlawfully withheld wages. Please be advised that there will be a monthly full roadway and street closure for the use of concrete placement, at 123 Melrose Street between Stanwix Street and Evergreen Avenue from February 1, 2019 thru March 1, 2019 from 9am to 4pm Monday to Friday.

CityBench

The CityBench program is an initiative to increase the amount of public seating on New York City's streets. DOT installs attractive and durable benches

around the city, particularly at bus stops, retail corridors, and in areas with high concentrations of senior citizens. These benches make streets more comfortable for transit riders and pedestrians. especially for those who are older and disabled. Anyone can request a bench, and anyone can use one. DOT encourages all New Yorkers to recommend locations for benches on the DOT rightof-way (not private property). If you know of a good location that meets the requirements below. please complete the web form below or print out a paper form and send in by mail. http://www. nvc.gov/html/dot/downloads/pdf/ citybench_form.pdf The CitvBench program has installed over 1,800 benches

throughout the five boroughs and will install an additional 100 benches by 2019. To find a bench near you or request a bench in neighborhoods with a lack of seating, visit our web map at http://a841-dotweb01.nyc.gov/ citybench_map/ See a list of our installed benches at http://www1. nyc.gov/html/dot/downloads/pdf/ citvbench-locations.pdf In order to support walking and transit, priority bench locations include:

• Bus stops without shelters

 Sidewalks near transit facilities (e.g. subway stations)

- Senior centers
- Hospitals and community health centers
- Commercial zones and shopping districts

• Municipal facilities (e.g., public libraries, schools)

The benches are for use by the general public and are not restricted to tenants of any particular building or patrons of any particular business. Benches cannot be used to displace street vendors.

For safety and engineering reasons, there are some base requirements for where benches can do:

• In all instances, an 8 feet clear path from bench to building line must be maintained.

 For benches with backs placed along the curb, the minimum

sidewalk width is 12 feet from building to curb.

• For backless benches placed along the curb, the minimum sidewalk width is 14 feet from building to curb.

• For benches placed against a building, the minimum sidewalk width is 10 feet, six inches.

 Benches cannot be placed directly opposite a building entrance or cellar door.

• Where there is a sidewalk café, the sidewalk width is measured from the outside of the café to the curb. The minimum widths listed above apply in these cases. DOT covers the costs of installing and maintaining the bench. The CityBench program is funded through the Federal Transit Authority's (FTA) Section 5310 Program grant. The goal of the Section 5310 program is to improve mobility for seniors and individuals with disabilities throughout the country by removing barriers to transportation services and expanding the transportation mobility options available. If for some reason, such as construction activity or changes to bus stop locations, a bench needs to be removed or relocated, please email to mailto:citybench@dot.nyc.gov or call 311. DOT will replace damaged benches. Property owners are responsible for keeping sidewalks around benches clean and cleared of snow as required by law. New Yorkers throw out over

10,000 tons of garbage a day. The best way to keep garbage from landfills is by limiting the materials you use. Reduce use when you can - and reuse and recycle the rest. For the rest, we offer curbside collection services so it is easy for you to get rid of your trash and keep our city clean.

Recvclina:

Our team collects approximately 1,200 tons of recycling a day bringing us every day a little bit closer to zero waste to landfills by 2030. We provide curbside collection and drop-off programs to simplify getting rid of your plastics, paper, glass and metals. Harmful Products:

Get rid of your harmful products such as paint, medical waste and flammable items the right way. Read through our resources to know what to toss and how to do it whether you are a resident, business, nonprofit or school.

Electronics:

Tossing out electronics is bad for the environment and illegal. We make it easy for you to dispose of electronics safely. Find out more about our programs and convenient drop-off locations to get rid of your old laptop, television, VCR and more. Donate Goods:

Give away or trade your unwanted goods with us. Our programs and services make it easy for you to donate or swap that old t-shirt for something new, all while saving you money and supporting the community.

Litter and Litter Baskets:

It's illegal to throw litter or garbage onto streets or other public spaces – or to throw garbage out of a building or window. People caught littering may be issued a summons. Report streets and sidewalks with chronic littering and the City will respond to recurring issues. You can also report litter, garbage or debris on highways. Property owners are responsible for cleaning litter from public areas next to their property - even if a chronic littering report has been filed.

Agency Notices

Litter Baskets:

Litter baskets are for pedestrians to dispose of light garbage – and can't be used for household or commercial garbage or sweepings. Bundle any loose trash that can blow away, and when discarding dog waste – wrap it first.

Notices and Signage

The City of New York will occasionally post notices, advertisements, posters and stickers to communicate important information to the public. It's illegal to tear down, deface or destroy any printed materials displayed by the City. Posting signs on public property - including on trees, lampposts, and curbs - is illegal and can result in a fine in addition to the cost of the removal. It is also illegal to place unwanted decals or stickers on public or private property or put handbills on cars. It's illegal to distribute unsolicited ads on private property where a sign is displayed discouraging such ads. To avoid unwanted ads and flyers on your property, post a sign in a visible area to let advertisers know you're not interested. The sign should be at least five inches tall and seven inches wide and legibly state, "Do not place unsolicited advertising materials on this property." In buildings with multiple dwellings, property owners should post such a sign if all the units unanimously agree to prohibit ads. If some residents want to receive the ads, the owner should indicate where and how many ads should be left.

Illegal Dumping:

It's illegal to dispose of any material or debris by driving it and dumping it on any street, lot, park, public space – or any publicly or privately owned area. To help keep communities clean, we run the Neighborhood Vacant Lot Cleanup Program to reduce blight and keep areas clean and safe. We remove garbage and debris from vacant lots and areas around abandoned buildings. • Illegal Dumping Award Program: Complete an affidavit after witnessing illegal dumping. When the lawbreaker is fined, the witness is eligible for 50% of the fine that the City collects. If the lawbreaker challenges the ticket at the Office of Administrative Trials and Hearings (OATH) hearing, the witness must attend. • Illegal Dumping Tip Program: Anyone who tips off the City so that we can catch an illegal dumper in the act - is eligible for a reward of up to 50% of the fine collected. The tipster's identity remains confidential - so he or she won't have to appear at an **Environmental Control Board** hearing.

Collection Bins:

It's illegal to place collection bins on City property (or property maintained by the City); only government agencies can put collection bins on public sidewalks or roadways. Collection bins can be placed on private property if the property owner gives written authorization. Collection bin owners must register and provide annual reports to us. Improperly placed bins will be removed. Request removal of an illegal collection bin on public property.

Animals: Dead Animals

The City accepts reports of dead animals. The City will collect a carcass from a public area or street (or from private property - if the animal may have been rabid, was killed by a family pet or scratched or bit a person or pet.) You may also place a dead animal in a heavy-duty black plastic bag or double plastic bag and put it out on the day of garbage collection with a note taped to the bag stating "dead dog" or "dead cat", for example. Animals that may have been rabid should not be put in the garbage. The City cremates dead pets for a fee, though the ashes are not returned to the animal's owner. Call 311 to learn about disposing of an animal or pet on private property.

• Ten or more dead animals in one place.

Dogs in Public Spaces If you have a dog or are caring for one in a public space or an unfenced area next to a public space, you must follow certain rules. For example:

• Keep the animal restrained on a leash no longer than six feet.

• Remove the dog's feces from any public area; seal it in a tight bag or container, and dispose of it properly (though this does not apply to seeing-eye dogs).

• Don't allow your dog to bark excessively or be a nuisance to others.

Vehicles:

It is illegal to dispose of a vehicle improperly. Contact a junk dealer, auto wrecker or other disposal service and keep your receipt as proof of proper disposal. Help us keep the City clean by reporting derelict vehicles. If you see a vehicle that looks abandoned, https://www1.nyc. gov/nyc-resources/service/989/ abandoned-vehicle. If the vehicle has a license plate, you can inform your local police precinct and describe the vehicle's location and its make, type and color.

Get Involved:

Make a difference in your community by volunteering with us. There are many way to get involved including educating neighbors, managing your own litter basket or even getting your hands dirty.

Adopt-a-Basket Program

New Yorkers in busy areas sometimes fill litter baskets faster than our teams can empty them. It's better for our neighborhoods – and businesses – to help keep garbage from spilling onto sidewalks. New Yorkers, businesses and organizations can partner with us by adopting or sponsoring a litter basket! **Community Clean-Up**

We support local community groups and block associations in their volunteer efforts to keep their neighborhoods clean through local block and street area clean-ups. Free loans of clean-up tools and equipment (for example, brooms, shovels, etc.) are available. For information, call 311.

Clean Community Campaign

The NYC Emergency Management Operations Division maintains around-the-clock, on call staffing with over 60 personnel in three separate units: Watch Command, Field Response, and Urban Search & Rescue (US&R). In a snapshot of activities in 2018, division personnel supported the following activities:

• Watch Command monitored 3,661 incidents and sent 2,116 Notify NYC messages to 742,200 subscribers.

• Field Response supported 797 emergencies.

Division personnel supported 23 special events and attended 263 Community Board District Service Cabinet meetings.
US&R managed the NY-Task

Force 1 (NY-TF1) response to Hurricane Florence.

• Operations supported field and interagency coordination in 16 Emergency Operation Center (EOC) activations.
