This is an important update as of January 18, 2019 regarding the administration of SNAP benefits in New York City. Please note that the information below replaces any communication you might have received previously. Please disregard that communication.

The administration of the Supplemental Nutrition Assistance Program (SNAP) here in New York City in the context of the ongoing federal government shutdown. As you are aware, the administration of this program is managed by the New York City Department of Social Services (DSS).

Like you, DSS share deep concerns about the shutdown, and in particular, its impact on our city's most vulnerable residents, including those facing poverty and hunger. We have been carefully monitoring the situation and have been in close contact with our state and federal partners regarding the administration of SNAP benefits.

While the situation is fluid and information continues to arrive daily, please find a brief overview regarding the administration of SNAP benefits as of today below.

- Current SNAP recipients who are eligible to receive February benefits will be receiving this benefit.
- · For most New York City SNAP recipients, their February benefits will have posted to their accounts yesterday, Thursday, January 17, 2019.
- For the remainder of New York City SNAP recipients, their benefits will post on their regularly-scheduled benefits availability date.
- We advise recipients that if they see a largerthan-anticipated benefit amount posted to their accounts, this amount includes their February benefit. An additional benefit will not be available in the calendar month of February.
- We strongly encourage recipients to check their balances carefully and budget wisely.

In New York City, SNAP recipients can manage their account by downloading ACCESS HRA app or by going online to nvc.gov/accesshra and creating an account. If you have additional questions, you can call the **Human Resources Administration's (HRA)** InfoLine at 718-557-1399.

CIVILIAN COMPLAINT REVIEW BOARD (CCRB)

As you may know, the CCRB is a City Agency, independent from the New York Police Department, which investigates and mediates complaints against NYPD officers in a neutral and unbiased manner. The CCRB investigates allegations of excessive force, abuse of authority, discourtesy, and offensive language. The goal of their outreach efforts is to inform New York City residents about the agency. Every year they give presentations to educational institutions, libraries, and government and community organizations to offer information to community members, students, staff, and concerned parents about their agency's services. Through their interactive tabling events and workshops, they will provide the following

information:

- Structure and authority of the CCRB
- Civilian rights and responsibilities during police encounters such as "Stop & Frisk"

communities. Since the profiles were last published in 2015, the Health Department saw citywide improvements in several high priority areas, including declining rates of uninsured New Yorkers. teen births, sugary beverage consumption, smoking, new HIV diagnoses, and premature mortality.

To create a broader picture of neighborhood health, the agency also included new positive indicators that look at a community's wellness and social connections, such as on-time high school graduation, helpful neighbors, and homes with air conditioning. While the profiles show that there are many neighborhoods in very good health, significant health inequities persist among many New York City (NYC) neighborhoods, such as the 11-year gap in life expectancy between Upper East Side and Brownsville. Data show that 54 % of deaths in Brownsville could have been averted if it had the same income as the wealthiest neighborhoods.

CON EDISON ConEdison Smart Meters **Are Coming!**

What's a smart meter?

It's a digital meter that communicates between your residence or business and Con Edison through a secure wireless communication network.

What's so smart about it?

Think of a smart meter as your tool for more choice, convenience and control. Smart meters provide detailed information about your energy use so you can make informed choices about how and when you use

energy in your home or business. What is the difference between my current meter and a smart meter?

Traditional meters and automated meters record total energy consumption, which we collect on a monthly basis. Smart meters record and transmit your energy consumption regularly throughout the day (via a secure wireless network) and will help us create a smart grid for the New York City

Smart meters will give you access to detailed information about your daily energy use and customized information to help you conserve energy and save money. Smart meters will alert us immediately about problems, so we can get to work restoring power even faster. If you use solar energy, a smart meter will help us manage these

Do I still need to call Con Edison to report an outage?

renewable resources more

efficiently.

Yes. Smart meters will alert us about most outages in your neighborhood. But it is important that you continue to tell us about any problems you are having so that we can address them as quickly as possible.

How are you protecting my privacy?

We take cyber security seriously, so all information is transmitted through an encrypted network. Our cybersecurity measures follow standards for smart meters set by the National Institute of Standards and Technology and are comparable to those used by financial institutions. Smart meters do not collect. store, or transmit any personal information. Like a traditional meter, the only information collected is the amount of energy you use, and all your energy usage information is kept confidential by Con Edison and our vendors. Con Edison adheres to all New York State laws that regulate the use of personal information for business functions, such as billing and customer service.

How do smart meters work?

Smart meters communicate over a secure wireless communication network using the same type of extremely low-frequency radio signals that allow you to use your smart phone. listen to the radio. or watch TV. Your meter transmits data to a system of access points on utility poles, which send your usage information to us.

My smart meter was installed. Why can't I see my usage information?

It takes about two weeks for your detailed energy usage information to begin to show on your account dashboard.

What if I don't want a smart meter?

Residential customers can choose to not have a smart meter installed. By opting out you will miss out on all of the benefits, including the ability to save money and energy by managing your energy usage.

If you choose not to have a smart meter, Con Edison will be required to send a meter reader to vour home. You will be charged for this and may also incur the following additional charges:

We will attempt to read your meter on a bimonthly basis and you will be charged a monthly fee of \$9.50.

If you choose to have your smart meters taken out, you will be charged \$104.74 for each electric meter and \$93.81 for each gas meter.

Additionally, Con Edison has the right to install an automated meter-reading device or smart meter at our discretion if we are unable to obtain access on four consecutive bimonthly meter-reading dates. As an alternative, you may agree to install and maintain equipment necessary to provide for outdoor metering.

If you change your mind at a later date, we will install smart meters at no cost.

While the situation is fluid and information continues to arrive daily, please find a brief overview regarding the administration of SNAP benefits as of today below.

- Current SNAP recipients who are eligible to receive February benefits will be receiving this benefit.
- For most New York City SNAP recipients, their February benefits will have posted to their accounts yesterday, Thursday, January 17, 2019.
- For the remainder of New York City SNAP recipients, their benefits will post on their regularly-scheduled benefits availability date.
- We advise recipients that if they see a larger-than-anticipated benefit amount posted to their accounts, this amount includes their February benefit. An additional benefit will not be

available in the calendar month of February.

• We strongly encourage recipients to check their balances carefully and budget wisely. In New York City, SNAP recipients can manage their account by downloading ACCESS HRA app or by going online to nyc.gov/accesshra and creating an account.
