

YOUR GUIDE NEW YORK CITY CHARTER REVISION COMMISSION 2019

WHAT IS THE CHARTER? The New York City Charter is the City's constitution. It creates a framework for our government. The Charter controls how the City spends our tax dollars, how decisions are made about changes to our neighborhoods and the power of our elected officials. Nearly 30 years ago, a Charter Revision Commission overhauled the city's government. Now it's time for a fresh look

Significant chapters in the Charter outline the budget, planning, zoning, contracting, collective bargaining, and land use processes for the city. The Charter establishes key institutions- including City agencies such as the Department of Housing Preservation and Development, Sanitation, NYPD, 311, and more- and defines the authority and responsibilities of these agencies and elected officials.

WHAT CAN THE CHARTER DO? There are many areas that the Charter may regulate, but there are some limits. Here are a few examples:

NYC Emergency Management and the Health Department NYC Emergency Management and the Health Department urge New Yorkers to prepare for extreme cold.

Code Blue – A Code Blue Weather Emergency notice is issued when the temperature is forecast to drop to 32 degrees Fahrenheit or less between 4 p.m. and 8 a.m., including National Weather Service calculations for wind chill values. No one who is homeless and seeking shelter in NYC during a Code Blue will be denied. Should you see an individual who appears to be homeless and in need out in the cold, please call 311 and an outreach team will be dispatched to offer assistance. During Code

Blue Weather emergencies, experienced outreach teams work to connect homeless New Yorkers with the following resources:

Shelters: During a Code Blue, shelter is available systemwide to accommodate anyone who is reasonably believed to be homeless and is brought to a shelter by outreach teams. Accommodations are also available for walk-ins.

Drop-in centers: All drop-in centers are open 24-hours per day, including when Code Blue procedures are in effect, and will assist as many people as possible for the duration of the emergency. Drop-in staff and the dedicated outreach teams they work closely with each and every day can also make arrangements for homeless individuals at other citywide facilities.

Safe havens and

stabilization beds: Chronically homeless individuals may be transported directly to these low-threshold housing programs.

Street homeless outreach:

Teams will contact vulnerable individuals on their Code Blue Priority lists a minimum of once every four (4) hours beginning at 8 p.m. during Code Blue Alerts and once every two (2) hours beginning at 8 p.m. for Enhanced Code Blue Alerts to encourage them to accept services, including transportation to a shelter placement. DSS coordinates borough-level Code Blue efforts directly with partner City agencies, including but not limited to NYPD, DSNY, and the Parks Department.



Department of Consumer Affairs (DCA) Commissioner Lorelei Salas announced a lawsuit against Berkeley College – one of the largest for-profit colleges in New York State with approximately 4,000 students - alleging violations of the NYC **Consumer Protection Law** and local debt collection rules. DCA's lawsuit, filed in New York County Supreme Court, alleges numerous violations and wideranging consumer harm, and seeks to end Berkeley's unlawful practices and restore any illegal profits back to consumers. DCA encourages any consumer who believes they may have experienced any wrongdoing by Berkeley to contact the agency by calling 311, or by filing a complaint at nyc.gov/dca.



Complaint Review Board Civilian Complaint

Review Board – 4 Facts About the Right to Know Act – Changes in local law may affect your interactions with New York City Police Department (NYPD) officers. As of October 19, 2018, during certain frisks, searches, at sobriety checkpoints, and other encounters, officers should:

• Identify themselves by providing their name and other information such as their rank, command, and shield number.

• With some exceptions, explain the purpose of the interaction.

• Inform you of your right to say "no" when asking for your consent to search your person, property, vehicle or home.

• Offer a business card with the officer's information that explains how to comment or complain about an interaction with the NYPD. Civilians may request this business card in all interactions. If you feel your encounter with an NYPD officer did not follow these guidelines, file a complaint with the NYC Civilian Complaint Review Board: nyc.gov/ ccrbcomplaint or call at 1-800-341-2272

You can now request an Inspection History Report for your restaurant. The individualized report shows violations that have been cited two or more times during your restaurant's most recent inspections over a three year period. The report also includes the steps necessary to correct and to prevent each violation from reoccurring. Reports are available to all restaurants that have received two or more gradable inspections.

Please note: this information is based solely on sanitary violations cited during an inspection, regardless of the results of the OATH hearing. For more information, visit nyc.gov/health and search for inspection history report.

Food Service Establishment Consultative Inspections

The New York City Health Department offers consultative inspections for your food service establishment. This is an educational visit from a Public Health Inspector that will help you identify and solve food safety problems, protect customers' health and avoid common violations.

Please note: these inspections are educational, and you will NOT be graded or fines. Inspections are scheduled with the restaurant owner during the restaurant's regular business hours. SCA SCA Authority (SCA)

The New York City School Construction Authority (SCA) wishes to advise you that a construction project will begin on the building's Parapets, Roofs, Exterior Masonry, cafeteria Floor. The work also includes Flood Elimination.

Work will begin shortly. The work requires asbestos abatement. The workers in actual contact with the asbestos will be wearing protective suits and respirators. A licensed asbestos abatement contractor performs the asbestos removal work, when the school is unoccupied. An environmental consulting firm manages the abatement work. This work is done under a Department of Environmental Protection permit. Representatives of the environmental consulting firm will be on site for the duration of the project to ensure that the contractor adheres to all

the proper regulations. The consultant will also monitor the air in the immediate area to insure that the removal is taking place properly.

The entire project is expected to be completed in October, 2020. During the school year, regular project work will start after normal school hours and go until the time permitted by the Department of Building's issued After Hours Variance Permit.
