2) Acceptance of the Agenda

Barbara Jackson made a motion to accept the agenda. It was seconded by Tashawna Wade. All were in favor, so moved.

3) Acceptance of the Previous Meeting Minutes

Jo-Ena Bennett made a motion to accept the previous meeting minutes. It was seconded by James Steward. All were in favor, so moved.

4) Chairperson's Report

Mr. Camacho provided an overview of meetings and events he attended during the past month. He covered a wide range of meetings and activities, including concerns from board members that were removed from the board in regard to attendance. Some didn't hear. The information was emailed, emphasized by borough hall, and in the minutes.

He also asked about the public comment section from the December public hearing. Is there any feedback? Please let the office know. For the bylaw revision process, only one person has volunteered. Is there anyone else? If not, the Executive Board will review the information. He also received a letter from a business owner on Knickerbocker Avenue. He is not going to comment as a courtesy. The Deputy Inspector will address the concerns. We are not going to tolerate anyone disrespecting any of our seniors/leaders. If there are differences, we address them.

Council Member Sandy Nurse:

Spoke in support of Barbara Smith and the Precinct Community Council process. She greeted and thanked everyone for their support at the walkthrough with the DEP commissioner. Progress + next steps: Installed an experimental storm water basin and continue to follow up on how that's working.

There was also a DOT walkthrough on Broadway. She is pushing forward. She also extended an invitation to a town hall for the State of the District. She was happy to answer questions and emphasized the importance of working together as a united force—all the help to support the Board.

Assemblymember Maritza Davila:

Thanked everyone for the opportunity to rep the district. Happy New Year! She just had open heart surgery and is feeling much better. She has not stopped doing the job. Albany updates:

- She is no longer the PR Task Force Chair. She held the role for four years during the pandemic, the earthquakes.
- She's now the Social Services Chair.
- The community has come a long way since the 60s to the present. We care about people.
- CB4 is a board to be reckoned with—all of you. An attack on us is an attack on all of us. It's unnecessary and unwarranted and I have a problem with it. Barbara Smith has been a friend for decades. And Anita Haines—we grew up together. It's really insulting and disrespectful. Someone that's vulnerable—to attack them asking them to resign. The people that elected her have the right.
- We have the first female CO in 83 Precinct.
- Avenue of Puerto Rico on Graham Avenue DOT messed up. Local elected officials were on it. Do not disrespect the culture. Council Member Jennifer Gutierrez is taking care of the matter.

83rd Precinct Report

Captain Sean Claxon, Executive Officer, greeted everyone and extended greetings from Deputy Inspector Alexandra Sarubbi. He acknowledged the Chairperson, Mr. Camacho, who is also a community partner. His steadfast dedication to the board and the partnership does not go unnoticed.

The end of December marks the fifth consecutive decrease in crime citywide. 7th consecutive week for a decrease in citywide shooting incidents. Down 17.5% citywide. Many of you have heard about transit crime, NYPD has an increased presence. It's down 17.8% over the last twenty-eight days.

In reference to the 83 Precinct, for 2022.

Up in total index crimes about 20% in every major crime category excluding murder, which has seen a decrease. Shooting incidents are down. Violence has gone down

tremendously. Arrests are up. He cannot praise the detective squad enough. They solve really tough crimes. They are the best. Gun arrests are up. Criminal summonses are up.

The prevailing condition is robbery in Sectors David and Boy. They have been working with the 104 Precinct. There's more work to do. The strategies are paying dividends.

Traffic safety – down in collisions, up in pedestrian collisions, up in DWI and suspended license requests. Up 99% in total hazardous movers. Update on complaints received in reference to trucks on Bushwick Avenue during overnight hours. They changed the highway safety routine three times for several off-route initiatives overnight hours. November 17th and December 14th adjusted schedules. November 14th another date they issued multiple moving violations for trucks.

Personnel – 22 new officers. They will alleviate the strain from being understaffed. The commander has made some changes. Sgt. Thomas Billock, the new DV sergeant, Sgt. Christopher Ascazubi will be the new NCO sergeant, and Sgt. Dawn Ganci will be the new public safety sergeant by the end of this week.

Barbara Jackson referenced 12/9/2022 she was coming home with a board member. There was a car parked in the middle of the road at Bushwick and Bleecker. They called the precinct before 11pm. The car was just sitting there, no one was in there. She called the precinct and the female office never identified herself. They were told to call 311 since it was not an emergency, which they did. A patrol car happened to stop next to them at the light. They attempted to speak with them, and they did not respond. The number on the car was 3047 or 4047. Officers need to identify themselves. This was bad. It's dangerous.

Captain Claxon apologized for what happened, noting the importance of the quality of their service to the community. He thanked her for providing the info. He's going to look into and get back to the board.

Felix Ceballos congratulated Captain Claxon and the 83 Precinct. When we hear that shootings are going down, that means a lot for our community. Also, when we hear that more officers are coming to the precinct that's good news because that means more support for our community.
