Brooklyn Community Board 4 Public Hearing and Regular Meeting Minutes Wednesday, October 16, 2024 6pm

Meeting Start: 6:05pm

Celeste called the meeting to order and announced the first public hearing item.

Public Hearing:

- 1) NYC Department of Sanitation Residential Containerization Update Marissa Yanni, Community Affairs representative for the Department of Sanitation, provided a summary of upcoming changes to residential containerization:
 - Starting November 12th, 2024, buildings with 1-9 residential units must containerize their trash. Existing bins with lids are acceptable. NYC official bins are not required until June 1st, 2026.
 - Fines for businesses with repeat sidewalk obstruction violations will increase: second offense from \$100 to \$300, third and subsequent offenses to \$500.

Q&A with the Board and Public:

- Clarification on bin requirement dates and types.
- Concerns about stolen bins no current city program for replacement.
- Handling of bulk and construction waste.
- No limit on the number of bins per property.
- Issues with bins ordered in July not being received advised to check with Otto, the bin supplier.
- Clarification on responsibility for receptacles for mixed-use buildings.
- Composting requirements mandatory for yard waste starting January 2025, food scraps in Spring 2025.
- Inquiry about recycling old bins.
- 2) NYC Campaign Finance Board Ballot Proposals Presentation Isabelle Chandler, Intergovernmental Affairs Manager at the CFB, presented information on the 2024 ballot

proposals. Key dates: early voting starts October 26th, voter registration deadline October 26th, absentee ballot request deadline October 26th, election day November 5th.

Q&A with the Board and Public:

- Clarification on Proposal 2 and its implications for DSNY enforcement.
- Discussion on the mayor's power and control over DSNY enforcement.
- Concerns about the proposals being a power grab by the mayor.
- Confirmation that voting will be a simple yes or no for each proposal.

3) CB4 Annual Budget Hearing – an overview of proposed capital and expense budget priorities for Bushwick.

<u>Civic, Public Safety, Religious:</u> Surveillance cameras at Bushwick Playground, additional uniform officers, more firefighters/EMS workers.

District Office: More community board staff.

<u>Economic Development:</u> Investment in infrastructure along Broadway, Myrtle, Knickerbocker, and Wyckoff Avenues; support for merchants on Broadway; public investment in Broadway, Myrtle, and Wyckoff Avenues.

<u>Health, Human Services, Senior Citizens, Veterans:</u> Address mental health issues, address rat and mosquito populations, expand street outreach for the homeless, enhance senior center programs.

<u>Housing and Land Use:</u> More housing for low-income households, expand housing inspections and code enforcement, hire additional building inspectors.

- Discussion on zoning concerns, affordability, homeowner programs, and the need for youth recreation facilities.
- Request for the city to evaluate infrastructure capacity.

Environmental Protection, Transportation, Sanitation: Reconstruct Broadway, Myrtle, and Wyckoff Avenues; elevator installations at DeKalb and Wilson Avenue subway stations; inspect sewer on Wilson Avenue; clean catch basins; increase graffiti removal and cleaning; more frequent garbage/recycling pickup for schools; enforce K9 waste laws; educate residents about recycling/composting; fund public drop-off sites for electronics, textiles, etc.

Concern about ponding water and ice conditions.

<u>Parks and Recreation:</u> Upgrade/reconstruct comfort station in Maria Hernandez Park; new/expanded playground in Irving Square Park; enhance park safety with more Parks

Enforcement Patrol staff; forestry services; improve trash removal. Recommendation for stronger fencing around parks.

- Note about maintenance and operations staff request
- Youth and Education: Create/renovate/upgrade public libraries (DeKalb and Washington Irving branches); expand after-school programs.
- 4) NYC Parks Irving Square Park Proposed Dog Run Presentation Jim Morris (Brooklyn Parks) and designers Kim and David presented the schematic design for a new dog run in Irving Square Park, funded by Council Member Sandy Nurse.
 - Project Timeline: Design phase (current), procurement, construction (estimated 2026).
 - Dog run location: Knickerbocker and Hart Street corner.
 - Reasons for location choice: Grade change and tree preservation concerns at the current informal dog run area
 - Features: Separate small dog and all dog areas, entrance on sidewalk side away from playground, drinking fountains, hose bibs, seating, lighting, double fencing on sidewalk side, 5-foot fence along playground side, planting buffer, restoration of the southern lawn area.

Q&A with the Board and Public:

- Question about the location choice.
- Concerns about maintenance and park hours.
- Question about the cost and impact on children's amenities. \$4 million has been allocated for playground renovations.
- Support from Irving Square Puppers (community dog group) and Friends of Irving Square Park.
- Concerns about fence height.
- Clarification on fence heights and design.
- Question about time limits for dog run use no time limits.

<u>83rd Precinct Report</u> - Captain David Poggioli, Commanding Officer Captain Poggioli reported on crime statistics (overall decrease), highlighted efforts to address smoke shops and moped confiscations, and discussed plans for the holiday season (retail theft and package deliveries). A new Community Affairs Officer for the 83rd Precinct was also introduced.

5) District Manager's Report

Ms. León began her report with acknowledgements of Indigenous Peoples' Day and various awareness months (Breast Cancer Awareness, Emotional Wellness, and World Bullying Prevention). She then highlighted the current focus on preparing the annual Statement of Community District Needs and Budget Requests. She announced the addition of 17 new public members to board committees, reminding attendees that these members contribute to quorum and recommendations but do not have voting privileges. Ms. León encouraged those interested in learning more about public member participation to consult the board's website or contact the district office.

She emphasized the importance of recognizing the board's power to influence change by quoting Alice Walker: "The most common way people give up their power is by thinking they don't have any." This served as a transition to discussing her recent activities, which included: participating in a meeting with the Need Landmarks Coalition, advocating for increased preservation efforts in underserved neighborhoods; ongoing engagement with Riseboro's monthly Property Management meetings, aiming to address tenant concerns and hold Riseboro accountable; and continued involvement with the Future of

Community Boards Working Group and the CB Term Limit project, with the goal of securing support from the Borough President and potentially the Citywide President. She promised to share updates on these projects as they progress.
