Brooklyn Community Board 4 Public Hearing and Regular Meeting Minutes Wednesday, February 19, 2025 6pm

Celeste called the meeting to order and announced the first public hearing item.

Public Hearing:

1) Deputy Inspector David Poggioli, Commanding Officer, NYPD – delivered a monthly report on behalf of the 83rd Precinct

Deputy Inspector Poggioli introduced the new Special Operations Lieutenant, Freddy Cantio, and Neighborhood Coordination Officers (NCOs) Officer Padron and another officer whose name was unclear in the transcript. He acknowledged Community Affairs Officers Kich and Lopez for organizing a youth engagement event at the Salvation Army. He also addressed a recent domestic violence-motivated homicide on Jefferson Avenue and highlighted the services offered by the precinct's domestic violence unit, emphasizing their focus on stabilizing families. He reported a 38% decrease in overall index crime year-to-date in 2025, furthering the 13.8% decrease from 2024, with reductions in robberies, burglaries, grand larcenies, and grand larceny auto. He attributed this to the efforts of the officers. However, he noted an increase in auto break-ins, particularly in Sector Adam (Halsey Street to Eastern Parkway, Broadway to Evergreen), often involving visible property left in vehicles. He urged residents to secure their belongings and not leave valuables visible in their cars.

Deputy Inspector Poggioli addressed a recent increase in stolen vehicles, often due to vehicles being left running unattended, and advised residents against this practice. He addressed a structure fire at 1155 Halsey Street, a church located between Central and Wilson Avenues, which resulted in the collapse of a wall into the adjacent building at 1159 Halsey Street and the displacement of five residents. No injuries were reported. He noted that the fire hydrants were accessible, unlike in a previous incident where blocked hydrants hindered firefighting efforts, and thanked the community for reporting blocked hydrants via 311. He addressed concerns about open fire hydrants during the

summer, acknowledging it as a common occurrence in Bushwick. He also reiterated the availability of a downloadable program to update the internal technology of Hyundai and Kia vehicles to prevent theft using USB chargers.

• Perris Straughter, Director, Brian Paul, Deputy Director, and Tim Anderson, Borough Planner, NYC Council Land Use – providing an informational presentation of the City of Yes for Housing Opportunity modifications.

Perris Straughter, Director of the NYC Council Land Use Division, along with Brian Paul (Deputy Director) and Tim Anderson (Borough Planner), presented on the City of Yes for Housing Opportunity modifications. They were joined by Veronica from DCP. The presentation began with a review of the rationale behind the citywide zoning text amendments, which aimed to address the housing crisis by increasing housing production, particularly affordable housing, and promoting more equitable distribution across the city. They displayed a map showing housing production over the last 10 years, highlighting disparities between community districts. They explained the division of the city into high-density and low-density zones, with Community Board 4 primarily falling within the high-density category due to its predominantly R6 zoning. This zoning already permits significant development, primarily market-rate, due to the lack of city-owned sites and the previous 421a tax abatement program, which incentivized affordable housing at 130% AMI (considered market-rate in Bushwick). The presentation then focused on the Universal Affordability Preference (UAP) concept, which grants increased density in exchange for affordable housing at 60% AMI (approximately \$67,000-\$85,000 annual income depending on household size). Several scenarios were presented, illustrating the impact of City of Yes on building height and affordability. For example, a typical four-story market-rate building could now become five stories, with the additional floor designated as affordable housing. In the case of 100% affordable developments with subsidies, building height could increase to eight stories.

The presenters acknowledged concerns about the increased height, particularly in R6 and R71 zones with narrow streets. They explained that the City Council had modified the original proposal, reducing the allowable height increase by one story. They also addressed concerns about the affordability level (60% AMI), explaining that for buildings with 50 units or more, 5% of the units must be affordable at 40% AMI (approximately \$45,000-\$60,000 annual income). The issue of enforcement was also discussed, with the presenters explaining that zoning regulations are enforced by the Department of Buildings, and the City Council has secured increased staffing for inspections. The presentation then moved to Accessory Dwelling Units (ADUs), explaining the regulations and limitations for detached one- and two-family homes. ADUs are allowed as separate structures in rear yards, up to 800 square feet, with restrictions on lot coverage (33%) and proximity to neighboring properties (5 feet). The presenters highlighted City Council modifications to the ADU regulations, including the requirement for homeowner occupancy and restrictions on ADU construction in flood zones. A map illustrating areas

eligible for ADUs, based on lot size, was shared. The issue of parking requirements was also addressed. The City Council created three zones with varying approaches: Zone 1 (elimination of parking requirements), Zone 2 (substantial reduction, applying to CB4), and Zone 3 (maintaining existing requirements). In CB4 (Zone 2), large buildings with 60 or more units still have parking requirements, but they are reduced by half (25% of units). Mid-size buildings (20-40 units) no longer require parking. Finally, the presenters confirmed that the proposed changes to dwelling unit factor (average apartment size), which would have allowed for smaller apartments, were removed by the City Council for Community Board 4. Council Member Sandy Nurse joined the meeting virtually, expressing confidence in the modifications secured by the City Council and highlighting the City for All package as a source of community benefits.
