Here's what you can and can't bring to food scrap drop-off sites:

#### Accepted Items

- Fruit and vegetable scraps
- Coffee grounds, filters, and paper tea
- Bread and grains
- Eggshells
- Nutshells
- Corncobs
- Food-soiled paper towels and napkins
- Shredded newspaper
- Sawdust and wood shavings from untreated wood
- Stale beans, flour, and spices
- Cut or dried flowers
- · Houseplants and potting soil
- Feathers

#### **Don't Bring**

- · Meat or fish scraps
- Cheese or dairy products
- Fats, grease, oil, or oily foods
- Pet food
- Pet feces
- Kitty litter
- Colored or glossy paper
- Sawdust made from pressure-treated plywood or lumber
- · Coal or charcoal ashes
- Non-compostable materials like plastic, metals, or glass
- Diseased or insect-infested houseplants and soil
- Biodegradable or compostable plastics

#### **DEPARTMENT OF HOMELESS SERVICES**

**Homeless Outreach Population Estimate (HOPE)** 

On Monday, January 27, 2020, the Department of Homeless Services (DHS) will conduct its Homeless Outreach Population Estimate (HOPE), an annual point-in-time survey of New Yorkers sleeping unsheltered on the streets that is required by the US Department of Housing and Urban Development. The HOPE Survey provides valuable information that helps ensure our HOME-STAT outreach teams are providing resources to this vulnerable population in their ongoing year-round outreach efforts.

That day is coming soon, and I am once again asking for your help to canvass parks, subways, and other public spaces to estimate the number of people who are sleeping on the street on

one of the coldest nights of the year. HOPE can only be a success with the assistance of our NYC agency colleagues, like you. Volunteers are needed from approximately 10:00 p.m. to 4:00 a.m. on the night of the 27th. Just one night of your time will help us collect critical information to help people move from the streets and into a safe, stable environment. During the past two years, through our HOME-STAT street outreach program, we have helped more than 2,200 people come off the streets and in to transitional programs or permanent housing.

As we work to address street homelessness across the city, one person at a time, this is a unique opportunity to participate in an extraordinary citywide effort. If you have volunteered before, I encourage you to sign up again. If you have yet to experience how truly rewarding a night of HOPE can be, I invite you to join us for the first time.

#### **Lifeguards Wanted for Summer 2020!**

Try out now to become an NYC lifeguard for Summer 2020! NYC Parks is starting the search for new candidates with strong swimming skills to participate in our free lifeguard training program for the upcoming summer season. Qualifying tests to become a New York City lifeguard begin this week on December 7, 2019 and run through mid-January! Testing locations can be found throughout the five boroughs. Find a qualifying test location near you. Please check back periodically as additional dates may be added.

For those who qualify, training begins in January. First-year lifequards earn a minimum of \$15.00 an hour. Most lifeguards work 48 hours each week, for a weekly salary of up to \$800. New York City's 8 beaches are open from Memorial Day

weekend through the week after Labor Day, and the 53 outdoor pools are open from late June through the week after Labor Day. There is no need for an appointment; just be sure to bring a bathing suit, towel and lock for a locker.

#### **NYC LANDMARKS PRESERVATION COMMISSION**

#### **LPC Launches New Permit Application Guide And** Forms To Make It Easier To **Apply For And More Quickly Obtain A Permit**

The enhanced LPC Permit Guidebook and application forms are designed to help applicants understand the Commission's processes and rules and the information needed to submit a complete application so they can get their permits as quickly as possible.

The New York City Landmarks Preservation Commission (LPC) has launched an updated edition of the Permit Application Guide, now named the LPC Permit Guidebook: How to Get Staff-Level Approvals and new application forms to make it easier for property owners and tenants looking to do work on landmark properties. The enhanced guidebook and application forms are designed to help applicants understand the Commission's processes and rules and the information needed to submit a complete application so they can get their permits as quickly as possible.

The LPC Permit Guidebook is meant to provide applicants with a clear explanation of the Commission's processes and rules for all of the most common work types, and what is required to get staff approval — the fastest way to get a permit. It breaks down the application process into simple steps, outlines and illustrates the rules and criteria for staff-level-approval, and identifies what materials need to be included in the initial

application submission so that staff can quickly review and issue the permit.

The updated guidebook, which reflect the new rules and amendments adopted by the Commission in January 2019, focuses on the most common types of work that require a permit, such as window replacement, restoration and additions. It includes new quidance on barrier-free access in order to ensure buildings are accessible, and, for the first time, it also addresses sustainability, resiliency and flood-proofing measures in historic buildings so they may best adapt to the impacts of climate change. The guidebook can be downloaded as a comprehensive document or by chapter. The revision and design of the guidebook were supported by a grant from the New York State Office of Parks, Recreation, and Historic Preservation.

### **About the Landmarks Preservation Commission**

The Landmarks Preservation Commission is the mayoral agency responsible for protecting and preserving New York City's architecturally, historically and culturally significant buildings and sites. Since its creation in 1965, LPC has granted landmark status to more than 37,000 buildings and sites, including 1,435 individual landmarks, 120 interior landmarks, 11 scenic landmarks, and 149 historic districts and extensions in all five boroughs. #### **NYC EMERGENCY MANAGEMENT DEPT** Winter Weather Planning

New York City winters, which often bring extreme cold, heavy snow, ice, sleet, and freezing rain, can pose serious hazards. It is important to prepare for winter weather-related dangers. There are several steps you can take to stay safe before, during, and after winter storms including:

- 1. Make sure your household disaster plan is ready and all members of your household are familiar with how to contact one another in an emergency.
- 2. Winterize your Go Bag by adding a blanket, warm socks and gloves.
- 3. Your emergency supply kit should be fully stocked to allow

you to sustain yourself for up to seven days without power, or in the event, you are unable to travel far from home.

4. You may wish to include additional items such as extra blankets, additional warm clothing, and a battery-operated radio to monitor weather conditions during a storm.

#### **NYC DEPARTMENT OF BUILDINGS**

#### Local Law 196

As of Sunday, December 1, 2019, Local Law 196 site safety training requirements for all construction sites that require a Site Safety Plan are now in effect. Workers are required to have OSHA 30 cards or temporary SST cards as proof that they have completed the required 30 hours of training, and supervisors must have full SST cards certifying they have completed the mandated 62 hours of training. Contractors and property owners are on notice: DOB inspectors recently conducted site-safety enforcement inspections in a sweep of 6,000 active construction sites citywide, and these unannounced inspections will be conducted on a regular basis in the coming year.

Site Safety Training (SST) NOTICE: Beginning October 14, 2019, general contractors must post worker safety information signs at construction sites where site safety training is required. The signs must:

- contain specific information about required worker safety training, including all site safety training deadlines and the number of required training hours, and the information must
- be in all the languages used by workers to communicate at the construction site. In addition, the signs must
- be clearly visible to workers

and must be posted at the construction site as follows:

- Sites with construction fencing must post a sign at each egress point on the inside of the construction fencing, including vehicle delivery fence gates and existing loading docks.
- Sites without construction fencing must post a sign at each egress point within the controlled access zone where construction is taking place and at each existing loading dock or location being used for construction delivery or access.

To comply with the new requirements, the posted sign must:

- be 44 inches wide and 30 inches high;
- have letters at least 1 inch (25 mm) high;
- have white letters on a blue background; and
- be made of a durable and weatherproof material such as vinyl, plastic, or aluminum that is flame retardant.

#### Special Waste Drop-Off **Locations**

Special Waste Drop-Off Sites are locations across the city where residents can drop-off certain harmful products. The sites are open from 10 AM to 5 PM every Saturday and the last Friday of the month. Sites are closed on legal holidays and may be closed during severe weather.

Brooklyn: New Location: 459 North Henry Street in Greenpoint What to Bring

The following items are accepted at DSNY Special Waste Drop-Off Sites:

- · Batteries, including automotive, rechargeable (such as small sealed lead acid batteries, Li-Ion, Ni-MH, Ni-ZN, Ni-Cd) and singleuse (such as alkaline and lithium primary). Follow instructions below to prepare batteries before arrival.
- Motor oil and transmission fluid (up to 10 quarts per visit)
- Motor oil filters (up to two filters per visit)

- Fluorescent light bulbs & CFLs
- Latex paint (up to five gallons per visit)
- Mercury-containing devices (up to two per visit)
- Passenger car tires (up to four per visit)
- Electronics (covered by the disposal ban)

#### Rules & Procedures

DSNY drop-off sites are only for non-commercial materials from NYC residents. Anyone with a commercial license plate will not be allowed to enter the site. When you arrive at the drop-off site, you'll be required to show a valid NYS driver's license and vehicle registration. If you aren't arriving by car, you can provide a picture ID and proof of residency, such as a phone or utility bill. The drop-off location may not be immediately visible. If you have trouble finding the location, ask a DSNY garage foreman or supervisor at the site. DSNY officials will be there to instruct you, but the sites are do-ityourself style. Wearing casual clothes and work gloves is strongly recommended.

#### **Special Instructions for Batteries**

To prevent the risk of fire, individually bag each non-alkaline battery or use CLEAR tape to cover the terminals. Do not use opaque tape and do not bag or tape alkaline batteries. Important Transparency Tool: ZAP to Allow Community Boards, Borough Presidents and City Council to Instantly Post Public Hearings Dates & Recommendations related to **ULURP** 

The newest feature of DCP's Zoning Application Portal (ZAP) means hearing dates and recommendations will be posted in a central location for all to see NEW YORK - Department of City Planning (DCP) Director Marisa Lago announced an important public transparency update to ZAP, DCP's Zoning Application Portal. Now, Community Boards, Borough Presidents and Borough Boards will be able to quickly and effortlessly calendar public hearings for land use items digitally, making the process much faster and more accessible than ever before. Community Boards and Borough Presidents will also be able to instantly upload their recommendations for land use applications.

The scheduling feature will be available for City Council hearings as well in the near future, making ZAP a true one-stop-shop for the City's Uniform Land Use Review Procedure (ULURP).

Through this new system, Community Boards, Borough Presidents or the City Council fill out a simple online form with the details of their upcoming public hearing for a land use proposal. As soon as they submit it, the details are instantly posted both on the public ZAP portal as well as sent to the City Record. Community Boards and Borough Presidents can also use the system to send their recommendations on land use items to the City Planning Commission - making them immediately available to the public as well.

These new features will smooth out and speed up the process of calendaring hearings and filing recommendations by placing all the details and events for any land use proposal on one website.

ZAP - and many other digital tools created by the agency for the public - is part of DCP's commitment toward a greener, paperless process. DCP's other digital webtools are listed here. More broadly, the ZAP platform offers easy searches for land use applications, including pending applications, with a variety of useful filters. It includes direct links to DCP tools and other City databases by project address to ZoLa (DCP's Zoning & Land Use map), the Department of Buildings' BISWeb and the Department of Finance's ACRIS

To make the new system as easy as possible, DCP has held outreach events since October and will continue to offer one-onone trainings to all 59 Community Boards in New York City.
