2. Revise plans based on the rule and below comments that includes but not limited to the following:

I. All submissions for service equipment totaling 1000 KVA or more or above 600 Volts must include the following plans/drawings: -

1 One line diagram  
 2 Plan view / service equipment room layout

Submissions must be in accordance with, and include the following requirements:                      a. A one-line diagram must be submitted indicating the service equipment and the distribution equipment up to the 2nd level overcurrent protection, showing all overcurrent devices with their ampere rating, make and type, interrupting current ratings and bus and wire sizes. Frame and trip sizes for circuit breakers must be indicated.

b. Clearly show the point of entry in the one-line plan.  
 c. Bubble new work versus existing.  
 d. The location of the main switchboard and/or distribution panels in relation to the service equipment must be shown.  
 e. The location of the electric service room with respect to the surrounding areas must be shown.  
 f. The means of egress from the switchboard room and where it leads to must be shown. The legal exit(s) to which egress door(s) lead must also be shown  
 g. If the existing service equipment and/or point of service entrance is to be discontinued, the drawings must so state.  
 h. All voltages must be clearly shown on the drawings, which must include voltages pertaining to all of the equipment overcurrent protection up to and including the second level protection.  
 i.  
 j. A statement confirming that all fuses and/or circuit breakers have been coordinated for selective short circuit overcurrent protection must be on the drawing.

II. A selective coordination report prepared by a professional engineer must be filed with the Department prior to electrical inspection. Such engineer may be different from the applicant.

The asbestos compliance document shall be submitted along with the electrical submission in order to obtain an approval. In case the job was submitted and is missing the asbestos compliance document then, the job will be in a pending status until required document will be submitted.

If the project/new work area is not an asbestos project; the accepted documents will be as follow:

1. ACP5 Form includes the area of new work to be submitted prior the approval or;  
 2. ACP21 Form includes the area of new work to be submitted prior the approval or;  
 3. Applicant to certify on the plans that the building is new, a wholly new building wing, floor, etc. or in an existing building or building wing, floor etc. that was wholly constructed pursuant to plans submitted for approval on or after April 1, 1987. In case the building is new building:  
 ? A note can be added in the EPR submittal/plan (signed and sealed by P.E/RA) stating, “The proposed electrical work is exempt from any filing of ACP forms because such work is occurring in a new building, wholly new building wing, floor, etc. or in an existing building or building wing, floor etc. that was wholly constructed pursuant to plans submitted for approval on or after April 1, 1987.” or  
 ? A copy of the PW1(if available) to show the building is new.
