**Description:** Split-system air conditioners consisting of outdoor condensing section matched with indoor evaporator units as described. The system consists of a hermetically sealed compressor, air-cooled condenser with blower, evaporator coil, and safety controls. **Terms and conditions:** The above-described air-conditioning units are accepted under the following conditions:

- **1.** Units shall use only Refrigerant R-22.
- 2. If utilized for residence heating, the circulatory air system shall have (a) one register or grille without a damper, or (b) dampers and shutter within the system that shall be constructed or controlled so as to prevent closure beyond 80 percent of the gross duct area at all times.
- **3.** All shipments and deliveries of such equipment shall be provided with a metal tag, suitably placed, certifying that the equipment shipped or delivered is equivalent to that tested and acceptable for use, as provided for in Section 27-131 of the Building Code.
- **4.** A tag must be permanently affixed to the equipment stating that if installed in New York City within 100 feet of any dwelling window, there shall be compliance with all provisions of Section 27-770, as to maximum sound levels permitted for exterior mechanical equipment.
- **5.** Approval of all electrical equipment, apparatus, materials, and devices shall be obtained form the Department's Electrical Advisory Board before installation.
- **6.** Units shall be used in compliance with the Energy Conservation Construction Code of New York State.
