Soldered or brazed type joints are provided in the refrigerant line to relieve excessive pressure. Units, wit model numbers, and cooling capacities, are listed below:

Recommendation - That the above described split system air conditioning units, be accepted, when utilizing Refrigerant R-22, under the following conditions:

- All equipment shall be furnished with a permanently affixed metal tag stating that if installed in New York City within 100 feet of any dwelling unit window, there shall be compliance with all provisions of Section 27-770, as to maximum sound levels permitted for exterior mechanical equipment.
- 2. All shipments and deliveries of such equipment shall be accompanied by a certificate or label certifying that the equipment shipped or delivered are equivalent to those tested and acceptable for use, as provided for in Section 27-131 of the Building Code.
- 3. Approval of all electrical equipment, apparatus, materials and devices shall be obtained from the Bureau of Electrical Control before installation.
