- Description Self contained commercial refrigerated showcases, as tabulated below. These are display units with or without glass enclosure. They do not employ a defrost system. Units comprise on/off switches, refrigeration controllers, condensing units, junction boxes, and evaporators. Condensing units are equipped with compressors, starting capacitors, condensers, interior lighting and receivers.

Following models have been evaluated and found to be in compliance with the Standard for Commercial Refrigerators and Freezers, UL 471.

PRODUCT DESCRIPTION:

The product covered by this report is a series of open front refrigerators used for display of merchandize in food markets and the like. The refrigerators are remote condenser or self-contained. The latter are built around a compressor and associated components or around a condensing unit assembly. The product is for use indoors.

The self contained models may be permanently connected to the supply source or they may be provided with a 120 volt, 20 or 30 amp power supply cord for connection to the supply source.

The remote condenser models are permanently connected only.

Dome Pizza Table, Model PTD; followed by -4, -5, -6, -7, -8, -9, -10, -11, or -12, may be followed by EW, IW, R, RRS, DRS or CT.

Flower Table, Model No. FTM, followed by 4, 5, 6, 7, 8, 9, 10, 11 or 12, may be followed by EW, IW or R.

Bent Double Curve, Model No. BDC, followed by 4, 5, 6, 7, 8, 9, 10, 11 or 12, followed by R, D, SS, SR, SD, CS, CR, or CD.

Bakery Lift Front, Model No: BLF, followed by 4, 5, 6, 7, 8, 9, 10, 11 or 12, followed by R, D, SS, SR, SD, CS, CR, or CD.

Display Lift Front, Model No. DLF, followed by 4, 5, 6, 7, 8, 9, 10, 11 or 12, followed by R, D, SS, SR, SD, CS, CR, or CD

Recommendation - That the above described self contained refrigerated show cases, be accepted, under the following conditions:

- 1. Units shall be installed in accordance with manufacturer's instructions and New York City Electrical Code requirements.
- 2. Adequate supply of fresh air shall be provided into room or space enclosing equipment for ventilation.
- 3. The installation shall not interfere with accessibility for operation and servicing.
- 4. No flammable material (except electrical insulation) shall be located in the machine or wiring compartments unless specified.
- 5. All shipments and deliveries of such equipment shall be provided with a metal tag, suitably placed, certifying that the equipment shipped or delivered is equivalent to that tested and acceptable for use, as provided for in Section 27-131 of the Building Code.
- 6. Approval of all electrical equipment, apparatus, materials and devices shall be obtained from the Bureau of Electrical Control before installation.
