Overview

This step-by-step guide will provide applicants with a systematic understanding of how to request Renewal or Reissue of an Elevator License in DOB NOW: *Licensing*.

This step-by-step guide will explain and visually show an applicant how to navigate the Licensing Dashboard.

Requirements

- Elevator License renewals or reissues can only be created after the initial license has been issued.
- They will need to be requested using an approved License Qualification Application (LQA) number.

SYSTEM GUIDELINES

- 1. Fields with a red asterisk (*) are required and must be completed.
- 2. Grayed-out fields are Read-Only or are auto-populated by the system.
- Depending on the size of your screen or browser you may have to use the scroll bar to view more options or full fields.

In order to renew an Elevator License, follow the steps below.

Elevator License Reissue

If a holder of an existing Elevator License loses their license or their license is stolen, they may request a reissue of their existing license.
