NEW Electrical Inspection Request Types

To improve scheduling of electrical inspections, starting January 6, 2023, DOB NOW: *Inspections* will list new inspection types for electrical jobs.

The inspection types in **DOB NOW:** *Inspections* is being changed from a list based on the number of floors to be inspected to a list based on the proposed use of the space where the electrical scope of work was performed. The new list is:

- Dwelling 1-2 Family
- Dwelling 3-4 Family
- Multi-Dwelling 5 Family and Above
- Commercial Buildings
- Mixed Use Buildings
- Hotel
- Elevator
- Sustainable Energy
- Field Sign
- Shop Sign
