

The Department of Buildings is requesting applications from members of the construction, real estate, labor, architectural, and engineering community, and other interested stakeholders, to serve on the NYC Energy Conservation Code Advisory Committees that will help develop and review amendments to the New York City Energy Conservation Code as part of the mandated code revision cycle. Applications will be accepted through **May 20th 2025**.

BACKGROUND

The New York City Energy Conservation Code (NYCECC) is comprised of the New York State Energy Conservation Construction Code (NYSECCC) with NYC-specific amendments that are more stringent than the NYSECCC.

Periodically, the NYSECCC is updated based upon the latest version of the International Code Council Codes (I-Codes). New York City must then review the NYSECCC, and if necessary, propose amendments for New York City.

Additionally, New York City, pursuant to Local Law 32 of 2018, must propose amendments which bring the NYCECC in line with the NYStretch Code published by the New York State Energy Research and Development Authority (NYSERDA). To this end, the Department is organizing Advisory Committees to review updates to the 2024 International Energy Conservation Code (IECC), ASHRAE 90.1- 2022, the NYSECCC, and the NYSERDA's NYStretch Code 2025, as well as to determine whether additional changes should be incorporated into the NYCECC. The Department expects to begin submitting the proposed Code Revisions to the New York City Council in the Summer of 2025.

TIME COMMITMENT

It is anticipated that the Advisory Committees will meet once a month for approximately two to three months. Committee members are expected to be available to attend all meetings of their committee. All committee work is on a volunteer basis. The Department cannot provide any compensation for work or travel.

COMMITTEE MEMBERSHIP

Committee participants should be experts in the subject matters regulated by the NYCECC. Members may represent either a specific organization or be appointed to act on their own behalf due to their personal expertise in the subject matter.

Organizations whose interest is primarily in the areas of real estate, labor, policy, or economics, and who wish to have representation on an advisory committee, must provide a technical expert to represent their organization. The Department will not consider applications for individuals who do not possess technical proficiency in regards to the material assigned to the committee.

COMMITTEE STRUCTURE

Space on the advisory committees identified below is limited. The Department seeks to appoint volunteers to the committees to ensure a balanced representation of stakeholders.
