## Cranes Filings (Phase Two) to Launch in DOB NOW: Build

Beginning Tuesday, July 7, 2020, all new Crane Notice (CN), Tower Crane Foundation and On-Site Waiver filings must be submitted in DOB NOW, as well as all associated After-Hour Variance (AHV) requests and notifications for arrival, departure, assembly and disassembly. Paper forms will no longer be accepted for new CNs, and fees will no longer be waived for CD amendments.

All stakeholders (Professional Engineers, Master Riggers, A/D Directors, Hoist Machine Operators, Lift Directors, Device Installers/Removers, Equipment Users, etc.) need to **register in eFiling** prior to being identified on DOB NOW applications and submitting attestations online.

Any CNs and On-Site Waivers filed in BIS on July 6, 2020 or earlier will remain in BIS until completion, and all related actions, such as amendments and renewals, must be done in BIS. Submission of documents for these filings and actions will continue to be done via paper until further notice.
