A Local Law to amend the New York city charter and the administrative code of the city of New York, in relation to making improvements to clarify and strengthen the human rights law, and to repeal and replace section 8-102 of the administrative code of the city of New York, relating to definitions of terms in the human rights law, and to repeal sections 8-103, 8-104, 8-105 and 8-106 of the administrative code of the city of New York, relating to the functions, powers and duties of the commission on human rights and its relations with city departments and agencies

Be it enacted by the Council as follows:

1 Section 1. Paragraph 8 of subdivision e of section 905 of the New York city charter, as
2 added by a vote of the electors on November 6, 2001, is amended to read as follows:

3 8. [to] Annual reporting. To submit [an annual] a report by September 30, 2018 and
4 September 30 of each year thereafter to the mayor and the speaker of the council [which shall be
5 published in City Record; and]. Such report shall be published in the City Record and shall
6 include information for the previous fiscal year regarding: (i) inquiries received by the
7 commission from the public; (ii) investigations initiated by the commission; (iii) complaints filed
8 with the commission; and (iv) education and outreach efforts made by the commission.

9 § 2. Sections 900, 901, 902, 903, 904, 905 and 906 of the New York city charter, as
10 added by a vote of the electors on November 6, 2001 and paragraph 8 of subdivision e of section
11 905 as amended by section one of this local law, are amended to read as follows:

12 § 900. Declaration of intent. It is [hereby declared as] the public policy of the city [of
13 New York] to promote equal opportunity and freedom from unlawful discrimination through the
14 provisions of the city's human rights law[, chapter 1 of title 8 of the administrative code of the
15 city of New York].

1 § 901. Executive orders. The mayor may issue such executive orders as [he or she] the
2 mayor deems appropriate to provide for city agencies and contractors to act in accordance with
3 the policy set forth in this chapter.

4 § 902. Commission on human rights. a. The New York city commission on human rights
5 is hereby established and continued.

6 b. The commission [shall have the] has general jurisdiction and power to eliminate and
7 prevent unlawful discrimination by enforcing the provisions of [the New York city human rights
8 law, and shall have general jurisdiction and power for such purposes] chapter 1 of title 8 of the
9 administrative code and also has the powers conferred upon such commission by such title and
10 all other applicable laws in furtherance of the elimination and prevention of such unlawful
11 discrimination. [It] The commission may, in addition, take such other actions as may be provided
12 by law against prejudice, intolerance, bigotry and unlawful discrimination and has the powers
13 and duties conferred by this chapter and any other law in furtherance of such purposes. Nothing
14 in this chapter shall be construed to limit the powers of the corporation counsel pursuant to
15 applicable law.

16 § 903. Commission membership; chairperson; appointment; vacancy. The commission
17 shall consist of [fifteen] 15 members, to be appointed by the mayor, one of whom shall be
18 designated by the mayor as its chairperson and shall serve as such at the pleasure of the mayor.
19 The chairperson shall devote [his or her] the chairperson's entire time to the chairperson's duties
20 and shall not engage in any other occupation, profession or employment. Members other than the
21 chairperson shall serve without compensation for a term of three years. In the event of the death
22 or resignation of any member, [his or her] such member's successor shall be appointed to serve
23 for the unexpired portion of the term for which such member had been appointed.

1 § 904. Functions. The functions of the commission [shall be] are:

2 a. [to] To foster mutual understanding and respect among all persons in the city [of New
3 York];

4 b. [to] To encourage equality of treatment for, and prevent discrimination against, any
5 group or its members;

6 c. [to] To cooperate with governmental and non-governmental agencies and organizations
7 having like or kindred functions; and

8 d. [to] To make such investigations and studies in the field of human relations as in the
9 judgment of the commission will aid in effectuating its general purposes.

10 § 905. Powers and duties. The powers and duties of the commission shall be exercised in
11 a manner consistent with this chapter, title 8 of the administrative code and all other applicable
12 laws and include but are not limited to the following:

13 a. [to] Public education and other activities. To work together with federal, state and city
14 agencies in developing courses of instruction, for presentation to city employees and in public
15 and private schools, public libraries, museums and other suitable places, on techniques for
16 achieving harmonious [inter-group] intergroup relations within the city [of New York,] and on
17 types of bias-related harassment and repeated hostile behavior including conduct or verbal
18 threats, taunting, intimidation, abuse, and cyberbullying, and to engage in other anti-
19 discrimination activities. For the purposes of this subdivision, the term “cyberbullying” means
20 willful and repeated harm inflicted through the use of computers, cell phones, and other
21 electronic devices that is intended to frighten, harass, cause harm to, extort, or otherwise target
22 another;

1 b. [to] Cooperation with groups and organizations. To enlist the cooperation of various
2 groups and organizations[,] in mediation efforts, programs and campaigns devoted to eliminating
3 group prejudice, intolerance, hate crimes, bigotry and discrimination. For the purposes of this
4 subdivision, the term “hate crime” means a crime that manifests evidence of prejudice based on
5 race, religion, ethnicity, disability, sexual orientation, national origin, age, gender, or alienage or
6 citizenship status;

7 c. [to] Studies. To study the problems of prejudice, intolerance, bigotry, discrimination
8 and disorder occasioned thereby in all or any fields of human relationship;

9 d. [(1) to] Investigations and complaints; referral. 1. To receive, investigate and pass
10 upon complaints and to initiate its own investigation of: (i) [group-tensions] group tensions,
11 prejudice, intolerance, bigotry and disorder occasioned thereby, and (ii) unlawful discrimination
12 against any person or group of persons, [provided, however,] except that with respect to
13 discrimination alleged to be committed by city officials or city agencies, such investigation shall
14 be commenced after consultation with the mayor[.];

15 2. Upon its own motion, to make, sign and file administrative complaints alleging
16 violations of the city’s human rights law; and

17 [(2) in] 3. In the event that any [such] investigation undertaken pursuant to paragraph 1 of
18 this subdivision discloses information that any person or group of persons may be engaged in a
19 pattern or practice that results in the denial to any person or group of persons of the full
20 enjoyment of any right secured by the human rights law, in addition to making, signing and filing
21 [a] an administrative complaint upon its own motion pursuant to paragraph [a] 2 of this
22 subdivision, to refer such information to the corporation counsel for the purpose of commencing
23 a civil action pursuant to chapter [four] 4 of title [eight] 8 of the administrative code;

1 e. Hearings and production of evidence; order to preserve records. 1. [to] To issue
2 subpoenas in the manner provided for in the civil practice law and rules compelling the
3 attendance of witnesses and requiring the production of any evidence relating to any matter
4 under investigation or any question before the commission, and to take proof with respect
5 thereto;

6 2. [to] To hold hearings, administer oaths and take testimony of any person under oath;
7 [and

8 3. In accordance with applicable law, to] 3. To require the production of any names of
9 persons necessary for the investigation of any institution, club or other place or provider of
10 accommodation[.

11 4. In accordance with applicable law, to]; and

12 4. To require, in accordance with the provisions of subdivision b of section 8-114 of the
13 administrative code, any person or persons who are the subject of an investigation by the
14 commission to preserve such records as are in the possession of such person or persons and to
15 continue to make and keep the type of records that have been made and kept by such person or
16 persons in the ordinary course of business within the previous year, which records are relevant to
17 the determination whether such person or persons have committed unlawful discriminatory
18 practices or other acts made unlawful by chapter 1 or chapter 6 of title 8 of the administrative
19 code with respect to activities in the city;

20 [5. to] f. Publications and reports. To issue publications and reports of investigation and
21 research designed to promote good will and minimize or eliminate prejudice, intolerance,
22 bigotry, discrimination and disorder occasioned thereby;

1 [6. to] g. Appointments and assignments; expenses. To appoint such employees and
2 agents as it deems to be necessary to carry out its functions, powers and duties[: provided,
3 however,] and to assign to such persons any of such functions, powers and duties, except that the
4 commission shall not delegate its power to adopt rules[,] and [provided further,] also except that
5 the commission's power to order that records be preserved or made and kept pursuant to
6 subdivision b of section 8-114 of the administrative code and the commission's power to
7 determine that a respondent has engaged in an unlawful discriminatory practice and to issue an
8 order for such relief as is necessary and proper shall be delegated only to members of the
9 commission. The expenses for the carrying on of the commission's activities shall be paid out of
10 the funds in the city treasury. The commission's appointment and assignment powers as set forth
11 in this subdivision may be exercised by the chairperson of the commission;

12 [7. to] h. Recommendations. To recommend to the mayor and to the council legislation to
13 aid in carrying out the purposes of this chapter;

14 [8.] i. Annual reporting. To submit a report by September 30, 2018 and September 30 of
15 each year thereafter to the mayor and the speaker of the council. Such report shall be published
16 in the City Record and shall include information for the previous fiscal year regarding: (i)
17 inquiries received by the commission from the public; (ii) investigations initiated by the
18 commission; (iii) complaints filed with the commission; and (iv) education and outreach efforts
19 made by the commission.

20 1. The information regarding inquiries received by the commission from the public shall
21 include, but not be limited to: (i) the total number of inquiries; (ii) the number of inquiries made
22 by limited English proficient persons disaggregated by language; (iii) the subject matter of
23 inquiries disaggregated by the alleged category of unlawful discriminatory practice as set forth

1 by section 8-107 of the administrative code and the protected class of person; and (iv) the
2 number of inquiries resolved by pre-complaint intervention.

3 2. The information regarding investigations initiated by the commission shall include, but
4 not be limited to: (i) the total number of investigations initiated by the commission disaggregated
5 by the category of unlawful discriminatory practice as set forth by section 8-107 of the
6 administrative code and the protected class at issue; (ii) the total number of commission-initiated
7 complaints filed pursuant to section 8-109 of the administrative code after an investigation
8 finding that a person or group of persons may be engaged in a pattern or practice of
9 discrimination; (iii) the total number of investigations referred to the corporation counsel for the
10 purpose of commencing a civil action pursuant to chapter 4 of title 8 of the administrative code;
11 and (iv) the total number of publications and reports of investigations designed to promote good
12 will and minimize or eliminate prejudice, intolerance, bigotry, discrimination and disorder
13 occasioned thereby.

14 3. The information regarding complaints filed with the commission shall include, but not
15 be limited to, the number of complaints filed with the commission and shall be disaggregated by:
16 (i) the category of unlawful discriminatory practice, as set forth by section 8-107 of the
17 administrative code, alleged; (ii) the basis of the alleged discriminatory practice based on
18 protected class of the complainant; (iii) whether the complaint was resolved by mediation and
19 conciliation, as set forth in section 8-115 of the administrative code; a determination of no
20 probable cause, as set forth in section 8-116 of the administrative code; or a hearing, as set forth
21 by section 8-119 of the administrative code; (iv) the number of days the complaint was
22 outstanding at the time such resolution occurred; and (v) whether a fine, penalty or cash award
23 was imposed and, if so, the dollar amount of such fine, penalty or cash award.

1 4. The information regarding the commission’s education and outreach efforts as required
2 by subdivisions a and b of this section shall include, but not be limited to: (i) the types of
3 outreach initiated; (ii) the number of people with whom the commission made contact as a result
4 of outreach; (iii) the number of limited English proficient persons served; and (iv) the languages
5 in which such outreach was conducted; and

6 [9. to] j. Rules. To adopt rules to carry out the [provisions of] powers and duties
7 delegated to the commission by this chapter, title 8 of the administrative code or any other law,
8 and the policies and procedures of the commission in connection therewith.

9 § 906. Relations with city departments and agencies. So far as practicable and subject to
10 the approval of the mayor, the services of all other city departments and agencies shall be made
11 available by their respective [head] heads to the commission for the carrying out of the functions
12 [herein] stated in this chapter. The head of any department or agency shall furnish information in
13 the possession of such department or agency when the commission so requests. The corporation
14 counsel, upon request of the chairperson, may assign counsel to assist the commission in the
15 conduct of its investigative or prosecutorial functions.

16 § 3. Section 8-102 of the administrative code of the city of New York is REPEALED and
17 a new section 8-102 is added to read as follows:

18 § 8-102 Definitions. Except as otherwise expressly provided, when used in this chapter,
19 the following terms have the following meanings:

20 Acts or threats of violence. The term “acts or threats of violence” includes, but is not
21 limited to, acts, which would constitute violations of the penal law.

22 Alienage or citizenship status. The term “alienage or citizenship status” means:

23 1. The citizenship of any person, or

1 2. The immigration status of any person who is not a citizen or national of the United
2 States.

3 Caregiver. The term “caregiver” means a person who provides direct and ongoing care
4 for a minor child or a care recipient. As used in this definition:

5 1. Care recipient. The term “care recipient” means a person with a disability who: (i) is a
6 covered relative, or a person who resides in the caregiver’s household and (ii) relies on the
7 caregiver for medical care or to meet the needs of daily living.

8 2. Covered relative. The term “covered relative” means a caregiver’s child, spouse,
9 domestic partner, parent, sibling, grandchild or grandparent, or the child or parent of the
10 caregiver’s spouse or domestic partner, or any other individual in a familial relationship with the
11 caregiver as designated by the rules of the commission.

12 3. Grandchild. The term “grandchild” means a child of a caregiver’s child.

13 4. Grandparent. The term “grandparent” means a parent of a caregiver’s parent.

14 5. Parent. The term “parent” means a biological, foster, step- or adoptive parent, or a
15 legal guardian of a caregiver, or a person who stood in loco parentis when the caregiver was a
16 minor child.

17 6. Sibling. The term “sibling” means a caregiver’s brother or sister, including half-
18 siblings, step-siblings and siblings related through adoption.

19 7. Spouse. The term “spouse” means a person to whom a caregiver is legally married
20 under the laws of the state of New York.

21 8. Child. The term “child” means a biological, adopted or foster child, a legal ward or a
22 child of a caregiver standing in loco parentis.

23 9. Minor child. The term “minor child” means a child under the age of 18.

1 Commercial space. The term “commercial space” means any space in a building,
2 structure or portion thereof which is used or occupied or is intended, arranged or designed to be
3 used or occupied for the manufacture, sale, resale, processing, reprocessing, displaying, storing,
4 handling, garaging or distribution of personal property; and any space which is used or occupied,
5 or is intended, arranged or designed to be used or occupied as a business or professional unit or
6 office in any building, structure or portion thereof.

7 Commission. The term “commission,” unless a different meaning clearly appears from
8 the text, means the city commission on human rights.

9 Consumer credit history. The term “consumer credit history” means an individual’s
10 credit worthiness, credit standing, credit capacity, or payment history, as indicated by: (i) a
11 consumer credit report; (ii) credit score; or (iii) information an employer obtains directly from
12 the individual regarding (1) details about credit accounts, including the individual’s number of
13 credit accounts, late or missed payments, charged-off debts, items in collections, credit limit,
14 prior credit report inquiries, or (2) bankruptcies, judgments or liens. A consumer credit report
15 shall include any written or other communication of any information by a consumer reporting
16 agency that bears on a consumer’s creditworthiness, credit standing, credit capacity or credit
17 history.

18 Covered entity. The term “covered entity” means a person required to comply with any
19 provision of section 8-107.

20 Disability. The term “disability” means any physical, medical, mental or psychological
21 impairment, or a history or record of such impairment. As used in this definition:

22 1. Physical, medical, mental, or psychological impairment. The term “physical, medical,
23 mental, or psychological impairment” means:

1 (a) An impairment of any system of the body; including, but not limited to, the
2 neurological system; the musculoskeletal system; the special sense organs and respiratory
3 organs, including, but not limited to, speech organs; the cardiovascular system; the reproductive
4 system; the digestive and genito-urinary systems; the hemic and lymphatic systems; the
5 immunological systems; the skin; and the endocrine system; or

6 (b) A mental or psychological impairment.

7 2. In the case of alcoholism, drug addiction or other substance abuse, the term
8 “disability” only applies to a person who (i) is recovering or has recovered and (ii) currently is
9 free of such abuse, and does not include an individual who is currently engaging in the illegal use
10 of drugs, when the covered entity acts on the basis of such use.

11 Domestic partner. The term “domestic partner” means any person who has a registered
12 domestic partnership pursuant to section 3-240, a domestic partnership registered in
13 accordance with executive order number 123, dated August 7, 1989, or a domestic partnership
14 registered in accordance with executive order number 48, dated January 7, 1993.

15 Educational institution. The term “educational institution” includes kindergartens,
16 primary and secondary schools, academies, colleges, universities, professional schools, extension
17 courses, and all other educational facilities.

18 Employer. For purposes of subdivisions 1, 2, 3, 11-a, and 22, subparagraph 1 of
19 paragraph a of subdivision 21, and paragraph e of subdivision 21 of section 8-107, the term
20 “employer” does not include any employer with fewer than four persons in the employ of such
21 employer. For purposes of this definition, natural persons employed as independent contractors
22 to carry out work in furtherance of an employer’s business enterprise who are not themselves
23 employers shall be counted as persons in the employ of such employer.

1 Employment agency. The term “employment agency” includes any person undertaking to
2 procure employees or opportunities to work.

3 Family. The term “family,” as used in subparagraph (4) of paragraph a of subdivision 5
4 of section 8-107, means either a person occupying a dwelling and maintaining a household, with
5 not more than four boarders, roomers or lodgers, or two or more persons occupying a dwelling,
6 living together and maintaining a common household, with not more than four boarders, roomers
7 or lodgers. As used in this definition, a “boarder,” “roomer” or “lodger” residing with a family
8 means a person living within the household who pays a consideration for such residence and
9 does not occupy such space within the household as an incident of employment therein.

10 Gender. The term “gender” includes actual or perceived sex, gender identity and gender
11 expression, including a person’s actual or perceived gender-related self-image, appearance,
12 behavior, expression or other gender-related characteristic, regardless of the sex assigned to that
13 person at birth.

14 Housing accommodation. The term “housing accommodation” includes any building,
15 structure or portion thereof that is used or occupied or is intended, arranged or designed to be
16 used or occupied, as the home, residence or sleeping place of one or more human beings. Except
17 as otherwise specifically provided, such term includes a publicly-assisted housing
18 accommodation.

19 Intelligence information. The term “intelligence information” means records and data
20 compiled for the purpose of criminal investigation or counterterrorism, including records and
21 data relating to the order or security of a correctional facility, reports of informants, investigators
22 or other persons, or from any type of surveillance associated with an identifiable individual, or
23 investigation or analysis of potential terrorist threats.

1 Intern. 1. The term “intern” means an individual who performs work for an employer on
2 a temporary basis whose work:

3 (a) Provides training or supplements training given in an educational environment such
4 that the employability of the individual performing the work may be enhanced;

5 (b) Provides experience for the benefit of the individual performing the work; and

6 (c) Is performed under the close supervision of existing staff.

7 2. The term includes such individuals without regard to whether the employer pays them
8 a salary or wage.

9 Labor organization. The term “labor organization” includes any organization that exists
10 and is constituted for the purpose, in whole or in part, of collective bargaining or of dealing with
11 employers concerning grievances, terms and conditions of employment, or of other mutual aid or
12 protection in connection with employment.

13 Lawful source of income. The term “lawful source of income” includes income derived
14 from social security, or any form of federal, state or local public assistance or housing assistance
15 including section 8 vouchers.

16 National origin. The term “national origin” includes “ancestry.”

17 National security information. The term “national security information” means any
18 knowledge relating to the national defense or foreign relations of the United States, regardless of
19 its physical form or characteristics, that is owned by, is produced by or for, or is under the
20 control of the United States government and is defined as such by the United States government
21 and its agencies and departments.

22 Occupation. The term “occupation” means any lawful vocation, trade, profession or field
23 of specialization.

1 Partnership status. The term “partnership status” means the status of being in a domestic
2 partnership, as defined by subdivision a of section 3-240.

3 Person. The term “person” includes one or more natural persons, proprietorships,
4 partnerships, associations, group associations, organizations, governmental bodies or agencies,
5 corporations, legal representatives, trustees, trustees in bankruptcy, or receivers.

6 Person aggrieved. 1. The term “person aggrieved,” except as used in section 8-123,
7 includes a person whose right created, granted or protected by this chapter is violated by a
8 covered entity directly or through conduct of the covered entity to which the person’s agent or
9 employee is subjected while the agent or employee was acting, or as a result of the agent or
10 employee having acted, within the scope of the agency or employment relationship. For purposes
11 of this definition, an agent or employee’s protected status is imputed to that person’s principal or
12 employer when the agent or employee acts within the scope of the agency or employment
13 relationship. It is irrelevant whether or not the covered entity knows of the agency or
14 employment relationship.

15 2. A person is aggrieved even if that person’s only injury is the deprivation of a right
16 granted or protected by this chapter.

17 3. This definition does not limit or exclude any other basis for a cause of action.

18 Place or provider of public accommodation. The term “place or provider of public
19 accommodation” includes providers, whether licensed or unlicensed, of goods, services,
20 facilities, accommodations, advantages or privileges of any kind, and places, whether licensed or
21 unlicensed, where goods, services, facilities, accommodations, advantages or privileges of any
22 kind are extended, offered, sold, or otherwise made available. Such term does not include any
23 club which proves that it is in its nature distinctly private. A club is not in its nature distinctly

1 private if it has more than 400 members, provides regular meal service and regularly receives
2 payment for dues, fees, use of space, facilities, services, meals or beverages directly or indirectly
3 from or on behalf of non-members for the furtherance of trade or business. For the purposes of
4 this definition, a corporation incorporated under the benevolent orders law or described in the
5 benevolent orders law but formed under any other law of this state, or a religious corporation
6 incorporated under the education law or the religious corporation law is deemed to be in its
7 nature distinctly private. No club that sponsors or conducts any amateur athletic contest or
8 sparring exhibition and advertises or bills such contest or exhibition as a New York state
9 championship contest or uses the words “New York state” in its announcements is a private
10 exhibition within the meaning of this definition.

11 Publicly-assisted housing accommodations. The term “publicly-assisted housing
12 accommodations” includes:

13 1. Publicly-owned or operated housing accommodations;

14 2. Housing accommodations operated by housing companies under the supervision of the
15 state commissioner of housing and community renewal, or the department of housing
16 preservation and development;

17 3. Housing accommodations constructed after July 1, 1950, and housing accommodations
18 sold after July 1, 1991:

19 (a) That are exempt in whole or in part from taxes levied by the state or any of its
20 political subdivisions;

21 (b) That are constructed on land sold below cost by the state or any of its political
22 subdivisions or any agency thereof, pursuant to the federal housing act of 1949;

1 (c) That are constructed in whole or in part on property acquired or assembled by the
2 state or any of its political subdivisions or any agency thereof through the power of
3 condemnation or otherwise for the purpose of such construction; or

4 (d) For the acquisition, construction, repair or maintenance for which the state or any of
5 its political subdivisions or any agency thereof supplies funds or other financial assistance; and

6 4. Housing accommodations, the acquisition, construction, rehabilitation, repair or
7 maintenance of which is, after July 1, 1955, financed in whole or in part by a loan, whether or
8 not secured by a mortgage, the repayment of which is guaranteed or insured by the federal
9 government or any agency thereof, or the state or any of its political subdivisions or any agency
10 thereof.

11 Real estate broker. The term “real estate broker” means any person who, for another and
12 for a fee, commission or other valuable consideration, lists for sale, sells, at auction or otherwise,
13 exchanges, buys or rents, or offers or attempts to negotiate a sale at auction, or otherwise,
14 exchange, purchase or rental of an estate or interest in real estate or collects or offers or attempts
15 to collect rent for the use of real estate, or negotiates, or offers or attempts to negotiate, a loan
16 secured or to be secured by a mortgage or other incumbrance upon or transfer of real estate. In
17 the sale of lots pursuant to the provisions of article nine-a of the real property law, the term “real
18 estate broker” shall also include any person employed by or on behalf of the owner or owners of
19 lots or other parcels of real estate, at a stated salary, or upon commission, or upon a salary and
20 commission, or otherwise, to sell such real estate, or any parts thereof, in lots or other parcels,
21 and who shall sell or exchange, or offer or attempt or agree to negotiate the sale or exchange of
22 any such lot or parcel of real estate.

1 Real estate salesperson. The term “real estate salesperson” means a person employed by
2 or authorized by a licensed real estate broker to list for sale, sell or offer for sale at auction or
3 otherwise to buy or offer to buy or to negotiate the purchase or sale or exchange of real estate or
4 to negotiate a loan on real estate or to lease or rent or offer to lease, rent or place for rent any real
5 estate, or who collects or offers or attempts to collect rents for the use of real estate for or on
6 behalf of such real estate broker.

7 Reasonable accommodation. 1. The term “reasonable accommodation” means such
8 accommodation that can be made that does not cause undue hardship in the conduct of the
9 covered entity’s business. The covered entity has the burden of proving undue hardship. In
10 making a determination of undue hardship with respect to claims filed under subdivisions 1, 2,
11 22 or 27 of section 8-107, the factors which may be considered include but are not limited to:

12 (a) The nature and cost of the accommodation;

13 (b) The overall financial resources of the facility or the facilities involved in the provision
14 of the reasonable accommodation; the number of persons employed at such facility; the effect on
15 expenses and resources, or the impact otherwise of such accommodation upon the operation of
16 the facility;

17 (c) The overall financial resources of the covered entity; the overall size of the business
18 of a covered entity with respect to the number of its employees, the number, type, and location of
19 its facilities; and

20 (d) The type of operation or operations of the covered entity, including the composition,
21 structure and functions of the workforce of such entity; the geographic separateness,
22 administrative or fiscal relationship of the facility or facilities in question to the covered entity.

1 2. In making a determination of undue hardship with respect to claims for reasonable
2 accommodation to an employee’s or prospective employee’s religious observance filed under
3 subdivision 3 of section 8-107, the definition of “undue hardship” set forth in paragraph b of
4 such subdivision applies.

5 Sexual orientation. The term “sexual orientation” means an individual’s actual or
6 perceived romantic, physical or sexual attraction to other persons, or lack thereof, on the basis of
7 gender. A continuum of sexual orientation exists and includes, but is not limited to,
8 heterosexuality, homosexuality, bisexuality, asexuality and pansexuality.

9 Trade secrets. The term “trade secrets” means information that (i) derives independent
10 economic value, actual or potential, from not being generally known to, and not being readily
11 ascertainable by proper means by other persons who can obtain economic value from its
12 disclosure or use; (ii) is the subject of efforts that are reasonable under the circumstances to
13 maintain its secrecy; and (iii) can reasonably be said to be the end product of significant
14 innovation. The term “trade secrets” does not include general proprietary company information
15 such as handbooks and policies. The term “regular access to trade secrets” does not include
16 access to or the use of client, customer or mailing lists.

17 Unemployed or unemployment. The term “unemployed” or “unemployment” means not
18 having a job, being available for work, and seeking employment.

19 Uniformed service. The term “uniformed service” means:

20 1. Current or prior service in:

21 (a) The United States army, navy, air force, marine corps, coast guard, commissioned
22 corps of the national oceanic and atmospheric administration, commissioned corps of the United
23 States public health services, army national guard or air national guard;

1 (b) The organized militia of the state of New York, as described in section 2 of the
2 military law, or the organized militia of any other state, territory or possession of the United
3 States; or

4 (c) Any other service designated as part of the “uniformed services” pursuant to
5 subsection (16) of section 4303 of title 38 of the United States code;

6 2. Membership in any reserve component of the United States army, navy, air force,
7 marine corps, or coast guard; or

8 3. Being listed on the state reserve list or the state retired list as described in section 2 of
9 the military law or comparable status for any other state, territory or possession of the United
10 States.

11 Unlawful discriminatory practice. The term “unlawful discriminatory practice” includes
12 only those practices specified in section 8-107.

13 Victim of domestic violence. The term “victim of domestic violence” means a person
14 who has been subjected to acts or threats of violence, not including acts of self-defense,
15 committed by a current or former spouse of the victim, by a person with whom the victim shares
16 a child in common, by a person who is cohabiting with or has cohabited with the victim, by a
17 person who is or has been in a continuing social relationship of a romantic or intimate nature
18 with the victim, or by a person who is or has continually or at regular intervals lived in the same
19 household as the victim.

20 Victim of sex offenses or stalking. The term “victim of sex offenses or stalking” means a
21 victim of acts that would constitute violations of article 130 of the penal law or a victim of acts
22 that would constitute violations of sections 120.45, 120.50, 120.55, or 120.60 of the penal law.

1 § 4. Sections 8-103, 8-104, 8-105 and 8-106 of the administrative code of the city of New
2 York are REPEALED.

3 § 5. Paragraphs (e) and (f) of subdivision 1 of section 8-107 of the administrative code of
4 the city of New York, paragraph (e) of such subdivision as amended by local law number 39 for
5 the year 1991 and paragraph (f) of such subdivision as amended by local law number 27 for the
6 year 1998, are amended to read as follows:

7 (e) The provisions of this subdivision and subdivision [two] 2 of this section: (i) as they
8 apply to employee benefit plans, shall not be construed to preclude an employer from observing
9 the provisions of any plan covered by the federal employment retirement income security act of
10 [nineteen hundred seventy-four] 1974 that is in compliance with applicable federal
11 discrimination laws where the application of the provisions of such subdivisions to such plan
12 would be preempted by such act; (ii) shall not preclude the varying of insurance coverages
13 according to an employee's age; (iii) shall not be construed to affect any retirement policy or
14 system that is permitted pursuant to [paragraph] paragraphs (e) and (f) of subdivision [three-a] 3-
15 a of section [two hundred ninety-six] 296 of the executive law; (iv) shall not be construed to
16 affect the retirement policy or system of an employer where such policy or system is not a
17 subterfuge to evade the purposes of this chapter.

18 (f) The provisions of this subdivision shall not govern the employment by an employer of
19 [his or her] the employer's parents, spouse, domestic partner, or children; provided, however,
20 that such family members shall be counted as persons employed by an employer for the purposes
21 of [subdivision five of] the definition of employer set forth in section 8-102 [of this chapter].

1 § 6. Paragraphs (b), (c) and (d) of subdivision 2 of section 8-107 of the administrative
2 code of the city of New York, as amended by local law number 119 for the year 2017, are
3 amended to read as follows:

4 (b) To deny to or withhold from any person because of [his or her] such person's actual
5 or perceived race, creed, color, national origin, gender, age, disability, marital status, partnership
6 status, sexual orientation, uniformed service, [or] alienage or citizenship status or status as a
7 victim of domestic violence or as a victim of sex offenses or stalking the right to be admitted to
8 or participate in a guidance program, an apprentice training program, on-the-job training
9 program, or other occupational training or retraining program, or to represent that such program
10 is not available when in fact it is available.

11 (c) To discriminate against any person in [his or her] such person's pursuit of such
12 program or to discriminate against such a person in the terms, conditions or privileges of such
13 program because of actual or perceived race, creed, color, national origin, gender, age, disability,
14 marital status, partnership status, sexual orientation, uniformed service, [or] alienage or
15 citizenship status or status as a victim of domestic violence or as a victim of sex offenses or
16 stalking.

17 (d) To declare, print or circulate or cause to be declared, printed or circulated any
18 statement, advertisement or publication, or to use any form of application for such program or to
19 make any inquiry in connection with such program which expresses, directly or indirectly, any
20 limitation, specification or discrimination as to race, creed, color, national origin, gender, age,
21 disability, marital status, partnership status, sexual orientation, uniformed service, [or] alienage
22 or citizenship status or status as a victim of domestic violence or as a victim of sex offenses or
23 stalking, or any intent to make any such limitation, specification or discrimination.

1 § 7. Subdivision 3 of section 8-107 of the administrative code of the city of New York, as
2 amended by local law number 54 for the year 2011, is amended to read as follows:

3 3. Employment; religious observance. (a) It shall be an unlawful discriminatory practice
4 for an employer or an employee or agent thereof to impose upon a person as a condition of
5 obtaining or retaining employment any terms or conditions, compliance with which would
6 require such person to violate, or forego a practice of, [his or her] such person's creed or religion,
7 including but not limited to the observance of any particular day or days or any portion thereof as
8 a sabbath or holy day or the observance of any religious custom or usage, and the employer shall
9 make reasonable accommodation to the religious needs of such person. Without in any way
10 limiting the foregoing, no person shall be required to remain at [his or her] such person's place of
11 employment during any day or days or portion thereof that, as a requirement of such person's
12 religion, [he or she] such person observes as a sabbath or other holy day, including a reasonable
13 time prior and subsequent thereto for travel between [his or her] such person's place of
14 employment and [his or her] such person's home, provided, however, that any such absence from
15 work shall, wherever practicable in the judgment of the employer, be made up by an equivalent
16 amount of time at some other mutually convenient time.

17 (b) "Reasonable accommodation", as used in this subdivision, shall mean such
18 accommodation to an employee's or prospective employee's religious observance or practice as
19 shall not cause undue hardship in the conduct of the employer's business. The employer shall
20 have the burden of proof to show such hardship. "Undue hardship" as used in this subdivision
21 shall mean an accommodation requiring significant expense or difficulty (including a significant
22 interference with the safe or efficient operation of the workplace or a violation of a bona fide

1 seniority system). Factors to be considered in determining whether the accommodation
2 constitutes an undue economic hardship shall include, but not be limited to:

3 (i) [the] The identifiable cost of the accommodation, including the costs of loss of
4 productivity and of retaining or hiring employees or transferring employees from one facility to
5 another, in relation to the size and operating cost of the employer;

6 (ii) [the] The number of individuals who will need the particular accommodation to a
7 sincerely held religious observance or practice; and

8 (iii) [for] For an employer with multiple facilities, the degree to which the geographic
9 separateness or administrative or fiscal relationship of the facilities will make the
10 accommodation more difficult or expensive.

11 Provided, however, an accommodation shall be considered to constitute an undue
12 hardship, for purposes of this subdivision, if it will result in the inability of an employee who is
13 seeking a religious accommodation to perform the essential functions of the position in which
14 [he or she] the employee is employed.

15 § 8. Paragraphs c and e of subdivision 4 of section 8-107 of the administrative code of the
16 city of New York, paragraph c of such subdivision as amended by local law number 39 for the
17 year 1991 and paragraph e of such subdivision as amended by local law number 34 for the year
18 2016, are amended to read as follows:

19 c. The provisions of this subdivision relating to discrimination on the basis of gender
20 shall not prohibit any educational institution subject to this subdivision from making gender
21 distinctions which would be permitted (i) for educational institutions which are subject to section
22 [thirty-two hundred one] 3201-a of the education law or any rules or regulations promulgated by
23 the state commissioner of education relating to gender or (ii) under sections 86.32, 86.33 and

1 86.34 of title [forty-five] 45 of the code of federal regulations for educational institutions
2 covered thereunder.

3 e. The provisions of this section relating to disparate impact shall not apply to the use of
4 standardized tests as defined by section [three hundred forty] 340 of the education law by an
5 educational institution subject to this subdivision provided that such test is used in the manner
6 and for the purpose prescribed by the test agency which designed the test.

7 § 9. Paragraphs (g), (h), (i), (j) and (l) of subdivision 5 of section 8-107 of the
8 administrative code of the city of New York, as amended by local law number 39 for the year
9 1991, are amended to read as follows:

10 (g) Applicability; persons under [eighteen] 18 years of age. The provisions of this
11 subdivision, as they relate to unlawful discriminatory practices in housing accommodations, land
12 and commercial space or an interest therein and lending practices on the basis of age, shall not
13 apply to unemancipated persons under the age of [eighteen] 18 years.

14 (h) Applicability; discrimination against persons with children. The provisions of this
15 subdivision with respect to discrimination against persons with whom children are, may be or
16 would be residing shall not apply to housing for older persons as defined in paragraphs [two] 2
17 and [three] 3 of subdivision (b) of section [thirty-six hundred seven] 3607 of title [forty-two] 42
18 of the United States code and any regulations promulgated thereunder.

19 (i) Applicability; senior citizen housing. The provisions of this subdivision with respect
20 to discrimination on the basis of age shall not apply to the restriction of the sale, rental or lease of
21 any housing accommodation, land or commercial space or an interest therein exclusively to
22 persons [fifty-five] 55 years of age or older. This paragraph shall not be construed to permit
23 discrimination against such persons [fifty-five] 55 years of age or older on the basis of whether

1 children are, may be or would be residing in such housing accommodation or land or an interest
2 therein unless such discrimination is otherwise permitted pursuant to paragraph (h) of this
3 subdivision.

4 (j) Applicability; dormitory residence operated by educational institution. The provisions
5 of this subdivision relating to discrimination on the basis of gender in housing accommodations
6 shall not prohibit any educational institution from making gender distinctions in dormitory
7 residences which would be permitted under sections 86.32 and 86.33 of title [forty-five] 45 of
8 the code of federal regulations for educational institutions covered thereunder.

9 (l) Exemption for special needs of particular age group in publicly-assisted housing
10 accommodations. Nothing in this subdivision shall restrict the consideration of age in the rental
11 of publicly-assisted housing accommodations if the state division of human rights grants an
12 exemption pursuant to section [two hundred ninety-six] 296 of the executive law based on bona
13 fide considerations of public policy for the purpose of providing for the special needs of a
14 particular age group without the intent of prejudicing other age groups; provided however, that
15 this paragraph shall not be construed to permit discrimination on the basis of whether children
16 are, may be or would be residing in such housing accommodations unless such discrimination is
17 otherwise permitted pursuant to paragraph (h) of this [section] subdivision.

18 § 10. Subparagraphs (3), (4) and (5) of paragraph (a) and subparagraph (1) of paragraph
19 (d) of subdivision 9 of section 8-107 of the administrative code of the city of New York,
20 subparagraphs (3), (4) and (5) of paragraph (a) of such subdivision as amended by local law
21 number 63 for the year 2015 and subparagraph (1) of paragraph (d) of such subdivision as added
22 by local law number 37 for the year 2015, are amended to read as follows:

1 (3) For any person to deny any license, registration or permit to any applicant, or act
2 adversely upon any holder of a license, registration or permit by reason of [his or her] such
3 applicant or holder having been convicted of one or more criminal offenses, or by reason of a
4 finding of a lack of “good moral character” which is based on [his or her] such applicant or
5 holder having been convicted of one or more criminal offenses, when such denial or adverse
6 action is in violation of the provisions of article [twenty-three-a] 23-a of the correction law.

7 (4) For any person to deny any license, registration or permit to any applicant, or act
8 adversely upon any holder of a license, registration or permit by reason of [his or her] such
9 applicant or holder having been arrested or accused of committing a crime when such denial or
10 adverse action is in violation of subdivision 16 of section 296 of article 15 of the [New York
11 state] executive law.

12 (5) For any person to make any inquiry, in writing or otherwise, regarding any arrest or
13 criminal accusation of an applicant for any license, registration or permit when such inquiry is in
14 violation of subdivision 16 of section 296 of article 15 of the [New York state] executive law.

15 (d)(1) Except as otherwise provided in this paragraph, it shall be an unlawful
16 discriminatory practice for an agency to request or use for licensing or permitting purposes
17 information contained in the consumer credit history of an applicant, licensee or permittee [for
18 licensing or permitting purposes].

19 § 11. Paragraphs (a) and (c) of subdivision 10 of section 8-107 of the administrative code
20 of the city of New York, as amended by local law number 63 for the year 2015, are amended to
21 read as follows:

22 (a) It shall be an unlawful discriminatory practice for any employer, employment agency
23 or agent thereof to deny employment to any person or take adverse action against any employee

1 by reason of such person or employee having been convicted of one or more criminal offenses,
2 or by reason of a finding of a lack of “good moral character” which is based on such person or
3 employee having been convicted of one or more criminal offenses, when such denial or adverse
4 action is in violation of the provisions of article [twenty-three-a] 23-a of the correction law.

5 (c) Pursuant to section [seven hundred fifty-five] 755 of the correction law, the provisions
6 of this subdivision shall be enforceable against public agencies by a proceeding brought pursuant
7 to article [seventy-eight] 78 of the [Civil Practice Law and Rules] civil practice law and rules,
8 and the provisions of this subdivision shall be enforceable against private employers by the
9 commission through the administrative procedure provided for in this chapter or as provided in
10 chapter [five] 5 of this title. For purposes of this paragraph only, the terms “public agency” and
11 “private employer” [shall] have the meaning given such terms in section [seven hundred fifty]
12 750 of the correction law.

13 § 12. Subdivision 11 of section 8-107 of the administrative code of the city of New York,
14 as amended by local law number 63 for the year 2015, is amended to read as follows:

15 11. Arrest record; employment. It shall be an unlawful discriminatory practice, unless
16 specifically required or permitted by any other law, for any person to:

17 (a) [deny] Deny employment to any applicant or act adversely upon any employee by
18 reason of an arrest or criminal accusation of such applicant or employee when such denial or
19 adverse action is in violation of subdivision 16 of section 296 of article 15 of the [New York
20 state] executive law; or

21 (b) [make] Make any inquiry in writing or otherwise, regarding any arrest or criminal
22 accusation of an applicant or employee when such inquiry is in violation of subdivision 16 of
23 section 296 of article 15 of the [New York state] executive law.

1 § 13. Subdivision 11-a of section 8-107 of the administrative code of the city of New
2 York, as amended by local law number 40 for the year 2016, is amended to read as follows:

3 11-a. Arrest and conviction records; employer inquiries. (a) In addition to the restrictions
4 in subdivision 11 of this section, it shall be an unlawful discriminatory practice for any
5 employer, employment agency or agent thereof to:

6 (1) Declare, print or circulate or cause to be declared, printed or circulated any
7 solicitation, advertisement or publication, which expresses, directly or indirectly, any limitation,
8 or specification in employment based on a person’s arrest or criminal conviction;

9 (2) Because of any person’s arrest or criminal conviction, represent that any employment
10 or position is not available, when in fact it is available to such person; or

11 (3) Make any inquiry or statement related to the pending arrest or criminal conviction
12 record of any person who is in the process of applying for employment with such employer or
13 agent thereof until after such employer or agent thereof has extended a conditional offer of
14 employment to the applicant. For purposes of this subdivision, with respect to an applicant for
15 temporary employment at a temporary help firm as such term is defined by subdivision [five] 5
16 of section 916 of article 31 of the labor law, an offer to be placed in the temporary help firm’s
17 general candidate pool shall constitute a conditional offer of employment. For purposes of this
18 subdivision, “any inquiry” means any question communicated to an applicant in writing or
19 otherwise, or any searches of publicly available records or consumer reports that are conducted
20 for the purpose of obtaining an applicant’s criminal background information, and “any
21 statement” means a statement communicated in writing or otherwise to the applicant for
22 purposes of obtaining an applicant’s criminal background information regarding: (i) an arrest
23 record; (ii) a conviction record; or (iii) a criminal background check.

1 (b) After extending an applicant a conditional offer of employment, an employer,
2 employment agency or agent thereof may inquire about the applicant's arrest or conviction
3 record if before taking any adverse employment action based on such inquiry, the employer,
4 employment agency or agent thereof:

5 (i) [provides] Provides a written copy of the inquiry to the applicant in a manner to be
6 determined by the commission;

7 (ii) [performs] Performs an analysis of the applicant under article [twenty-three-a] 23-a of
8 the correction law and provides a written copy of such analysis to the applicant in a manner to be
9 determined by the commission, which shall include but not be limited to supporting documents
10 that formed the basis for an adverse action based on such analysis and the employer's or
11 employment agency's reasons for taking any adverse action against such applicant; and

12 (iii) [after] After giving the applicant the inquiry and analysis in writing pursuant to
13 subparagraphs (i) and (ii) of this paragraph, allows the applicant a reasonable time to respond,
14 which shall be no less than three business days and during this time, holds the position open for
15 the applicant.

16 (c) Nothing in this subdivision shall prevent an employer, employment agency or agent
17 thereof from taking adverse action against any employee or denying employment to any
18 applicant for reasons other than such employee or applicant's arrest or criminal conviction
19 record.

20 (d) An applicant shall not be required to respond to any inquiry or statement that violates
21 paragraph (a) of this subdivision and any refusal to respond to such inquiry or statement shall not
22 disqualify an applicant from the prospective employment.

1 (e) This subdivision shall not apply to any actions taken by an employer or agent thereof
2 pursuant to any state, federal or local law that requires criminal background checks for
3 employment purposes or bars employment based on criminal history. For purposes of this
4 paragraph federal law shall include rules or regulations promulgated by a self-regulatory
5 organization as defined in section 3(a)(26) of the securities exchange act of 1934, as amended.

6 (f) This subdivision shall not apply to any actions taken by an employer or agent thereof
7 with regard to an applicant for employment:

8 (1) [as] As a police officer or peace officer, as those terms are defined in subdivisions
9 [thirty-three] 33 and [thirty-four] 34 of section 1.20 of the criminal procedure law, respectively,
10 or at a law enforcement agency as that term is used in article 23-a of the correction law,
11 including but not limited to the police department, the fire department, the department of
12 correction, the department of investigation, the department of probation, the division of youth
13 and family services, the business integrity commission, and the district attorneys' offices; or

14 (2) listed in the determinations of personnel published as a commissioner's calendar item
15 and listed on the website of the department of citywide administrative services upon a
16 determination by the commissioner of citywide administrative services that the position involves
17 law enforcement, is susceptible to bribery or other corruption, or entails the provision of services
18 to or safeguarding of persons who, because of age, disability, infirmity or other condition, are
19 vulnerable to abuse. If the department takes adverse action against any applicant based on the
20 applicant's arrest or criminal conviction record, it shall provide a written copy of such analysis
21 performed under article [twenty-three a] 23-a of the correction law to the applicant in a form and
22 manner to be determined by the department.

1 (g) The provisions of this subdivision shall be enforceable against public agencies by a
2 proceeding brought pursuant to article [seventy-eight] 78 of the [Civil Practice Law and Rules]
3 civil practice law and rules, and the provisions of this subdivision shall be enforceable against
4 private employers by the commission through the administrative procedure provided for in this
5 chapter or as provided in chapter [five] 5 of this title. For purposes of this paragraph only, the
6 terms “public agency” and “private employer” [shall] have the meaning given such terms in
7 section [seven hundred fifty] 750 of the correction law.

8 § 14. Paragraphs a, b, e and f of subdivision 13 of section 8-107 of the administrative
9 code of the city of New York, as amended by local law number 39 for the year 1991, are
10 amended to read as follows:

11 a. An employer shall be liable for an unlawful discriminatory practice based upon the
12 conduct of an employee or agent which is in violation of any provision of this section other than
13 subdivisions [one] 1 and [two] 2 of this section.

14 b. An employer shall be liable for an unlawful discriminatory practice based upon the
15 conduct of an employee or agent which is in violation of subdivision [one] 1 or [two] 2 of this
16 section only where:

17 (1) [the] The employee or agent exercised managerial or supervisory responsibility; or

18 (2) [the] The employer knew of the employee’s or agent’s discriminatory conduct, and
19 acquiesced in such conduct or failed to take immediate and appropriate corrective action; an
20 employer shall be deemed to have knowledge of an employee’s or agent’s discriminatory
21 conduct where that conduct was known by another employee or agent who exercised managerial
22 or supervisory responsibility; or

1 (3) [the] The employer should have known of the employee's or agent's discriminatory
2 conduct and failed to exercise reasonable diligence to prevent such discriminatory conduct.

3 e. The demonstration of any or all of the factors listed above in addition to any other
4 relevant factors shall be considered in mitigation of the amount of civil penalties to be imposed
5 by the commission pursuant to this chapter or in mitigation of civil penalties or punitive damages
6 which may be imposed pursuant to chapter [four] 4 or [five] 5 of this title and shall be among the
7 factors considered in determining an employer's liability under subparagraph [three] 3 of
8 paragraph b of this subdivision.

9 f. The commission may establish by rule policies, programs and procedures which may
10 be implemented by employers for the prevention and detection of unlawful discriminatory
11 practices by employees, agents and persons employed as independent contractors.
12 Notwithstanding any other provision of law to the contrary, an employer found to be liable for an
13 unlawful discriminatory practice based solely on the conduct of an employee, agent or person
14 employed as an independent contractor who pleads and proves that such policies, programs and
15 procedures had been implemented and complied with at the time of the unlawful conduct shall
16 not be liable for any civil penalties which may be imposed pursuant to this chapter or any civil
17 penalties or punitive damages which may be imposed pursuant to chapter [four] 4 or [five] 5 of
18 this title for such unlawful discriminatory practices.

19 § 15. Subdivision 14 of section 8-107 of the administrative code of the city of New York,
20 as amended by local law number 39 for the year 1991, is amended to read as follows:

21 14. Applicability; alienage or citizenship status. Notwithstanding any other provision of
22 this section, it shall not be an unlawful discriminatory practice for any person to discriminate on
23 the ground of alienage or citizenship status, or to make any inquiry as to a person's alienage or

1 citizenship status, or to give preference to a person who is a citizen or national of the United
2 States over an equally qualified person who is an alien, when such discrimination is required or
3 when such preference is expressly permitted by any law or regulation of the United States, the
4 state of New York or the city [of New York], and when such law or regulation does not provide
5 that state or local law may be more protective of aliens; provided, however, that this provision
6 shall not prohibit inquiries or determinations based on alienage or citizenship status when such
7 actions are necessary to obtain the benefits of a federal program. An applicant for a license or
8 permit issued by the city [of New York] may be required to be authorized to work in the United
9 States whenever by law or regulation there is a limit on the number of such licenses or permits
10 which may be issued.

19 disability is known or should have been known by the covered entity.

1 17. Disparate impact. a. An unlawful discriminatory practice based upon disparate impact

3 (1) [the] The commission or a person who may bring an action under chapter [four] 4 or
4 [five] 5 of this title demonstrates that a policy or practice of a covered entity or a group of
5 policies or practices of a covered entity results in a disparate impact to the detriment of any
6 group protected by the provisions of this chapter; and

7 (2) [the] The covered entity fails to plead and prove as an affirmative defense that each
8 such policy or practice bears a significant relationship to a significant business objective of the
9 covered entity or does not contribute to the disparate impact; provided, however, that if the
10 commission or such person who may bring an action demonstrates that a group of policies or
11 practices results in a disparate impact, the commission or such person shall not be required to
12 demonstrate which specific policies or practices within the group results in such disparate
13 impact; provided further, that a policy or practice or group of policies or practices demonstrated
14 to result in a disparate impact shall be unlawful where the commission or such person who may
15 bring an action produces substantial evidence that an alternative policy or practice with less
16 disparate impact is available to the covered entity and the covered entity fails to prove that such
17 alternative policy or practice would not serve the covered entity as well. “Significant business
18 objective” shall include, but not be limited to, successful performance of the job.

21 professional or occupational license; a certificate, registration, permit, or other credential; a
22 minimum level of education or training; or a minimum level of professional, occupational, or
23 field experience.

1 (4) (a) Nothing set forth in this subdivision shall be construed as prohibiting an employer,
2 employment agency, or agent thereof, when making employment decisions with regard to hiring,
3 compensation, or the terms, conditions or privileges of employment, from determining that only
4 applicants who are currently employed by the employer will be considered for employment or
5 given priority for employment or with respect to compensation or terms, conditions or privileges
6 of employment. In addition, nothing set forth in this subdivision shall prevent an employer from
7 setting compensation or terms or conditions of employment for a person based on that person's
8 actual amount of experience.

14 history of an applicant for employment or employee, or otherwise discriminate against an
15 applicant or employee with regard to hiring, compensation, or the terms, conditions or privileges
16 of employment based on the consumer credit history of the applicant or employee.

17 (b) Paragraph (a) of this subdivision shall not apply to:

18 (1) [an] An employer or agent thereof, that is required by state or federal law or
19 regulations or by a self-regulatory organization as defined in section 3(a)(26) of the securities

22 (2) [persons] Persons applying for positions as or employed:

1 (A) [as] As police officers or peace officers, as those terms are defined in subdivisions
2 [thirty-three] 33 and [thirty-four] 34 of section 1.20 of the criminal procedure law, respectively,
3 or in a position with a law enforcement or investigative function at the department of
4 investigation;

5 (B) [in] In a position that is subject to background investigation by the department of
6 investigation, provided, however, that the appointing agency may not use consumer credit
7 history information for employment purposes unless the position is an appointed position in
8 which a high degree of public trust, as defined by the commission in rules, has been reposed[.];

9 (C) [in] In a position in which an employee is required to be bonded under [City] city,
10 state or federal law;

11 (D) [in] In a position in which an employee is required to possess security clearance
12 under federal law or the law of any state;

13 (E) [in] In a non-clerical position having regular access to trade secrets, intelligence
14 information or national security information;

15 (F) [in] In a position: (i) having signatory authority over third party funds or assets valued
16 at \$10,000 or more; or (ii) that involves a fiduciary responsibility to the employer with the
17 authority to enter financial agreements valued at \$10,000 or more on behalf of the employer[.];

19 (G) [in] In a position with regular duties that allow the employee to modify digital
20 security systems established to prevent the unauthorized use of the employer's or client's
21 networks or databases.

22 (c) Paragraph (a) of this subdivision shall not be construed to affect the obligations of
23 persons required by section 12-110 [of this code] or by mayoral executive order relating to

1 disclosures by city employees to the conflicts of interest board to report information regarding
2 their creditors or debts, or the use of such information by government agencies for the purposes
3 for which such information is collected.

4 [(d) As used in this subdivision:

5 (1) The term “intelligence information” means records and data compiled for the purpose
6 of criminal investigation or counterterrorism, including records and data relating to the order or

9 potential terrorist threats.

22 customer or mailing lists.

1 (e)] (d) Nothing in this subdivision [shall preclude] precludes an employer from
2 requesting or receiving consumer credit history information pursuant to a lawful subpoena, court
3 order or law enforcement investigation.

4 § 22. Section 8-107.1 of chapter 1 of title 8 of the administrative code of the city of New
5 York, as amended by local law number 40 for the year 2016, is re-designated as a new

16 cohabiting with or has cohabited with the victim, by a person who is or has been in a continuing
17 social relationship of a romantic or intimate nature with the victim, or a person who is or has
18 continually or at regular intervals lived in the same household as the victim.

19 “Victim of sex offenses or stalking” means a victim of acts which would constitute
20 violations of article 130 of the penal law, or a victim of acts which would constitute violations of
21 sections 120.45, 120.50, 120.55, or 120.60 of the penal law.

22 Practices “based on,” “because of,” “on account of,” “as to,” “on the basis of,” or
23 “motivated by” an individual’s “status as a victim of domestic violence,” or “status as a victim of

1 sex offenses or stalking” include, but are not limited to, those based solely upon the actions of a
2 person who has perpetrated acts or threats of violence against the individual.

3 b. Unlawful discriminatory practices] a. Employment. [1. (a)] It shall be an unlawful

18 a victim of sex offenses or stalking is known or should have been known by the covered entity.

19 [(c)] c. Documentation of status. Any person required by [subparagraph (b)] paragraph b
20 to make reasonable accommodation may require a person requesting reasonable accommodation
21 pursuant to [subparagraph (b)] such paragraph to provide certification that the person is a victim
22 of domestic violence, sex offenses or stalking. The person requesting reasonable accommodation
23 pursuant to [subparagraph (b)] such paragraph shall provide a copy of such certification to the

1 covered entity within a reasonable period after the request is made. A person may satisfy the
2 certification requirement of this paragraph by providing documentation from an employee, agent,
3 or volunteer of a victim services organization, an attorney, a member of the clergy, or a medical
4 or other professional service provider, from whom the individual seeking a reasonable
5 accommodation or that individual's family or household member has sought assistance in
6 addressing domestic violence, sex offenses or stalking and the effects of the violence or stalking;
7 a police or court record; or other corroborating evidence. All information provided to the covered
8 entity pursuant to this paragraph, including a statement of the person requesting a reasonable
9 accommodation or any other documentation, record, or corroborating evidence, and the fact that
10 the individual has requested or obtained a reasonable accommodation pursuant to this [section]
11 subdivision, shall be retained in the strictest confidence by the covered entity, except to the
12 extent that disclosure is requested or consented to in writing by the person requesting the
13 reasonable accommodation[;], or otherwise required by applicable federal, state or local law.

14 [(d)] d. Affirmative defense in domestic violence, sex offenses or stalking cases. In any
15 case where the need for reasonable accommodation is placed in issue, it shall be an affirmative
16 defense that the person aggrieved by the alleged discriminatory practice could not, with
17 reasonable accommodation, satisfy the essential requisites of the job or enjoy the right or rights
18 in question.

19 [2. (a)] e. Housing accommodations. It shall be an unlawful discriminatory practice for
20 the owner, lessor, lessee, sublessee, assignee, or managing agent of, or other person having the
21 right to sell, rent or lease or approve the sale, rental or lease of a housing accommodation,
22 constructed or to be constructed, or an interest therein, or any agent or employee thereof, because

1 of any individual’s actual or perceived status as a victim of domestic violence, or as a victim of
2 sex offenses or stalking:

3 (1) To refuse to sell, rent, lease, approve the sale, rental or lease or otherwise deny to or
4 withhold from any person or group of persons such a housing accommodation or an interest
5 therein, or to discriminate in the terms, conditions, or privileges of the sale, rental or lease of any
6 such housing accommodation or an interest therein or in the furnishing of facilities or services in
7 connection therewith because of an actual or perceived status of said individual as a victim of
8 domestic violence, or as a victim of sex offenses or stalking; or

9 (2) To represent that such housing accommodation or an interest therein is not available
10 when in fact it is available.

11 [(b)] f. The provisions of [this] paragraph [2] e shall not apply:

12 (1) To the rental of a housing accommodation, other than a publicly-assisted housing
13 accommodation, in a building which contains housing accommodations for not more than two
14 families living independently of each other, if the owner or members of the owner’s family
15 reside in one of such housing accommodations, and if the available housing accommodation has
16 not been publicly advertised, listed, or otherwise offered to the general public; or

17 (2) To the rental of a room or rooms in a housing accommodation, other than a publicly-
18 assisted housing accommodation, if such rental is by the occupant of the housing accommodation
19 or by the owner of the housing accommodation and the owner or members of the owner’s family
20 reside in such housing accommodation.

21 g. For the purposes of this subdivision, practices “based on,” “because of,” “on account

1 based solely upon the actions of a person who has perpetrated acts or threats of violence against

3 § 23. Section 8-109 of the administrative code of the city of New York, as amended by
4 local law number 85 for the year 2005, is amended to read as follows:

5 § 8-109 Complaint. (a) Any person aggrieved by an unlawful discriminatory practice or
6 an act of discriminatory harassment or violence as set forth in chapter [six] 6 of this title [may,
7 by himself or herself], or such person's attorney, may make, sign and file with the commission a
8 verified complaint in writing which shall: (i) state the name of the person alleged to have
9 committed the unlawful discriminatory practice or act of discriminatory harassment or violence
10 complained of, and the address of such person if known; (ii) set forth the particulars of the

22 persons it deems to be necessary parties and shall advise the respondent of [his or her] the
23 respondent's procedural rights and obligations as set forth herein.

1 (e) The commission shall not have jurisdiction over any complaint that has been filed
2 more than one year after the alleged unlawful discriminatory practice or act of discriminatory
3 harassment or violence as set forth in chapter [six] 6 of this title occurred.

4 (f) The commission shall not have jurisdiction to entertain a complaint if:

5 (i) [the] The complainant has previously initiated a civil action in a court of competent
6 jurisdiction alleging an unlawful discriminatory practice as defined by this chapter or an act of
7 discriminatory harassment or violence as set forth in chapter [six] 6 of this title with respect to
8 the same grievance which is the subject of the complaint under this chapter, unless such civil
9 action has been dismissed without prejudice or withdrawn without prejudice; or

10 (ii) [the] The complainant has previously filed and has an action or proceeding before any
11 administrative agency under any other law of the state alleging an unlawful discriminatory
12 practice as defined by this chapter or an act of discriminatory harassment or violence as set forth
13 in chapter [six] 6 of this title with respect to the same grievance which is the subject of the
14 complaint under this chapter; or

15 (iii) [the] The complainant has previously filed a complaint with the state division of
16 human rights alleging an unlawful discriminatory practice as defined by this chapter or an act of
17 discriminatory harassment or violence as set forth in chapter [six] 6 of this title with respect to
18 the same grievance which is the subject of the complaint under this chapter and a final
19 determination has been made thereon.

20 (g) In relation to complaints filed on or after September [first] 1, [nineteen hundred
21 ninety-one] 1991, the commission shall commence proceedings with respect to the complaint,
22 complete a thorough investigation of the allegations of the complaint and make a final
23 disposition of the complaint promptly and within the time periods to be prescribed by rule of the

1 commission. If the commission is unable to comply with the time periods specified for
2 completing its investigation and for final disposition of the complaint, it shall notify the
3 complainant, respondent, and any necessary party in writing of the reasons for not doing so.

18 circumstances:

19 [(1) commission] 1. Commission personnel have been unable to locate the complainant
20 after diligent efforts to do so;

21 [(2) the] 2. The complainant has repeatedly failed to appear at mutually agreed upon
22 appointments with commission personnel or is unwilling to meet with commission personnel,
23 provide requested documentation, or to attend a hearing;

1 [(3) the] 3. The complainant has repeatedly engaged in conduct which is disruptive to the
2 orderly functioning of the commission;

3 [(4) the] 4. The complainant is unwilling to accept a reasonable proposed conciliation
4 agreement;

5 [(5) prosecution] 5. Prosecution of the complaint will not serve the public interest; and

6 [(6) the] 6. The complainant requests such dismissal, [one hundred eighty] 180 days have
7 elapsed since the filing of the complaint with the commission and the commission finds (a) that
8 the complaint has not been actively investigated, and (b) that the respondent will not be unduly
9 prejudiced thereby.

10 d. If after investigation the commission determines that probable cause does not exist to
11 believe that the respondent has engaged or is engaging in an unlawful discriminatory practice or
12 an act of discriminatory harassment or violence as set forth in chapter [six] 6 of this title, the
13 commission shall dismiss the complaint as to such respondent.

14 f. The complainant or respondent may, within [thirty] 30 days of such service, and in
15 accordance with the rules of the commission, apply to the chairperson for review of any
16 dismissal pursuant to this section. Upon such application, the chairperson shall review such
17 action and issue an order affirming, reversing or modifying such determination or remanding the
18 matter for further investigation and action. A copy of such order shall be served upon the
19 complainant, respondent and any necessary party.

20 § 27. Subdivisions b and c of section 8-114 of the administrative code of the city of New
21 York, as added by local law number 39 for the year 1991, are amended to read as follows:

22 b. Where the commission has initiated its own investigation or has conducted an
23 investigation in connection with the filing of a complaint pursuant to this chapter, the

1 commission may demand that any person or persons who are the subject of such investigation (i)
2 preserve those records in the possession of such person or persons which are relevant to the
3 determination of whether such person or persons have committed unlawful discriminatory
4 practices or other acts made unlawful by this chapter or chapter 6 of this title with respect to
5 activities in the city, and (ii) continue to make and keep the type of records made and kept by
6 such person or persons in the ordinary course of business within the year preceding such demand
7 which are relevant to the determination of whether such person or persons have committed
8 unlawful discriminatory practices or other acts made unlawful by this chapter or chapter 6 of this
9 title with respect to activities in the city. A demand made pursuant to this subdivision shall be
10 effective immediately upon its service on the subject of an investigation and shall remain in
11 effect until the termination of all proceedings relating to any complaint filed pursuant to this
12 chapter or civil action commenced pursuant to chapter [four] 4 of this title or if no complaint or
13 civil action is filed or commenced shall expire two years after the date of such service. The
14 commission's demand shall require that such records be made available for inspection by the
15 commission, [and/or] be filed with the commission, or both.

16 c. Any person upon whom a demand has been made pursuant to subdivision b of this
17 section may, pursuant to procedures established by rule of the commission, assert an objection to
18 such demand. Unless the commission orders otherwise, the assertion of an objection shall not
19 stay compliance with the demand. The commission shall make a determination on an objection
20 to a demand within [thirty] 30 days after such an objection is filed with the commission, unless
21 the party filing the objection consents to an extension of time.

14 findings of fact and conclusions of law and shall issue and cause to be served on [such] the
15 complainant, respondent, any necessary party and any complainant who has not intervened an
16 order requiring such respondent to cease and desist from such unlawful discriminatory practice

18 such affirmative action as, in the judgment of the commission, will effectuate the purposes of

20 [(1) hiring] 1. Hiring, reinstatement or upgrading of employees;

21 [(2) the] 2. The award of back pay and front pay;

22 [(3) admission] 3. Admission to membership in any respondent labor organization;

2 program, on-the-job training program or other occupational training or retraining program;

3 [(5) the] 5. The extension of full, equal and unsegregated accommodations, advantages,
4 facilities and privileges;

5 [(6) evaluating] 6. Evaluating applications for membership in a club that is not distinctly
6 private, without unlawful discrimination [based on race, creed, color, age, national origin,
7 disability, marital status, partnership status, gender, sexual orientation or alienage or citizenship
8 status];

9 [(7) selling] 7. Selling, renting or leasing, or approving the sale, rental or lease of housing
10 accommodations, land or commercial space or an interest therein, or the provision of credit with
11 respect thereto, without unlawful discrimination;

12 [(8) payment] 8. Payment of compensatory damages to the person aggrieved by such

14 [(9) submission] 9. Submission of reports with respect to the manner of compliance; and

15 [(10) payment] 10. Payment of the complainant's reasonable attorney's fees, expert fees
16 and other costs. The commission may consider matter-specific factors when determining the

23 of law recommended by the administrative law judge, the commission shall find that a

1 respondent has not engaged in any such unlawful discriminatory practice or act of discriminatory
2 harassment or violence as set forth in chapter [six] 6 of this title, the commission shall state its
3 findings of fact and conclusions of law and shall issue and cause to be served on the
4 complainant, respondent, and any necessary party and on any complainant who has not
5 intervened an order dismissing the complaint as to such respondent.

6 § 31. Section 8-122 of the administrative code of the city of New York, as amended by
7 local law number 11 for the year 1993, is amended to read as follows:

8 § 8-122 Injunction and temporary restraining order. At any time after the filing of a
9 complaint alleging an unlawful discriminatory practice under this chapter or an act of
10 discriminatory harassment or violence as set forth in chapter [six] 6 of this title, if the
11 commission has reason to believe that the respondent or other person acting in concert with
12 respondent is doing or procuring to be done any act or acts, tending to render ineffectual relief
13 that could be ordered by the commission after a hearing as provided by section 8-120 [of this
14 chapter], a special proceeding may be commenced in accordance with article [sixty-three] 63 of
15 the civil practice law and rules on behalf of the commission in the supreme court for an order to

18 special proceeding may be commenced in any county within the city [of New York] where the

22 § 8-124 Civil penalties for violating commission orders. Any person who fails to comply
23 with an order issued by the commission pursuant to section 8-115 or section 8-120 [of this

1 chapter] shall be liable for a civil penalty of not more than [fifty thousand dollars] \$50,000 and
2 an additional civil penalty of not more than [one hundred dollars] \$100 per day for each day that
3 the violation continues.

7 b. Notwithstanding any inconsistent provision of subdivision a of this section, where a
8 complaint filed with the city commission on human rights or the state division on human rights is
9 dismissed by the city commission on human rights pursuant to subdivisions a, b or c of section 8-
10 113 [of chapter one of this title], or by the state division of human rights pursuant to subdivision
11 [nine] 9 of section [two hundred ninety-seven] 297 of the executive law either for administrative
12 convenience or on the grounds that such person's election of an administrative remedy is

8 status, disability, or alienage or citizenship status as defined in chapter [one] 1 of this title, the

10 corporation counsel's own initiative, may bring a civil action on behalf of the city for injunctive
11 and other appropriate equitable relief in order to protect the peaceable exercise or enjoyment of
12 the rights secured.

13 b. An action pursuant to subdivision a of this section may be brought in any court of
14 competent jurisdiction.

15 c. Violation of an order issued pursuant to subdivision a of this section may be punished
16 by a proceeding for contempt brought pursuant to article [nineteen] 19 of the judiciary law and,
17 in addition to any relief thereunder, a civil penalty may be imposed not exceeding [ten thousand
18 dollars] \$10,000 for each day that the violation continues.

21 § 8-603 Discriminatory harassment; civil penalties. a. No person shall by force or threat

1 by the constitution or laws of this state or by the constitution or laws of the United States or by
2 local law of the city when such injury, intimidation, interference, oppression or threat is
3 motivated in whole or in part by the victim’s actual or perceived race, creed, color, national
4 origin, gender, sexual orientation, age, marital status, partnership status, disability or alienage or
5 citizenship status, as defined in chapter [one] 1 of this title.

6 b. No person shall knowingly deface, damage or destroy the real or personal property of
7 any person for the purpose of intimidating or interfering with the free exercise or enjoyment of
8 any right or privilege secured to the other person by the constitution or laws of this state or by
9 the constitution or laws of the United States or by local law of the city when such defacement,
10 damage or destruction of real or personal property is motivated in whole or in part by the
11 victim’s actual or perceived race, creed, color, national origin, gender, sexual orientation, age,
12 marital status, partnership status, or whether children are, may be, or would be residing with such
13 victim, disability or alienage or citizenship status, as defined in chapter [one] 1 of this title.

14 c. Any person who violates subdivision a or b of this section shall be liable for a civil
15 penalty of not more than [one hundred thousand dollars] \$100,000 for each violation, which may
16 be recovered by the corporation counsel in an action or proceeding in any court of competent
17 jurisdiction.

20 § 8-702 Definitions. [When] As used in this chapter, the following terms have the
21 following meanings:

22 [(1) The term “discriminatory boycott or blacklist” means any act that is an unlawful
23 discriminatory practice under subdivision eighteen of section 8-107 of chapter one of this title.

1 (2) Commission. The term “commission” means the [New York] city commission on
2 human rights.

3 [(3)] Council. The term “council” means the council of the city of New York.

4 Discriminatory boycott or blacklist. The term “discriminatory boycott or blacklist” means
5 any act that is an unlawful discriminatory practice under subdivision 18 of section 8-107.

6 § 45. Section 8-703 of the administrative code of the city of New York, as added by local
7 law number 39 for the year 1991, is amended to read as follows:

8 § 8-703 Investigative reporting requirements. The following requirements shall apply to
9 all complaints alleging that a discriminatory boycott or blacklist is occurring:

10 (1) The commission shall begin an investigation within [twenty-four] 24 hours of the
11 filing of a complaint which alleges that a discriminatory boycott or blacklist is occurring.

12 (2) Within three days after initiating such an investigation, the commission shall file a
13 written report with the mayor. The report shall state:

14 (a) [the] The allegations contained in the complaint;

15 (b) [whether] Whether the commission has reason to believe a discriminatory boycott or
16 blacklist is taking place; and

19 commission has reason to believe that a discriminatory boycott or blacklist has taken place,
20 within [thirty] 30 days after filing such report, the commission shall file a second report with the
21 mayor and the council. This second report shall contain:

22 (a) [a] A brief description of the allegations contained in the complaint;

1 (b) [a] A determination of whether probable cause exists to believe a discriminatory
2 boycott or blacklist is taking place;

3 (c) [a] A recitation of the facts that form the basis of the commission's determination of
4 probable cause; and

5 (d) [if] If the boycott or blacklist is continuing at the date of the report, a description of
6 all actions the commission or other city agency has taken or will undertake to resolve the dispute.

7 (4) If a finding of probable cause is not contained in the report required by subdivision
8 [three] 3 of this section and the boycott or blacklist continues for more than [twenty] 20 days
9 subsequent to the report's release, then, upon demand of the mayor or council, the commission
10 shall update such report. Report updates shall detail:

14 interfering with, or attempting to interfere with (i) medical procedures being performed at such

15 [§ 8-902]§ 10-1102 Declaration of [Legislative Findings and Intent]legislative findings
16 and intent. Gender-motivated violence inflicts serious physical, psychological, emotional and
17 economic harm on its victims. Congressional findings have documented that gender-motivated
18 violence is widespread throughout the United States, representing the leading cause of injuries to
19 women ages 15 to 44. Further statistics have shown that three out of four women will be the
20 victim of a violent crime sometime during their lives, and as many as [four million]4,000,000
21 women a year are victims of domestic violence. Senate hearings, various task forces and the
22 United States [Department]department of [Justice]justice have concluded that victims of gender-
23 motivated violence frequently face a climate of condescension, indifference and hostility in the

1 court system and have documented the legal system’s hostility towards sexual assault and
2 domestic violence claims. Recognizing this widespread problem, [Congress]congress in 1994
3 provided victims of gender-motivated violence with a cause of action in federal court through the
4 [Violence Against Women Act]violence against women act (VAWA) ([42 USC § 13981] section
5 13981 of title 42 of the United States code). In a May 15, 2000, decision, the United States
6 [Supreme Court]supreme court held that the [Constitution]constitution provided no basis for a
7 federal cause of action by victims of gender-motivated violence against [their]perpetrators of
8 offenses committed against them either under the[Commerce Clause or the Equal Protection
9 Clause of the Fourteenth Amendment] commerce clause or the equal protection clause of the
10 fourteenth amendment. In so ruling, the [Court]court held that it could “think of no better
11 example of the police power, which the Founders denied the National Government and reposed
12 in the States, than the suppression of violent crime and vindication of its victims.”

13 In light of the void left by the [Supreme Court’s]supreme court’s decision, this
14 [Council]council finds that victims of gender-motivated violence should have a private right of
15 action against [their] perpetrators of offenses committed against them under the [Administrative
16 Code]administrative code. This private right of action aims to resolve the difficulty that victims
17 face in seeking court remedies by providing an officially sanctioned and legitimate cause of
18 action for seeking redress for injuries resulting from gender-motivated violence.

9 enters into a covered contract with the agency.

3 participants, whose sole responsibility is to provide language assistance services.

4 [n. “Language”Language assistance services. The term “language assistance services”
5 means interpretation services [and/or]or translation services provided by bilingual personnel or
6 interpreter personnel to a limited English proficient individual in [his/her]such individual’s
7 primary language to ensure [their]such individual’s ability to communicate effectively with
8 agency or agency contractor personnel.

9 [o.]Limited English proficient individual. The term “[Limited English proficient
10 individual]limited English proficient individual” means an individual who identifies as being, or
11 is evidently, unable to communicate meaningfully with agency or agency contractor personnel

15 screen bilingual personnel and interpreter personnel for their ability to provide language
16 assistance services. The agency and each agency contractor shall provide annual training for
17 bilingual personnel and interpreter personnel and ensure that they are providing appropriate
18 language assistance services.

19 [§ 8-1007]§ 21-195 Recordkeeping. a. Agency and agency contractors. No later than [the
20 first day of the sixtieth month after the effective date of the local law that added this
21 chapter]February 1, 2008, the agency and each agency contractor shall maintain records of the
22 primary language of every individual who seeks or receives benefits or services from the agency

1 or agency contractor. At a minimum, the agency and each agency contractor shall maintain

9 a New York city public school, on school grounds, during school-related events or while taking

11 EMS transports. The term “EMS transports” means transports performed by emergency
12 medical services, whether provided by the fire department or another authorized ambulance
13 service, in which a student is taken from a New York city public school to a hospital.

14 Homeless status. The term “homeless status” means the circumstance in which a student
15 lacks a fixed, regular and adequate nighttime residence, as determined in accordance with
16 applicable chancellor’s regulations.

17 Teacher removal. The term “teacher removal” means the removal from class, including
18 at least one class period and for up to four complete school days, of a student in kindergarten
19 through grade twelve whose conduct is substantially disruptive of the educational process or
20 substantially interferes with a teacher’s authority over the classroom, with notice and an
21 opportunity to be heard pursuant to applicable chancellor’s regulations.

22 [b.]§ 21-983 Confidentiality requirements. No information that is otherwise required to
23 be reported pursuant to this chapter shall be reported in a manner that would violate any

1 applicable provision of federal, state or local law relating to the privacy of student information,
2 including but not limited to restrictions with respect to personally identifiable information in
3 education records set forth in [20 U.S.C. § 1232g] section 1232g of title 20 of the United States
4 code, or that would interfere with law enforcement investigations or otherwise conflict with the
5 interests of law enforcement. If (i) the total number of students or incidents within a non-
6 disaggregated category contains from one through five students or incidents, (ii) the total number
7 of students or incidents within a disaggregated category, or reported pursuant to paragraph four
8 of subdivision a of section [8-1102 of this chapter]21-984, contains from zero through five
9 students or incidents; or (iii) the total number of students or incidents within a category, whether
10 or not disaggregated, contains an amount that would allow another category, whether or not
11 disaggregated, that contains from one through five students or incidents to be deduced, then the
12 number of students or incidents shall be replaced with a symbol or shall be subject to some other
13 form of data suppression.

14 [§8-1102.]§ 21-984 Annual report on student discipline. The chancellor shall submit to
15 the city council and post to the [department of education's]department's website by October
16 [31st]31 of each year an annual report, based on data from the preceding school year, on the
17 discipline of students.

18 a. The data in this report shall be disaggregated by school and shall show the following:

19 1. The number of teacher removals, which shall additionally be disaggregated by
20 infraction code and number of days removed;

21 2. The number of principal's suspensions, which shall additionally be disaggregated by
22 infraction code and length of suspension;

1 3. The number of superintendent’s suspensions, which shall additionally be disaggregated
2 by infraction code and length of suspension;

3 4. The number of students subjected more than once to a teacher removal, principal’s
4 suspension, superintendent’s suspension, or any combination thereof;

5 5. The number of students subjected to an expulsion; and

6 6. The number of incidents involving department contacts that also resulted in the
7 suspension of the students who were the subjects of the department contacts.

8 b. The data provided pursuant to subdivision a shall be disaggregated by race/ethnicity,
9 gender, grade, year of birth, whether the individual is receiving special education services,
10 whether the individual is an English language learner and homeless status. The report shall
11 include school district and citywide total numbers for each disaggregated category.

12 c. The report shall also include:

13 1. The citywide total number of transfers that were initiated during the superintendent’s
14 suspension process or during the period of any resulting superintendent’s suspension,
15 disaggregated by involuntary and voluntary transfers; and

16 2. The annual citywide percentage change in suspensions, disaggregated by school
17 district.

18 [§8-1103.]§ 21-985 Biannual citywide report on suspensions. The chancellor shall submit
19 to the council and post to the [department of education’s]department’s website by October
20 [31st]31 and March [31st]31 of each year a report on the discipline of students citywide, based
21 on data from the first six months of the current calendar year and the second six months of the
22 preceding calendar year respectively. Such report shall include the number of suspensions
23 citywide for each month, disaggregated by superintendent’s and principal’s suspensions.

1 [§8-1104.]§ 21-986 Citywide report on emergency medical services student transports.

2 a. The chancellor shall submit to the council and post to the [department of
3 education's]department's website by October [31st]31 and March [31st]31 of each year a citywide
4 report on the total number of EMS transports and the number of EMS transports performed
5 because of a student's psychological/emotional condition. The October report shall include EMS
6 transports from the first six months of the current calendar year and the March report shall
7 include EMS transports from the second six months of the preceding calendar year. Each report
8 shall be disaggregated by school district and by month.

9 b. The chancellor shall submit to the council and post to the [department of
10 education's]department's website by October [31st]31 of each year a citywide report on EMS
11 transports during the twelve-month period ending on June [30th]30 of the same year. Each report
12 shall be disaggregated by school and by race/ethnicity, year of birth and whether the individual is
13 receiving special education services.

14 § 50. Subdivision j of section 20-556 of the administrative code of the city of New York,
15 as added by local law number 80 for the year 2016, is amended to read as follows:

16 j. No ticket seller shall use equipment, stands, vehicles, racks, or displays in connection
17 with vending in a public space except: (1) as necessary to accommodate a disability, as that term
18 is defined [by subdivision 16 of] in section 8-102; or (2) equipment that is at all times carried on
19 the person of the ticket seller.

20 § 51. Section 20-921 of the administrative code of the city of New York, as amended
21 by local law number 199 for the year 2017, is amended to read as follows:

22 § 20-921 Confidentiality and nondisclosure. a. An employer may not require the
23 disclosure of details relating to an employee's or his or her family member's medical condition

1 or require the disclosure of details relating to an employee's or his or her family member's status
2 as a victim of family offenses, sexual offenses, stalking, or human trafficking as a condition of
3 providing safe/sick time under this chapter. Health information about an employee or an
4 employee's family member, and information concerning an employee's or his or her family
5 member's status or perceived status as a victim of family offenses, sexual offenses, stalking or
6 human trafficking obtained solely for the purposes of utilizing safe/sick time pursuant to this
7 chapter, shall be treated as confidential and shall not be disclosed except by the affected
8 employee, with the written permission of the affected employee or as required by law. Provided,
9 however, that nothing in this section shall preclude an employer from considering information
10 provided in connection with a request for safe time in connection with a request for reasonable
11 accommodation pursuant to [section 8-107.1 of the administrative code] subdivision 27 of
12 section 8-107.

13 § 52. This local law takes effect 270 days after it becomes law, except that section one of
14 this local law takes effect immediately.
